### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audits of the accompanying financial statements of the Global Healthcare Exchange 401(k) and Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Global Health Exchange 401(k) and Defined Contribution Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Global Healthcare Exchange 401(k) and Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC).

**General**

The Plan is a defined contribution plan covering domestic employees of Global Healthcare Exchange, Inc. and its approved subsidiaries (the Company or the Plan Sponsor). The Plan was adopted on August 1, 2000. The Plan covers any employee age 18 or older. Employees are immediately eligible upon hire, pending they meet other remaining eligibility requirements. The Plan excludes any individual who is represented by a bargaining unit which has bargained with the Company in good faith on the subject of retirement benefits, a leased employee or a U.S. nonresident alien.

**Contributions**

Each year participants may contribute up to 75% of their annual compensation but not more than the maximum allowable limits established by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes a safe harbor matching contribution equal to 100% of participant contributions up to 4% of the participant's eligible wages. The Company may additionally make nonelective contributions to the Plan at its discretion. No such contributions were made to the Plan during 2024. Such discretionary contributions would be allocated to participants based upon each participant's share of the total compensation paid during the Plan year to all eligible participants in the Plan. In order to be eligible for a discretionary contribution, a participant must be an active participant in the Plan. An active participant is a participant in the Plan on December 31 or was a participant in the Plan during that Plan year, or through death or disability.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company contributions, and allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income (loss), and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

**Investment Options**

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Fidelity Management Trust Company (Fidelity). Participants may also invest in a self-directed brokerage account option through Fidelity. The Plan's funds include a variety of investment options with various objectives and degrees of financial risk.

**Vesting**

Participants are immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Participants are also immediately vested in safe harbor matching contributions. Vesting in discretionary Company contributions is based on years of continuous service. Participants are fully vested in these contributions upon the completion of two years of service, as follows:

Vesting Service (Years)	Vested Percentage
Less Than 1	-
1	50
2 or More	100

Vesting service periods are based upon each one-year period ending on December 31 during which an employee worked. Discretionary contributions shall be 100% vested upon attaining the Plan's normal retirement age (65), or upon death or disability.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a longer term. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The loans currently bear interest ranging from 5.25% to 10.50%. Participants may only have one loan outstanding at any given time. Generally, principal and interest are paid ratably through monthly payroll deductions.

**Payment of Benefits**

Upon termination of service due to retirement, death or disability, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution less applicable taxes, or the participant may elect to roll over his or her account balance into another qualified retirement savings account.

Terminated participants with vested account balances less than \$7,000 but greater than or equal to \$1,000 will automatically have their vested account balance rolled into an individual retirement account unless they otherwise instruct the third-party administrator and take a lump-sum distribution as soon as practicable following termination. Terminated participants with vested account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination.

A participant may generally request a distribution based on the participant's pre-tax contributions in the event of a participant's financial hardship. A description of the qualifications to receive a hardship withdrawal is defined in the Plan document.

**Forfeitures**

Forfeitures of nonvested employer contributions are used to either pay the Company's administrative expenses or will be used to reduce future employer contributions. Forfeited nonvested employer contributions totaled \$207 and \$7,088 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, the Plan did not utilize forfeitures to reduce employer contributions. The Plan utilized forfeitures of \$7,135 to pay plan expenses for the year ending December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Risks and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits to participants are recorded upon distribution.

**Subsequent Events**

Subsequent events were evaluated through June 25, 2025, the date the financial statements were available to be issued.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company. Plan related fees paid by the Company are not included in these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE**

Fidelity Management Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodology used for assets measured at fair value:

*Registered Investment Companies:* These are public investment vehicles valued using net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted market price on an active market and classified within Level 1 of the valuation hierarchy.

*Money Market Funds:* Reported at fair value based on quoted market price of the fund and classified within Level 1 of the valuation hierarchy.

*Collective Trust Funds:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. The collective trust fund has a readily determinable fair value and is classified within Level 2 of the valuation hierarchy.

*Self-Directed Brokerage Accounts (SDBAs):* SDBAs include money market funds, registered investment companies, exchange traded funds, options, rights and warrants, and common stock that are all reported at fair value based on quoted market prices and classified within Level 1 of the valuation hierarchy. SDBAs also include certificates of deposit and corporate bonds that are reported at fair value based on other observable inputs and classified within Level 2 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan has adopted a preapproved plan that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of registered investment companies which are managed by Fidelity and therefore qualify as party-in-interest transactions. Other parties-in-interest include professional service firms that perform certain services to the Plan. Notes receivable from participants are also party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Global Healthcare Exchange 401(k) and Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC).

**General**

The Plan is a defined contribution plan covering domestic employees of Global Healthcare Exchange, Inc. and its approved subsidiaries (the Company or the Plan Sponsor). The Plan was adopted on August 1, 2000. The Plan covers any employee age 18 or older. Employees are immediately eligible upon hire, pending they meet other remaining eligibility requirements. The Plan excludes any individual who is represented by a bargaining unit which has bargained with the Company in good faith on the subject of retirement benefits, a leased employee or a U.S. nonresident alien.

**Contributions**

Each year participants may contribute up to 75% of their annual compensation but not more than the maximum allowable limits established by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes a safe harbor matching contribution equal to 100% of participant contributions up to 4% of the participant's eligible wages. The Company may additionally make nonelective contributions to the Plan at its discretion. No such contributions were made to the Plan during 2024. Such discretionary contributions would be allocated to participants based upon each participant's share of the total compensation paid during the Plan year to all eligible participants in the Plan. In order to be eligible for a discretionary contribution, a participant must be an active participant in the Plan. An active participant is a participant in the Plan on December 31 or was a participant in the Plan during that Plan year, or through death or disability.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company contributions, and allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income (loss), and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

**Investment Options**

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Fidelity Management Trust Company (Fidelity). Participants may also invest in a self-directed brokerage account option through Fidelity. The Plan's funds include a variety of investment options with various objectives and degrees of financial risk.

**Vesting**

Participants are immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Participants are also immediately vested in safe harbor matching contributions. Vesting in discretionary Company contributions is based on years of continuous service. Participants are fully vested in these contributions upon the completion of two years of service, as follows:

Vesting Service (Years)	Vested Percentage
Less Than 1	-
1	50
2 or More	100

Vesting service periods are based upon each one-year period ending on December 31 during which an employee worked. Discretionary contributions shall be 100% vested upon attaining the Plan's normal retirement age (65), or upon death or disability.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a longer term. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The loans currently bear interest ranging from 5.25% to 10.50%. Participants may only have one loan outstanding at any given time. Generally, principal and interest are paid ratably through monthly payroll deductions.

**Payment of Benefits**

Upon termination of service due to retirement, death or disability, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution less applicable taxes, or the participant may elect to roll over his or her account balance into another qualified retirement savings account.

Terminated participants with vested account balances less than \$7,000 but greater than or equal to \$1,000 will automatically have their vested account balance rolled into an individual retirement account unless they otherwise instruct the third-party administrator and take a lump-sum distribution as soon as practicable following termination. Terminated participants with vested account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination.

A participant may generally request a distribution based on the participant's pre-tax contributions in the event of a participant's financial hardship. A description of the qualifications to receive a hardship withdrawal is defined in the Plan document.

**Forfeitures**

Forfeitures of nonvested employer contributions are used to either pay the Company's administrative expenses or will be used to reduce future employer contributions. Forfeited nonvested employer contributions totaled \$207 and \$7,088 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, the Plan did not utilize forfeitures to reduce employer contributions. The Plan utilized forfeitures of \$7,135 to pay plan expenses for the year ending December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Risks and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits to participants are recorded upon distribution.

**Subsequent Events**

Subsequent events were evaluated through June 25, 2025, the date the financial statements were available to be issued.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company. Plan related fees paid by the Company are not included in these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE**

Fidelity Management Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodology used for assets measured at fair value:

*Registered Investment Companies:* These are public investment vehicles valued using net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted market price on an active market and classified within Level 1 of the valuation hierarchy.

*Money Market Funds:* Reported at fair value based on quoted market price of the fund and classified within Level 1 of the valuation hierarchy.

*Collective Trust Funds:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. The collective trust fund has a readily determinable fair value and is classified within Level 2 of the valuation hierarchy.

*Self-Directed Brokerage Accounts (SDBAs):* SDBAs include money market funds, registered investment companies, exchange traded funds, options, rights and warrants, and common stock that are all reported at fair value based on quoted market prices and classified within Level 1 of the valuation hierarchy. SDBAs also include certificates of deposit and corporate bonds that are reported at fair value based on other observable inputs and classified within Level 2 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan has adopted a preapproved plan that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of registered investment companies which are managed by Fidelity and therefore qualify as party-in-interest transactions. Other parties-in-interest include professional service firms that perform certain services to the Plan. Notes receivable from participants are also party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
