NOTE 1 DESCRIPTION OF PLAN

The following description of the Black Gold Potato Sales, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Black Gold Potato Sales, Inc. and the related employers listed as participating employers in the Plan's adoption agreement (the "Company") who have attained the age of 21 and have completed six months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated effective January 1, 2024 to bring the Plan into compliance with recent legislative and regulatory changes.

The Plan is administered by a committee appointed by the Company. Third Party Administrators serve as the providers of the plan, maintain the records of the participant data, and hold the Plan assets.

Contributions

Participants may contribute up to 100% of their annual compensation, dependent upon any contributions to any other employee benefit plan, up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The employer may make a discretionary matching contribution. In addition, the Plan allows for a discretionary nonelective contribution to be made by the Plan sponsor, which is allocated pro rata as a uniform percentage of participant compensation. The discretionary nonelective contribution is allocated to plan participants who meet the eligibility requirements of 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. The last day requirement is waived if termination is due to death, disability or retirement. Effective January 1, 2024, the Plan was revised to add safe harbor matching contributions of 100 percent of the first four percent of a participant's elective deferrals, plus 50 percent of the participant's elective deferral that exceed four percent but do not exceed six percent of the participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contribution and an allocation of the Plan earnings. Allocations are based on participant account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

Participants' Investment Options

Participants must direct their salary deferral contributions and employer contributions, if any, to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting the Plan's third-party administrators.

Vesting

Participants are immediately vested in their contributions, and the Company's safe harbor matching contributions, plus actual earnings thereon. Participants are vested on a graduated schedule and after six years of completed service, discretionary matching and nonelective employer contributions plus actual earnings thereon are 100% vested. However, if the participant is employed on or after the normal retirement age or if the participant terminates employment due to death or as a result of becoming disabled, the participant will then be 100% vested.

Notes Receivable from Participants

Participants may borrow from their 401k account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000 reduced by the highest outstanding balance of plan loans during the prior one year. Loans are repaid over the term of five years. A loan term may extend up to fifteen years if the loan is used to acquire a dwelling unit which within a reasonable time will be used as the principal residence of the participant. Loans bear interest of one percent over the prime lending rate quoted in the Wall Street Journal. Principal and interest are paid ratably through payroll deductions and credited to the participant's account.

Payment of Benefits

Upon retirement, termination, disability or death, if the participant's vested account balance exceeds \$7,000, a participant may elect to receive either a lump-sum amount equal to the total vested value of their account, or rollover the balance into an IRA or another plan if their distribution is an "eligible rollover distribution", as stated in the plan document. If the participant's vested account balance does not exceed \$7,000, a distribution will be made as soon as administratively feasible following termination of employment. If the amount of the distribution exceeds \$1,000 and an election is not made to take a lump-sum distribution, the distribution will be directly rolled over to an IRA. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

Participants may also elect in-service distributions if they have reached age 59½.

The Plan permits hardship distributions.

Forfeitures

Forfeitures may be used to reduce administrative expenses or to reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,611 and \$608, respectively. For the years ended December 31, 2024 and 2023, administrative expenses were reduced by \$92 and \$10, respectively, from forfeited nonvested accounts. In addition, for the years ended December 31, 2024 and 2023, employer contributions were reduced by \$61,069 and \$54,561, respectively, from forfeited nonvested accounts.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the providers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and are reflected in the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of loans. Administrative expenses were paid from the Plan's assets. Certain other expenses were paid by the plan sponsor.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contribution to the applicable participants prior to March 15, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds an investment contract which is a guaranteed investment account. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Guaranteed Investment Account

The Plan investments include the Key Guaranteed Portfolio Fund, which is a deposit administration group annuity contract guaranteed investment account product. The contract is a fixed, deferred group annuity. It provides guaranteed protection of principal with a set rate of return. The Key Guarantee Portfolio Fund is guaranteed by Empower Annuity Insurance Company of America. The fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for each of the years ended December 31, 2024 and 2023 is 1.53% and 1.18%, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

NOTE 6 INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company in an opinion letter dated June 30, 2020 that the prototype plan document adopted by Black Gold Potato Sales, Inc. 401(k) Profit Sharing Plan qualifies under the applicable section of the Internal Revenue Code and is, therefore, not subject to tax under present income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST

Bremer Bank, N.A., is the Trustee of the Plan as defined by the plan document. As such, transactions with the Trustee qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$29,269 and \$24,055 for the years ended December 31, 2024 and 2023, respectively.

Bremer Bank, N.A. receives revenue from investment providers for services Bremer Bank, N.A. provides to the funds. This revenue is passed along to the Plan and used to offset certain amounts owed for administrative fees. Revenue sharing in excess of fees has been credited to participant accounts and is included in Net Appreciation in Fair Value of Investments on the Statements of Changes in Net Assets Available for Benefits. The amount was not materially significant.

The Plan has a fee levelization feature which equalizes the fee ratio paid at the participant level, regardless of their individual participant-directed investment elections.

NOTE 8 AMENDMENT AND PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

NOTE 9 RISKS AND UNCERTAINTIES

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.
