(1) Description of the plan:

The following description of the O'Neill & Borges Employees' Pension Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

(a) General -

O'Neill & Borges Employees' Pension Trust (the "Trust") was created in October 1970; its function was the administration of a fund accumulated under the provisions of the Plan for the purpose of providing retirement benefits for eligible employees of O'Neill & Borges LLC ("the Employer"), a limited liability company organized under the laws of the Commonwealth of Puerto Rico. It is a participant directed plan that complies with the requirements of Section 404(c) of ERISA, and was established to comply with the requirements of Section 165 of the Puerto Rico Income Tax Act and thereafter with Section 1165(e) of the Puerto Rico Income Tax Act of 1954, as amended, and continues to comply with Section 1081.01 of the 2011 Puerto Rico Internal Revenue Code, as amended (the "PRIRC"). The Puerto Rico Treasury Department has ruled that the terms of the Trust meet the requirements of this Section. The effects of such qualification, maintained through the continued operations of the Trust, were to:

- i. Exempt the Trust's investment income from income taxes,
- ii. Allow the Employer to deduct annual contributions, made in accordance with the Plan, for income tax purposes and,
- iii. Allow eligible employees (participants under the Trust) to exclude such contributions, income earned thereon and employee's voluntary contributions from their taxable income until distributed.

The Plan is a defined contribution plan covering all full-time employees of O'Neill & Borges LLC who have at least one (1) year of service. As of October 31, 2024 and 2023, the Plan had 148 and 151 participants, respectively, of which 45 and 52 were inactive accounts of terminated participants not yet distributed at the end of each respective year.

The Plan Document was amended effective February 3, 2009, being the most significant amendments related to participant vesting percentages, Plan valuation dates, and change of Trustees. Subsequent to this date, certain additional amendments have been made, as follows:

- i. Effective November 9, 2009, the Plan Document was restated to: change the Trustee, amend the definition of the Plan Year as to the twelve (12) consecutive month period beginning on November 1st of each year, and incorporate the evaluation date applicable to rollover contributions.
- ii. Effective August 1, 2011, the Plan Document was restated to change the Trustee and Recordkeeper, provide for participant directed investments and change the timing in which the participants may contribute to the Plan, among others.
- iii. On July 1, 2014, the Plan was amended in order to incorporate the qualification requirements of the Puerto Rico Internal Revenue Code of 2011, to allow for in-service withdrawals in order to prepay taxes at the special tax rate of 8% on a future distribution in accordance with Act No.77 of July 1, 2014 and, to incorporate changes regarding allocation of fees and expenses incurred in the administration of the Plan related to inactive participants.
- iv. On December 10, 2019, the Plan was amended to modify the definition of highly compensated employees and to modify the process established to determine participants' disability for purposes of early retirement.

(b) Contributions -

The Employer contributes on a monthly basis 9% of the participant's basic annual compensation up to the social security wage base and 7% when the participant's compensation exceeds the current social security wage base, reduced by the non-vested participant account balances forfeited upon termination. A formula is employed to prorate a partial year's contribution for participants whose employment is terminated before the Plan year-end.

Participants may also contribute up to ten percent (10%) of their annual basic compensation amounts on after-tax basis to the Plan, as defined in the Plan Document. Voluntary contributions cannot exceed ten percent (10%) of participant's aggregate compensation for all years of service since becoming a participant in the Plan.

(c) Participants' accounts -

An account is maintained for each participant, credited with the participant's contributions and allocation of: (i) the employer's contribution, and (ii) investment income based on the participant's compensation and account balances, respectively. The benefit to which a participant is entitled upon termination of employment is the vested portion of the amount accumulated in the participant's account. Upon termination of service, a participant will receive a joint-and-survivor annuity, unless electing a lump-sum or an installment basis payment.

(d) Vesting -

Participants are immediately vested in their voluntary contributions and the earnings thereon. Vesting in the balance of their employer contributed accounts, including the accumulated earnings thereon, is based on years of continuous service. Full vesting also occurs on the death of a participant or within five years of his or her normal retirement date, as well as in the event of complete plan termination.

For all participants employed on or after December 31, 1988, the vesting of employer contributions made for Plan Years beginning before January 1, 2007 will be as follows:

(e) **Forfeitures** -

The portion of a participant's account not vested at the date of termination of employment is forfeited immediately. Forfeitures of non-vested account balances in any given year are used to reduce future employer contributions or costs or expenses related to the Plan, at the employer's election. As of October 31, 2024, forfeited non-vested accounts amounted to \$81,254. As of October 31, 2023, there were no forfeited non-vested accounts.

(f) **Participant loans** -

The Plan document stipulates that loans to participants are not permitted.

(g) **Valuation date** -

Effective August 1, 2011, the Valuation Date will be the valuation date coinciding with or immediately preceding the date the participant receives his or her distribution.

(h) **Payments of benefits** -

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the participant's vested interest in his or her account as a joint-and-survivor annuity or in either a lump-sum amount or periodic installments.

(2) **Summary of accounting policies:**

(a) **Basis of presentation** -

The Plan's fiscal year ends on October 31st of each year. All references to years in the notes to these financial statements represent fiscal years then ended, unless otherwise noted. The Plan has evaluated subsequent events through August 4, 2025, the date the financial statements were available to be issued.

(b) **Basis of accounting** -

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (US GAAP).

(c) **Investment valuation and income recognition** -

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) **Use of estimates** -

In preparing financial statements in conformity with accounting principles generally accepted in the United States of America, the Plan is required to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and revenues and expenses during the reporting period. Actual results could differ from those estimates.

(e) **Payment of benefits** -

Benefit payments to participants are recorded when paid.

(f) **Fair value measurement -**

Financial Accounting Standards Board (FASB) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 -Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 -Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 -Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

Time deposit account: Valued at the amount of cash balances on deposit.

Money market: Valued at the net asset value ("NAV") of shares held by the Plan at year end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(g) Risk and uncertainties -

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

(3) Certified investments:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held and accrued income at October 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended October 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Banco Popular de Puerto Rico, the Plan's trustee.

(4) Administrative fees:

The Trustee and Recordkeeper charge administrative fees for the services performed under the Plan Agreement, which are paid by the Employer. The services provided under the agreement include a market value fee based on .20% of the first ten million, .15% of the next ten million and .10% of the remaining balance, an investment consulting fee based on .10% of the first ten million, .08% of the next ten million and .05% of the remaining balance and other recordkeeping minimum fees. Administrative fees paid by the Employer during the year ended October 31, 2024 amounted to \$99,102. Administrative fees allocated to the accounts of participants during the year ended October 31, 2024 amounted to \$11,256.

(5) Plan termination:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

(6) Party-in interest investments and transactions:

In accordance with the Department of Labor's Regulation 2510.3-102, an employer is required to segregate participants' contributions from its general assets as soon as practical when amounts are contributed by participants or withheld from their wages for a pension plan, such as the Plan. There were no prohibited party-in-interest transactions or investments during the year ended October 31, 2024.

On August 12, 2024, the Plan Sponsor remitted \$0.62 in lost earnings in order to cover 2023 failures in the amount of \$300.

(7) Tax status:

The Plan is exempt from United States income taxes by Section 1022 (i) (1) of ERISA. In addition, the Plan is exempt from Puerto Rico income taxes under the applicable provisions of the PRIRC. The Plan Sponsor obtained a determination letter as to the continued qualification of the Plan issued by the Puerto Rico Treasury Department on September 14, 2020, stating the Plan is qualified under Section 1081.01 of the PRIRC and therefore, exempt from taxation.

The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of ERISA and the PRIRC.

Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements; therefore, no provision or liability for income taxes has been included in the accompanying financial statements.
