Opinion

We have audited the accompanying financial statements of Kansas Electric Cooperative Health Insurance Trust Master Health Plan (a Health Care Benefits Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and accumulated plan benefits of Kansas Electric Cooperative Health Insurance Trust Master Health Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its accumulated plan benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Kansas Electric Cooperative Health Insurance Trust Master Health Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTE A - DESCRIPTION OF PLAN

The following description of the Kansas Electric Cooperative Health Insurance Trust Master Health Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

1. General

The Plan provides health care benefits covering substantially all eligible employees of Sunflower Electric Power Corporation, Lane-Scott Electric Cooperative, Inc., Pioneer Electric Cooperative, Inc. and its subsidiary, Southern Pioneer Electric Company, Prairie Land Electric Cooperative, Inc., Wheatland Electric Cooperative, Inc., Western Cooperative Electric Association, Inc., and Victory Electric Cooperative Association, Inc. (collectively, the Members). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees oversees governance of the Plan. Effective January 1, 2024 the Plan trustees elected to change from being a fully funded plan to becoming an Administrative Services Only (ASO) contract and being self-insured.

2. Benefits

The Plan provides health care benefits (medical, prescription drug, dental, and vision) to eligible employees, directors, retired employees, and covered dependents of the members. The Plan is sponsored by the Members and is administered by Blue Cross and Blue Shield of Kansas, Inc. (BCBS), under a minimum premium administrative services only agreement that processes and pays claims. Claims are submitted to BCBS by plan participants or directly by health care providers. BCBS processes such claims and makes payment to the participant or the health care provider if directed to do so by the participant. BCBS is reimbursed for the payments it makes through the Plan's trust account. However, the ultimate responsibility for payments to participants and providers is retained by the Plan, and the Plan is dependent upon continued funding by its Members.

3. Stop loss coverage

The plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims.

4. Contributions

The Members make monthly contributions to the Plan, to pay claims and expenses, based on rates established annually by the Plan upon recommendation by BCBS, and considering administrative fees and insurance premiums charged by BCBS. Most active and retired employees are required to pay a portion or all of their own premiums to the Members.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

1. Basis of accounting and use of estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Plan benefits

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as health claims payable and claims incurred but not reported, and are included as a component of benefit obligations in the accompanying statements of benefit obligations and net assets available for benefits. Any differences between estimated amounts and actual claims are reflected in subsequent periods.

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. This benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligation represents the amounts that are expected to be funded by contributions from the Members and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the Members.

The actuarial present value of the expected postretirement benefit obligation is determined by an independent actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes at December 31, 2024, a 6% annual rate of increase in the per capita cost of covered health care benefits was assumed for 2024; the rate of increase was assumed to decrease gradually to 4.5% for 2035 and to remain at that level thereafter. These assumptions are consistent with those used to measure the benefit obligation at December 31, 2023.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

3. Premium stabilization reserve deposit

In 2023 the Plan was required to maintain a premium stabilization reserve with BCBS, which could be drawn against for future plan costs should payments to BCBS not cover the total of claims paid and other charges. The premium stabilization reserve had been included as an asset of the Plan until such amounts were used to pay plan costs. The reserve was nonforfeitable should the insurance contract terminate. When the plan became an ASO self-insured plan on January 1, 2024, the reserve was no longer required and was returned by Blue Cross Blue Shield.

4. Stop loss insurance premiums

Premiums for stop-loss insurance of \$1,685,939 in 2024 are included in administrative expenses in the accompanying statement of changes in benefit obligations and net assets available for benefits. Stop-loss insurance proceeds of \$661,475 have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

5. Subsequent events

Management has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued.

NOTE C - BENEFIT OBLIGATIONS

Health costs incurred by participants and dependents are partially covered by a stop-loss insurance policy. The policy provides coverage for claims that exceed \$175,000 per individual per year and 120% of the aggregate expected claims. It is the intention of the Members and the Plan to continue stop-loss insurance coverage.

The benefit obligations of the Plan at December 31, 2024 and 2023 consist of health care costs incurred, but not paid at year end and postretirement benefit obligations.

Management estimated the amount of costs incurred, but not paid based upon the actual claims paid from January through May of the following year, less any associated insurance proceeds. An additional estimate for claims incurred but not reported is determined by management on the basis of historical trends.

The postretirement benefit obligations of the Plan at December 31, 2024 and 2023, principally health benefits, relate to the following categories of participants (including their beneficiaries and dependents):

The health care cost-trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$4,600,871 and \$5,995,505, respectively.

NOTE D - TAX STATUS

The Kansas Electric Cooperative Health Insurance Trust established to hold the Plan's assets is a grantor trust under Section 671 of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
