INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators of the

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of John Paul Mitchell Systems 401(k) & Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the John Paul Mitchell Systems 401(k) & Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**1. General**

The Plan is a defined contribution plan established by John Paul Mitchell Systems and JPMS Manufacturing, LLC (collectively, the “Employer”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan provides for a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Employer. The plan administrators are responsible for the oversight of the Plan. Management determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the plan administrators. Fidelity Management Trust Company (the “Trustee”) is responsible for the custody and management of the Plan’s assets. The Voya Insurance and Annuity Company (the “Custodian”) was responsible for the custody and management of the group pension funding contract through January 25, 2024, the date the contract was terminated (see Note E).

**2. Eligibility**

All non-union, non-leased employees who are U.S. residents may participate in the Plan. Employees may begin contributing to the Plan upon three months of employment with the Employer and attainment of age 21. Eligible employees with three months of employment are eligible for discretionary matching contributions and those who are employed on the last day of the plan year with three months service are also eligible for discretionary profit sharing contributions. Employees are eligible for Employer non-elective safe harbor contributions upon one year of service, as defined in the plan document, and attainment of age 21, prior to the entry dates of January 1 and July 1.

**3. Contributions**

Participants may elect to contribute, on a tax-deferred basis or after-tax Roth basis, up to 75% of their eligible compensation, subject to certain limitations under the IRC. All newly eligible participants are automatically enrolled in the Plan. In addition, all active participants without a deferral election on file as of March 1 each year will be automatically enrolled in the Plan at a 1% deferral rate subject to annual increases of 1%, up to a maximum of 5%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may direct contributions, as desired, in any of several investments offered by the Trustee and may change their investment options daily. In addition, the Employer makes a non-elective safe harbor contribution equal to 3% of a participant’s eligible wages.

The Employer may also make discretionary matching and/or profit sharing contributions for each active and eligible participant, in an amount subject to determination on an annual basis by the Board of Directors of the Employer.

**4. Participant Accounts**

Each participant's account is credited with the participant's contributions and the Employer's non-elective safe harbor contribution, as well as allocations of the Employer's discretionary matching and/or profit sharing contribution and earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**5. Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000 less the highest outstanding loan balance during the prior twelve-month period). All loans shall bear a fixed and reasonable rate of interest as determined by a plan administrator at the date of issuance. Loans must be paid back within five years of the date of issuance in accordance with terms established by a plan administrator. Loans for the purchase of a principal residence may be paid back over 15 years. Loans are due and payable upon the participant's termination of employment with the Employer.

**6. Vesting**

Employee contributions, rollovers, Employer non-elective safe harbor contributions, and actual earnings on all such contributions are fully vested at all times. Vesting of Employer discretionary matching contributions, Employer discretionary profit sharing contributions, and actual earnings thereon, are based upon the participant's years of service with the Employer as follows:

**NOTE A - DESCRIPTION OF THE PLAN (Continued)**

**7. Benefit Payments**

Upon termination of employment with the Employer, a participant may receive a lump sum disbursement if his or her vested account balance is less than \$1,000. If the vested account balance is between \$1,000 and \$5,000, a lump sum will be distributed directly to an individual retirement account. For balances greater than \$5,000, the participant is entitled to a lump sum amount. In the event of death or total and permanent disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account. In addition, upon attaining age 59½, participants may receive distributions. Hardship withdrawals are also permitted if certain criteria are met.

**8. Administrative Expenses**

Certain expenses of maintaining the Plan are paid from the assets of the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

**9. Forfeitures**

Forfeitures of terminated participants' non-vested accounts will first be utilized to pay plan expenses if elected by the Employer and then may be applied against future Employer contributions. During the year ended December 31, 2024, \$27 and \$67,286 of forfeitures were used to pay plan expenses and reduce employer contributions, respectively. As of December 31, 2024 and 2023, there was \$94,899 and \$70,993, respectively, of unallocated forfeitures included in net assets available for benefits. Employer contributions receivable as of December 31, 2024 has been reduced by \$86,841 for forfeitures applied in the subsequent year.

**10. Plan Amendments and Termination**

Although it has not expressed such intent, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**2. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**3. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The group pension funding contract is not considered fully-benefit responsive, and is reported at fair value which equals contract value as of December 31, 2023. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the Trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**4. Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**5. Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding increase to deductions from net assets.

**6. Benefit Payments**

Benefits are recorded when paid.

**7. Subsequent Events**

Plan management has evaluated subsequent events through August 6, 2025, the date the financial statements were available to be issued.

**NOTE C - CERTIFICATION BY TRUSTEE AND CUSTODIAN**

The plan administrators have elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all of the investment information, including investment income, and notes receivable from participants and related interest income, included in the accompanying financial statements and supplemental schedule has been certified as complete and accurate by the Trustee and Custodian of the Plan.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE D - FAIR VALUE MEASUREMENTS (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Group pension funding contract:* Valued at net participant contributions plus credited interest calculated at a pro-rated yearly rate based on maturity date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

**NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Trustee and Custodian are parties-in-interest with respect to the Plan. Investments are held with and managed by the Trustee, and were held with and managed by the Custodian (see Note A-1). Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than direct payment. Additional fees may be paid directly to the Trustee, Custodian or other parties-in-interest. Notes receivable and the related interest income are considered related party transactions.

**NOTE F - INCOME TAX STATUS**

The IRS has issued an opinion letter to the Trustee dated June 30, 2020, that the adopted non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan did not seek a favorable determination letter with respect to the initial adoption of the plan document, nor with any plan amendments, the plan administrators believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrators have analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expect to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H - PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, the Employer failed to remit employee contributions to the Plan on a timely basis for two pay periods, as required by DOL Reg. 2510.3-102, resulting in prohibited transactions. The Employer is in the process of computing the lost earnings related to the late remittances for deposit to the Plan.
