To the Participants and Plan Administrator of the Ventiv Technology Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Ventiv Technology Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 3, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to June 3, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Ventiv Technology Inc. 401(k) Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of Ventiv Technology Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by Ventiv Technology Inc. (the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company is the sponsor of the Plan. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”) serves as the trustee of the Plan.

The Plan’s assets are overseen by the Company acting as Plan Sponsor. The Plan Committee is authorized to select investment options and to invest Plan assets as directed by the participants.

Effective May 31, 2024, the Plan was amended to stop all future employee deferrals and employer contributions, including the safe harbor match contributions as the Plan merged with and into the Riskconnect, Inc. 401(K) Profit Sharing Plan. In connection with the merger, effective June 3, 2024, Principal Financial Group service agreement was terminated.

The merger into Riskconnect, Inc. 401(K) Profit Sharing Plan initiated a “Black Out” period beginning May 22, 2024 and continued through the week of June 16, 2024. During this period, participants’ plan accounts were not available for investment fund exchanges, loan requests, and distribution requests. During the Black Out period, the Plan’s participants, assets and liabilities were transferred from the Plan to the Riskconnect, Inc. 401(K) Profit Sharing Plan at which point participants had the option to make their own investment elections or otherwise have their account balance mapped to a target date fund based on the age of the respective participant. As a result of the plan merger, \$18,404,786 of mutual funds, \$3,784,434 of the Principal Guaranteed Option, \$262,411 of participant loans and other net assets of \$75,694 consisting of participant contributions receivable, employer contributions receivable and excess contribution payable were transferred from the Plan to the Riskconnect, Inc. 401(K) Profit Sharing Plan on June 3, 2024. Additionally, for Form 5500 purposes, all assets, liabilities and participants ceased to be part of the Plan as of June 3, 2024 and such amounts are reported as zero on the 2024 Form 5500.

Due to the plan merger, the Principal Guaranteed Option group annuity contract was subject to a redemption notice period. Participants invested in this investment continued to be able to direct the withdrawal or transfer to all or a portion of their investment at contract value. Under the terms of the contract with Principal Financial Group, balances in the Principal Guaranteed Option have a partial withdrawal and transfer limit of 20%, which limits the amount that may be transferred over a five-year annual installment transfer period. At each annual installment, funds in the Principal Guaranteed Option are to be allocated to the Invesco Stable Value Fund once received by the Riskconnect, Inc. 401(k) Profit Sharing Plan. No other events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants. As of June 3, 2024, the value of the Principal Guaranteed Option subject to redemption restrictions and transferred to the Riskconnect, Inc. 401(K) Profit Sharing Plan was \$3,784,434.

Eligibility

All employees of the Company age 21 and over, who are neither leased employees nor independent contractors, are eligible to participate. The Plan allows participants to enter the Plan on the first day of the month following completion of three months of service. The Plan was amended effective March 1, 2024, to allow legacy Ventiv Technology Inc. employees who became employees of Riskconnect, Inc. to continue participation in the Plan through the Plan merger date.

Contributions

Participants may make salary reduction contributions of a portion of compensation instead of receiving that amount in cash. Participants may contribute up to the maximum allowed by the Internal Revenue Code (“IRC”) on a pre-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may designate contributions as Roth contributions. Participation in the Plan is voluntary; however, any eligible employee who does not enroll on his or her own, or elect to opt out of automatic enrollment, will be automatically enrolled in the Plan starting on their eligibility date (or as soon as practicable thereafter). Under automatic enrollment, 3% of the participant’s compensation before tax will be contributed to the Plan as pre-tax contributions.

Participants may also contribute a rollover contribution representing all or part of an entire amount received from other qualified plans.

Company safe-harbor matching contributions are defined as 100% on the first 3% of a participant’s pre-tax and post-tax contributions and 50% of the next 2% of contributions as defined by the Plan document.

The Company may also elect to make a discretionary nonelective employer contribution to the Plan based on a group allocation method. No discretionary nonelective contributions were made to the Plan during the period from January 1, 2024 to June 3, 2024.

Participants’ Accounts and Investment Options

Each participant’s account is credited with the participant’s contributions and Company safe-harbor matching contributions as well as an allocation of the Company’s discretionary nonelective employer contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on all participant account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants may invest their account in a variety of investment options as more fully described in the Plan’s literature. Participants may change their investment elections at any time.

Vesting

Participants are immediately vested in their contributions, Company safe harbor matching contributions and rollover contributions plus actual earnings thereon. All other employer contributions made before January 1, 2021 are fully vested.

Participants vest in discretionary nonelective employer contributions made after January 1, 2021 based on their years of service in accordance with the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years, but less than 3 years	20%
3 years, but less than 4 years	40%
4 years, but less than 5 years	60%
5 years, but less than 6 years	80%
More than 6 years	100%

Notwithstanding the above vesting for the Company’s discretionary nonelective contribution portion of their accounts, a participant will become 100% vested in these accounts upon their attainment of normal retirement age (65) while an employee, death while an employee, or becoming disabled while an employee.

Payment of Benefits

Participants experiencing a qualified financial hardship, or on a qualified military leave, who have attained the age 59½ while employed by the Company, or whose employment has been terminated due to death or disability may withdraw a portion of their account balance as defined in the Plan. If a participant's employment terminates for any reason, the Plan provides for benefits to be paid in the form of a lump sum. If a participant's vested account balance is less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022) upon termination, a distribution of the participant's account may be made automatically in a single lump-sum cash distribution. In the event of a mandatory distribution greater than \$1,000 but does not exceed \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022), if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator.

The Plan permits hardship withdrawals, which are subject to the Plan Administrator's approval, the requirements of the Plan document and applicable regulations.

Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the participant's highest outstanding loan balance in the preceding 12 months) or 50% of their account balance. These loans are secured by the balance in the participant's account. The notes bear interest at the prime rate plus 1%. Loan interest rates ranged from 4.25 to 9.50% as of June 3, 2024 and December 31, 2023. Equal payments of principal and interest must be paid at least quarterly through after-tax payroll deductions. The repayment period on the note can range up to five years unless the loan is taken for the purchase of a primary residence. Notes are considered in default if no note payment is received when the loan repayments are due. A participant may only have one loan outstanding at any given time.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and its related activity on a contract value basis (see Note 5).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable

The Plan is required to return contributions received during the Plan year in excess of the Internal Revenue Code ("IRC") limits. As of December 31, 2023, the Plan had excess contributions. Such excess contributions are recorded as a liability with a corresponding reduction to contributions. The Plan transferred the liability for excess contributions payable to the Riskconnect, Inc. 401(K) Profit Sharing Plan as part of the plan merger.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the period in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), trustee of the Plan and a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-responsive investment contract, at contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of June 3, 2024 and December 31, 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2024 to June 3, 2024.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of June 3, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the merger of the Plan with and into the Riskconnect, Inc. 401(K) Profit Sharing Plan (see Note 1), the Plan's assets were transferred to the Riskconnect, Inc. 401(K) Profit Sharing Plan and there were no fair value measurements as of June 3, 2024.

5. Group Annuity Contract

The Plan held the Principal Guaranteed Option, a group fixed annuity contract that is backed by the general account of the Principal Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus interest credited less participant withdrawals, and administrative expenses.

The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed as outlined in the group annuity contract. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is based on the “vintage” approach. Each “vintage” is a set of guaranteed interest balances which remain in effect throughout the duration of the contract.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events (including but not limited to termination of the contract, plan disqualification or plan termination) might limit the ability of the Plan to transact at contract value with the contract issuer. Additionally, the contract issuer may terminate the contract for causes, including but not limited to failure to maintain certain minimum amount of assets, plan disqualification or failure to comply with the terms of the contract. Upon occurrence of such an event, a market value adjustment or withdrawal restrictions may apply. During 2024, the contract with Principal was terminated and withdrawal restrictions were instituted by Principal (see Note 1).

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the group fixed annuity contract values for credit risk of the contract issuer or otherwise.

As part of the merger of the Plan with and into Riskconnect, Inc. 401(K) Profit Sharing Plan, the fully benefit-responsive investment contracts, at contract value as of June 3, 2024 were transferred to the Riskconnect, Inc. 401(K) Profit Sharing Plan (see Note 1).

6. Related Party and Party-In-Interest Transactions

The Plan invests in a group annuity contract managed by affiliates of Principal, the trustee of the Plan. Certain Plan expenses are also paid to Principal, the trustee of the Plan, and Principal Life Insurance Company, the recordkeeper of the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Total administrative expenses paid by the Plan to its service providers amounted to \$26,097 for the period from January 1, 2024 to June 3, 2024. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant’s account balance.

During 2024, the Company failed to remit to the Plan’s trustee contributions and loan remittances totaling \$68,102 within the period prescribed by the Department of Labor regulations. During 2024 and 2025, the Company made contributions to the affected participants’ accounts to compensate the participant for potential lost income due to processing delays. The Company believes that these transactions do not affect the tax status of the Plan and took action prescribed by the regulations to remedy such errors.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in any employer contributions for which they were not already vested.

8. Risks and Uncertainties

The Plan provides for various investment options to its participants. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Tax Status

Effective January 1, 2022, the Plan was amended and restated by adopting a pre-approved plan designed by CCH Incorporated, DBA ftwilliam.com. The Internal Revenue Service ("IRS") issued an opinion letter, dated June 30, 2020, stating that the pre-approved plan document was designed in accordance with applicable IRC requirements as of that date. Although the Company has not applied for a determination letter for the Plan, and the Plan has subsequently been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 3, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

10. Subsequent Events

The Plan has evaluated subsequent events through August 8, 2025, the date the financial statements were available to be issued.
