### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of TowneBank Stock and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended , and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended , stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Note 1. Description of Plan**

The following description of the TowneBank Stock and Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of TowneBank (“Plan Sponsor”) and participating affiliates (collectively the “Company”) who have attained the age of eighteen and are expected to complete 1,000 hours of service during the Plan year, as defined in the Plan document. Effective April 1, 2024, the Plan was amended to reduce the expected hours of service to 500 hours. The Retirement Plan Committee of the Board of Directors of the Company controls and manages the operation and administration of the Plan. Principal Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### ***Contributions***

Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan document, subject to Internal Revenue Code (“IRC”) limitations. Participant salary deferrals may be traditional 401(k) (pretax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Plan includes an auto-enrollment provision whereby new employees are automatically enrolled in the Plan unless they affirmatively elect not to participate or elect to contribute another amount. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may provide a matching contribution as determined at the discretion of the Company's board of directors. The Company matched 50% of participant salary deferrals that did not exceed 6% of eligible compensation for 2024. Additional profit-sharing amounts may also be contributed at the discretion of the Company's board of directors. For 2024, there was no profit-sharing contribution. Contributions are subject to certain limitations.

#### ***Investment options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, common collective trusts, Company common stock, and a guaranteed investment contract as investment options for participants. Participants with at least three years of service are eligible to elect to diversify the portion of their account invested in Company stock.

#### ***Participant accounts***

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and plan earnings, and charged with benefit payments, transaction fees related to notes receivable from participants and requested participant services, and allocations of administrative expenses. Allocations are based on participant earnings, participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after five years of credited service.

### ***Notes receivable from participants***

Participants may borrow from their fund accounts not invested in TowneBank stock a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding loans bore interest rates ranging from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

### ***Payment of benefits***

On termination of service, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Amounts contributed on a before-tax basis may be withdrawn upon demonstration of financial hardship, subject to limitations defined in the Plan. In-service distributions are available after the participant reaches age 59½.

### ***Forfeitures***

Forfeited balances of terminated participants non-vested accounts are used to reduce future Company contributions and Plan expenses. During 2024, forfeitures of \$279,039 and \$5,150 were used to reduce contributions and expenses, respectively. At December 31, 2024 and 2023, the remaining forfeited nonvested accounts totaled \$1,678 and \$8,100, respectively.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

### ***Investment valuation and income recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes receivable from participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### ***Payment of benefits***

Benefits are recorded upon distribution.

### ***Administrative expenses***

The Plan's administrative expenses are paid by the Company or the Plan, as allowed by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and requested participant services) are charged directly to the participant's account.

### ***Subsequent events***

The Plan has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued.

### **Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

**Level 1:** Observable inputs such as quoted prices in active markets.

**Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.

**Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

#### ***Mutual funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

#### ***Common stocks***

Common stocks in the Plan are publicly traded investments and are valued daily at the closing price reported on the active market on which the individual securities are traded.

#### ***Common collective trust funds***

These funds are valued at the net asset value ("NAV") of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

#### ***Pooled separate accounts***

The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV per share, as determined by Principal Life Insurance Company, as the estimated fair value. Because quoted prices in active markets for

identical assets are not available, these prices are determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics.

### **Insurance Contracts**

The Plan invests in deferred income annuities which are considered insurance contracts under ASC 944, *Financial Services - Insurance*. Since these annuities cannot be sold, transferred, or assigned externally, there is limited market data to support valuation. As such, insurance contracts are classified as Level 3.

The fair market value for deferred income annuities is,

- i. for each paid-up deferred annuity surrendered within 90 days from the date of the purchase of the surrendered portion of such paid-up deferred annuity, the amount used to purchase the surrendered portion of the paid-up deferred annuity, or
- ii. for each paid-up deferred annuity surrendered more than 90 days after the date of the purchase of the surrendered portion of such paid-up deferred annuity, the lesser of:
  1. The guaranteed income balance associated with the surrendered portion of the paid-up deferred annuity, or
  2. The commuted value associated with the surrendered portion of the paid-up deferred annuity. inputs used to calculate the commuted value include the 30-year maturity Treasury Rate, which is publicly available, plus 2% and the 2012 Individual Annuity Reserving Table that is made available through the National Association of Insurance Commissioners.

The fair market value will never be greater than and may be less than the guaranteed income balance associated with the surrendered portion of the paid-up deferred annuities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4. Paid-Up Deferred Annuity

Under ASC 944, *Financial Services - Insurance*, an annuity is considered an insurance contract and can be reported at either fair value or at amounts determined by the insurance entity (contract value). Such value should be presented in the same manner specified in the annual report filed by the plan with certain governmental agencies in accordance with ERISA. We have elected to report these contracts at fair value. See note 3 "Fair Value Measurements" for additional information. These assets can be transferred in the future to other investment options with the plan or surrendered and thus are considered unallocated assets from the perspective of the plan.

### Note 5. Unaudited Information Certified by Trustee

### Note 6. Exempt Party-In-Interest Transactions

Certain plan investments are shares of funds managed by Principal Trust Company or its affiliates. Principal Trust Company is the trustee of the Plan as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the trustee or its affiliates by the Plan for administrative services were \$416,906 and \$380,129 for the years ended December 31, 2024 and 2023, respectively.

The Plan held 730,258 and 792,757 shares of the Company's common stock at December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, the Plan recorded dividend income related to Company common stock of \$778,294 and \$797,959, respectively.

### Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

### Note 8. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Company by letter dated December 22, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
