Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with the 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date of the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of and ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other matter – Supplemental Schedule Required by ERISA***

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024 AND 2023**

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the TSMC Washington 401(k) Retirement Plan (formerly known as WaferTech 401(k) Retirement Plan) (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan covering employees of TSMC Washington, LLC, (the Company), who have attained age 18 and are not employees who are covered by a collective bargaining agreement, leased employees, nonresident aliens who do not receive any earned income from the Company which constitutes United States source income, and those who are self-employed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendment** - Effective February 2024, the Plan document was amended to change the name of the Plan from WaferTech 401(k) Retirement Plan to TSMC Washington 401(k) Retirement Plan, as a result of the Plan sponsor's name change to TSMC Washington, LLC in 2023.

**Contributions** - Contributions consist of employee elective deferrals, employer safe harbor matching contributions and discretionary matching contributions provided by the Company. Employee elective deferrals and the employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may voluntarily contribute up to 60% of their eligible compensation, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and older may elect to make an additional catch-up contribution limited to \$7,500, annually. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan or elect to contribute a different amount. Automatically enrolled participants have an initial deferral rate of 6% and automatically escalate annually by 1% each year up to a maximum of 10%. In 2024 and 2023, the Company made a safe harbor matching contribution of 100% of the first 3% of eligible compensation and 50% of the next 3% of eligible compensation that a participant contributes to the Plan. In addition, the Company may make additional discretionary contributions. Company contributions, if any, are determined at the discretion of the board of directors. No discretionary Company contributions were made for the years ended December 31, 2024 and 2023.

**Participant Accounts** - Each participant's contributions and earnings thereon are recorded in a separate account. Allocation of investment earnings is based upon participant account balances. Company safe harbor matching and discretionary contributions are allocated among participants for the year based on elective deferrals and eligible participants' compensation, respectively. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Other than retirement or termination, a withdrawal is permitted only when participants are over the age of 59½ or in hardship situations, as defined in the Plan.

**Vesting** - Participants are immediately vested in their voluntary contributions, employer safe harbor matching contributions and actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service.

**Expenses** - Administrative expenses may be paid by the Company. Expenses not paid by the Company are satisfied in part through fees received by the Plan through revenue sharing with various mutual funds, and the remainder charged to participant accounts based upon relative account values on a quarterly basis.

Expenses of plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan. Participant loan fees are charged to the participant's account. Fees related to the administration of notes receivable from participants are charged directly to the participant account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits** - On termination of service, a participant may request receipt, rollover, or transfer of a cash distribution equal to the value of his or her vested account value. The Plan further provides for hardship distributions. Hardship distributions are available only for the purpose of meeting immediate and heavy financial needs. An employee who has attained age 59½ may elect a lump-sum payment withdrawal of any portion of his or her account. Payments must commence no later than April 1 of the calendar year following the year in which the participant attains age 70½ or the calendar year in which the participant retires. Account balances that are under \$1,000 may be automatically paid out at the discretion of the Company. Balances between \$1,000 and \$5,000 may be transferred to an IRA, also at the discretion of the Company.

**Forfeitures** - The forfeited accounts of nonvested terminated participants are used to pay administrative expenses and then to reduce future Company contributions. For the years ended December 31, 2024 and 2023, \$322 and \$0 forfeitures were used to pay administrative expenses and \$50 and \$0 forfeitures were used to reduce employer contributions. Forfeited accounts amounted to \$18 and \$32 at December 31, 2024 and 2023, respectively.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent Events** - The Plan’s management has performed an evaluation of subsequent events through July 31, 2025, which is the date these financial statements were available to be issued.

**NOTE 3 – INFORMATION CERTIFIED BY TRUSTEE OF THE PLAN**

The following is a summary of the comparative unaudited information regarding the Plan, included in the Plan’s financial statements and supplemental schedule that was certified by the trustee of the Plan, Fidelity Management Trust Company, and furnished to the Plan administrator. The Plan administrator has obtained certification from the trustee that such information is complete and accurate.

**NOTE 4 – FAIR VALUE MEASUREMENT**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* The Plan holds investments in the Fidelity Managed Income Portfolio Fund, a common/collective trust fund comprised primarily of fully benefit-responsive investment contracts. The NAV provided by the trustee, is used as a practical expedient to estimate fair value. Units in all common/collective trust funds are valued based on the underlying investments, the majority of which are based on quoted prices. The NAV provided by the trustee is used as a practical expedient to estimate fair value. Units in common trust funds are not publicly traded, but rather, are redeemable only by the issuer. The value of the Plan's investment in the common trust fund represents the value of the Plan's interests in the overall value of the common/collective trust fund. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner. Investments in common trust funds can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading. In addition, if a fund experiences periods of insufficient liquidity, then the fund may defer honoring any payment request until liquidity is sufficient.

Participant transactions (purchases and sales) may occur daily. Investments in common/collective trust funds can generally be redeemed without restriction; however, in certain cases, redemption or purchases may be limited to prevent excess and/or short-term trading. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner.

*Self-directed brokerage accounts:* Self-directed accounts primarily consist of money market accounts, certificates of deposit, mutual funds, and common stock that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan makes loans to participants based on their vested account balance. The minimum loan amount is \$1,000 and is limited to 50% of their vested account balance or \$50,000, whichever is less. Loans must be repaid within five years, except for loans made for the purchase of a primary residence. Interest is charged at the prevailing interest rate based upon the *Wall Street Journal* Prime Rate and the Freddie Mac and Fannie Mae 30-year Mortgage Yields (30 day), plus a margin of 1.00%, dependent upon the loan type. Loans outstanding at December 31, 2024 bear interest at rates ranging from 4.25% to 9.50% maturing through December 2034. Loans are secured by the vested interest account balance of the participant.

#### **NOTE 6 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Fidelity Management Trust Company is the trustee of the Plan. Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is an affiliate of the trustee as defined by the Plan; therefore, these transactions qualify as party in interest. Investment management and administrative fees paid to Fidelity Management Trust Company amounted to \$121,405 and \$104,030 in 2024 and 2023, respectively. During 2024 and 2023, the fees paid to were offset by revenue sharing income of \$24,805 and \$22,797, respectively.

#### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer discretionary contributions.

## NOTE 8 – CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan provides for investments that are exposed to various risks. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits, and therefore participants' account balances. There were two investments that individually represented more than 10% of the investments held as of December 31, 2024 and December 31, 2023. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

## NOTE 9 – TAX STATUS

The Plan document is a Non-Standardized Pre-Approved Defined Contribution Plan sponsored by FMR LLC. In an opinion letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting standards generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however; there are currently no audits for any tax periods in progress.
