Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Select Veal Feeds, Inc. 401(k) Profit Sharing Plan**, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES to FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION of PLAN

The following description of the **Select Veal Feeds, Inc. 401(k) Profit Sharing Plan** (the Plan) provides only general information. Participants should refer to the Plan Agreement for complete information.

General and Plan Amendment

The Plan is a defined contribution plan covering all eligible employees of Marcho Farms, Inc., Wayne A. Marcho (a sole proprietorship), and Select Veal Feeds, Inc. (collectively the Employer). Select Veal Feeds, Inc. is the Plan Sponsor and is responsible for the oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan was amended and restated to decrease the age required to participate in the Plan from 20 to 18.

The Plan is following regulatory changes related to the Coronavirus Aid, Relief, and Economic Security (CARES) Act and the Setting Every Community Up for Retirement Enhancement (SECURE) Act, but has not been formerly amended for these changes. The Plan has until December 31, 2026 to formally amend the Plan for these regulations.

Eligibility

Employees are eligible to participate in the Plan and receive employer matching contributions on the first day of the month after or coinciding with completing two consecutive months of employment, or being credited with a year of service, and attaining the age of 18. Employees are eligible for employer profit sharing contributions on the first day of the month after or coinciding with completing six consecutive months of employment, or being credited with a year of service, and attaining the age of 18. Union employees, certain nonresident aliens, and leased employees are excluded from participation in the Plan. The Plan will also allow eligibility for long-term part-time employees to participate in the Plan under the provisions of the Setting Every Community Up for Retirement Enhancement (SECURE) Act.

Contributions

Each year, eligible participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The employer may make a discretionary matching contribution to the Plan. Additional profit sharing contributions may be contributed at the discretion of the employer. The profit sharing contribution, if any, is generally allocated to eligible participants ratably as a percentage of compensation. During the years ended December 31, 2024 and 2023, \$280,276 and \$265,693 in discretionary matching contributions were made, respectively, by the employer. During the years ended December 31, 2024 and 2023, \$445,821 and \$412,211 in profit sharing contributions were made, respectively by the employer.

All contributions are invested as directed by each participant according to their investment allocation elections. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contributions and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on his or her earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. If a participant in the Plan terminates employment other than by retirement, disability, or death, employer contributions and earnings or losses thereon vest in accordance with the following table:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate, which remains fixed throughout the duration of the loan, is set at one percent above the prime rate. Principal and interest is paid ratably through weekly payroll deductions. Participants are only permitted to have one outstanding loan at a time. Repayment terms for loans may not extend beyond five years unless if requested for the purchase of a primary residence, in which case the loan repayment period can be a maximum of ten years.

Payment of Benefits

A participant shall be entitled to receive the balance held in his or her account upon termination of employment, death, disability, or attainment of normal retirement age. The normal retirement age is 65. In-service withdrawals are permitted upon attaining the age of 55. Participants may withdraw rollover accounts at any time. Hardship withdrawals are not permitted. Participant benefits may be paid as a lump sum distribution, direct rollover distribution, or a combination of the two. Effective January 1, 2024, in connection with SECURE ACT 2.0, the Plan increased their automatic force out threshold from \$5,000 to \$7,000. The Plan Administrator may automatically roll any terminated participant accounts with a balance of \$7,000 or less into an individual retirement account established on behalf of the terminated participant. The Plan Administrator may automatically distribute participant accounts with a balance of \$1,000 or less as a lump sum distribution following termination if the participant makes no election.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$43 and \$9,614, respectively. During the years ended December 31, 2024 and 2023, forfeitures in the amount of \$44,123 and \$5,769, respectively, were used to pay plan administrative expenses, audit fees, and reduce employer matching contributions. These accounts can be used to reduce future employer matching contributions or future employer profit sharing contributions or to pay Plan administrative expenses.

NOTE 2 - SUMMARY of SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP). Current US GAAP standards are contained in the Accounting Standards Codification (ASC) as set forth by the Financial Accounting Standards Board (FASB).

Use of Estimates

The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees, in collaboration with the Plan's investment advisor, determine the valuation policies utilizing information provided by the trustee and its related parties. The Plan's investment in the common collective trust is valued using NAV as a practical expedient. Plan Management determined that the practical expedient is preferable since participants are able to transact at NAV, and other fair value information is not readily available to management. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based upon the terms of the Plan Document for purposes of Form 5500 reporting. However, for purposes of the financial statement, for active participants who have not incurred a distributable event (employment termination, death, or disability), but have delinquent loans, the participant loan remains outstanding until a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Expenses

Certain expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. The balance of administrative costs are paid by the Plan and allocated to Plan participants.

Plan Net Credits

The Plan receives net credits when revenue sharing received by the trustee exceeds fees charged by the trustee. The Plan records the receipt of net credits as a reduction to administrative expenses upon receipt. The Plan received net credits of \$42,619 and \$39,141 for the years ended December 31, 2024 and 2023, respectively, and used net credits in the amounts of \$44,945 and \$38,745 during the years then ended, respectively, to pay Plan expenses. Available net credits were \$4,515 and \$6,841 as of December 31, 2024 and 2023, respectively.

NOTE 3 - INFORMATION PREPARED and CERTIFIED by the TRUSTEE and CUSTODIAN (UNAUDITED)

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the trustee and custodian, for the years ended December 31, 2024 and 2023.

Investment income for the years ended December 31, 2024 and 2023, totaled \$988,146 and \$1,094,830, respectively. The Plan earned interest income of \$27,788 and \$15,978 on the notes receivable from participants for the years ended December 31, 2024 and 2023, respectively.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset and liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. As disclosed in Note 2, the Plan uses the common collective trust fund's NAV as a practical expedient. There have been no changes in methodologies at December 31, 2024 and 2023.

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common Collective Trust Fund

Valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the common collective trust, the investment advisor reserves the right to temporarily delay withdrawal in order to ensure that security liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INVESTMENT CONTRACT with INSURANCE COMPANY

At December 31, 2024 and 2023, the Plan is invested in a common collective trust. The Reliance/MetLife Stable Value Series 25053 trust is a collective trust fund for collective investment in an annuity contract, designed for the stability of principal. The objective of the Fund is to provide preservation of capital and earnings at a rate competitive with short-term high quality fixed income investments.

The trust enters into guaranteed investment contracts. In a guaranteed investment contract, the underlying investments are owned by the trust and held in trust for Plan participants. The trust purchases a guaranteed investment contract from a high-quality insurance company or bank.

An issuer of investment contracts has certain rights to terminate a contract and settle at an amount which differs from contract value. For example, certain breaches by the Plan of its eligibility, compliance, or representations under the terms of an investment contract can result in its termination at market value, which may differ from contract value, if the performance of the contract constitutes a prohibited transaction under ERISA or other applicable law.

NOTE 6 - TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Plan which received an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Non-Standardized Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving this opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS audits for any tax periods in progress.

NOTE 7 - RELATED PARTY TRANSACTIONS and PARTY-in-INTEREST TRANSACTIONS

As previously discussed, the Plan may issue loans to participants that are secured by participant account balances. Participant loans totaled \$410,532 and \$335,957 at December 31, 2024 and 2023, respectively. Interest income from participant loans was \$27,788 and \$15,978 for the years ended December 31, 2024 and 2023, respectively. All of these transactions qualify as party-in-interest transactions.

The Plan pays for certain administrative fees charged by Ascensus, LLC, Newport Group, Inc., and Global Retirement Partners, parties-in-interest to the Plan for the years ended December 31, 2024 and 2023, respectively. These fees do not constitute prohibited transactions and amounted to \$40,509 and \$14,596, for the years ended December 31, 2024 and 2023, respectively.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary employer matching and profit sharing contributions.

NOTE 9 - INVESTMENT CONCENTRATION

The Plan had investments in one mutual fund investment option that accounted for 46.56% and 46.46% of total Plan assets at December 31, 2024 and 2023, respectively. Risks associated with investment concentrations for mutual funds are mitigated due to the diverse portfolio of investments held within the funds.

NOTE 10 - RISKS and UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through July 31, 2025, which represents the date the financial statements were available to be issued.
