Emphasis of Matter – Plan Liquidation

As discussed in Note 1 to the financial statements, the governing body of Animal Supply Company LLC 401(k) Retirement Plan has approved a plan of liquidation in February 2025. As a result, the Plan is not considered to be a going concern as of this date, and will change its basis of accounting from the ongoing basis to the liquidation basis effective January 1, 2025. Our opinion is not modified with respect to that matter.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in

accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

ANIMAL SUPPLY COMPANY LLC 401(k) RETIREMENT PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN:

Animal Supply Company LLC 401(k) Retirement Plan (the Plan) is a contributory, defined contribution plan for the benefit of the employees of Animal Supply Company LLC (the Company), as well as Pet Zoo Alaska, LLC and ASC Executive Management LLC. The Plan is administered by the Company and the Plan assets are held in a trust by Fidelity Management Trust Company. The funds must be used for the exclusive benefit of Plan participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In February 2025, substantially all of the assets of the Company were acquired by a third party. In connection with the acquisition, the Company will cease to have employees in 2025, and is in process of an orderly Plan liquidation. Management intends to have the Plan fully liquidated in 2025.

Employees are eligible for participation in the Plan upon attaining the age of eighteen years and completion of 6 months of service. Leased employees and non-resident alien employees are generally not eligible to participate in the Plan. Employees can enter the Plan on the first day of each month, upon meeting the eligibility requirements.

The Plan includes a 401(k) feature whereby eligible employees may contribute up to 90% of compensation, as defined in the Plan, and subject to statutory limitations. The deferrals may be pre-tax deferrals or Roth deferrals. Participants who have reached the age of 50 before the Plan year end may make catch-up contributions, subject to statutory limitations. Newly eligible employees are automatically enrolled at a 5% deferral rate, unless another rate is affirmatively elected by the eligible employee. Employee deferrals are generally funded with each pay period. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make discretionary matching contributions on employee deferrals (including catch-up contributions). Effective January 2023, the discretionary match was 30% of up to 5% of compensation. Effective January 2024, this was increased to 40% of up to 5% of compensation. The employer match is funded with each pay period. The Company may also make a non-elective discretionary match; to receive a nonelective matching contribution, the employee must be employed on the last day of the Plan year, and have earned at least 501 hours of service during the Plan year. There were no non-elective employer contributions in 2024 or 2023. In connection with the third party acquisition described above, the match was ceased.

Each participant's account is credited with the participant's contribution and related matching contribution and net plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All investments of the Plan are participant-directed.

NOTE 1 - Continued:

Participants are immediately vested in their voluntary contributions and both employer matching and nonelective contributions plus actual earnings thereon. Unvested benefits of terminated participants, if any, are forfeited.

As of December 31, 2024 and 2023, the balance of forfeitures available to offset future employer match and fees was \$4,017 and \$7,012, respectively. For the year ended December 31, 2024, \$3,379 of forfeited amounts were applied to employer contributions or fees.

Vested benefits are payable upon retirement, death, disability or termination of a participant. Normal retirement age is defined as age 59-1/2 by the Plan. In-service withdrawals of employee deferrals are permitted for participants in cases of hardship, as defined. In addition, all vested account balances are eligible for distribution upon the participant's attainment of age 59-1/2. Participants who terminate employment are cashed out if their vested Plan balance is \$1,000 or less, and if the balance is less than \$5,000, the Trustee will make a distribution to an IRA unless another account is specified by the participant.

Participants may borrow from their accounts a minimum of \$1,000 and a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans bear interest at a reasonable rate of interest as determined by the administrator. Outstanding loans bear interest at rates ranging from 4% to 9.5%. Principal and interest are paid through payroll deductions. If a participant with an outstanding loan balance terminates employment or otherwise ceases making payments on the loan, the balance is paid by recognition of a deemed distribution to the participant. No allowance for doubtful account is recognized due to adequate collateralization of the loans.

The Company has the right to discontinue the Plan at any time.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:**Use of estimates-**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets and net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Accordingly, actual results could differ from those estimates.

NOTE 2 - Continued:

Valuation of investments-

The Plan's investments are recorded at fair value or net asset value (“NAV”) for common collective trust funds as reported to the Plan by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4.

Recognition of income and expenses-

The Plan records income and expenses on the accrual basis of accounting. In accordance with generally accepted accounting principles, benefits are recorded in the period paid. Purchases and sales of securities are recorded on a trade-date basis.

Net appreciation (depreciation) in fair value of investments represents the net increase (decrease) in the fair value of investments sold during the year or held at year-end over (1) the fair value of investments held at the prior year-end, or (2) the cost of investments acquired during the current year.

Certain administrative expenses are borne by the Plan. However, the Company provides services and support to the Plan with no associated compensation.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

The Plan administrator has obtained certifications from the trustee, Fidelity Management Trust Company, that the following information furnished by the trustee and included in the financial statements and supplemental schedule of Assets (Held at End of Year) is complete and accurate:

1. Investments as of December 31, 2024 and 2023;
2. Participant loans as of December 31, 2024 and 2023; and,
3. Investment transactions, investment income and participant loan transactions for the year ended December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS:

Fair value is a market-based measurement, determined based on assumptions that market participants would use in pricing an asset or liability. Under generally accepted accounting principles, there are three levels of inputs, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

NOTE 4 - Continued:

In determining fair value, the Plan uses the most observable inputs available. If a fair value measurement reflects inputs at multiple levels within the hierarchy, the fair value measurement is characterized based on the lowest level of input that is significant to the fair value measurement.

The following is a description of valuation methodologies used for investments measured at fair value. In 2024 and 2023, the Plan added investments in common collective trusts which are valued as described below. There was no change in the valuation methodology for mutual funds used at December 31, 2024 and 2023.

Mutual funds:

Quoted market prices in active markets are used to value the money market and mutual fund investments.

Common collective trust funds:

The Plan holds investments in Great Gray Funds. These are held in a common collective trust fund and invest in equity securities of mid and small cap U.S. companies. Equity securities include common and preferred stocks, as well as convertible securities. These investments are valued at their NAV per unit as of the close of trading on the New York Stock Exchange each day. The NAV is based on the value of the Great Gray Fund's assets minus its liabilities, and then divided by the number of units outstanding. The Great Gray Funds seek to provide long-term capital appreciation. There are no significant redemption restrictions or unfunded commitments on these investments.

As of December 31, 2024 and 2023, the fair value of the mutual funds and money market fund was determined using Level 1 inputs.

NOTE 5 - FEDERAL INCOME TAXES:

The Plan trustees adopted a Fidelity volume submitter plan. A determination letter dated June 30, 2020 from the Internal Revenue Service has been obtained by the volume submitter plan sponsor that states that the form of the plan qualifies under section 401 of the Internal Revenue Code. Although the Plan has not received a determination letter specific to the Plan itself, it is the intent of the Company that by following the volume submitter plan, that the Plan be exempt from federal income taxes. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has concluded that as of December 31, 2024, the Plan has not taken any uncertain positions that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress and years prior to 2021 are no longer open for examination.

NOTE 6 - RECONCILIATION TO FORM 5500:

The Plan's financial statements report on the accrual basis of accounting. The Form 5500 is prepared on the cash basis. The following is a reconciliation of net assets available for benefits as reported in the financial statements to the Form 5500 as of December 31, 2024 and 2023:

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS:

Fidelity Management Trust Company (“FMTC”) acts as trustee for investments of the Plan. Therefore, transactions with FMTC qualify as party-in-interest transactions.

NOTE 8 - RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts as reported in these financial statements.

NOTE 9 - PLAN COMPLIANCE:

In connection with its annual non-discrimination testing, the Plan determined that certain participants must receive a return of excess contributions in connection with the 2024 and 2023 plan years. Accordingly, a liability for the excess contributions to be returned in the amount of \$2,857 and \$36,803 has been recorded as of December 31, 2024 and 2023, respectively.

NOTE 10 - SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through August 5, 2025, the date which the financial statements were available to be issued.
