## **Report of Independent Auditors**

To the Administrator of Bracebridge Capital, LLC 401(k) Profit Sharing Plan

## Notes to Financial Statements

### 1. Description of the Plan

The following description of the Bracebridge Capital, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. For a more complete description of the Plan’s provisions, participants should refer to the Summary Plan Description.

- a) General. The Plan is a defined contribution plan covering all full-time employees of Bracebridge Capital, LLC (“Bracebridge” or the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The assets of the Plan are held by Fidelity Management Trust Company (“Fidelity” or the “Trustee”). All employees, excluding interns, are eligible to participate in or make contributions to the Plan, as of the first day of the month following their date of hire.
- b) Plan Administrator. The Plan is administered by Bracebridge and is overseen by Bracebridge Capital, LLC 401(k) Profit Sharing Committee (“401(k) Committee”).
- c) Contributions. Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) after-tax contributions authorized by participants, (iii) participant rollovers from another qualified plan, and (iv) profit sharing contributions made by Bracebridge. Each calendar year, participants may contribute the lesser of 60% of eligible compensation or \$23,000 in 2024 and \$22,500 in 2023, respectively, set by the Secretary of the Treasury. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500 in 2024 and \$7,500 in 2023, respectively. Participants must be employed on the last day of the plan year and have completed at minimum, 501 hours of service, to be eligible to receive profit sharing contributions from Bracebridge.
- d) Participant Accounts. Individual accounts are maintained for each plan participant to reflect the participant’s contributions and profit sharing contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Hardship Withdrawals Participants who incurred a hardship are eligible to request an in-service withdrawal from their account attributable to pre-tax and Roth elective deferrals and Company contributions.
- e) Vesting. Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in Bracebridge’s profit sharing contribution portion of their account is vested over a 3 year service period, starting from their date of hire, as follows:

- f) Investment elections. The participant contributions and Bracebridge’s profit sharing contributions are allocated to the various investment options offered by the Plan, as directed by the participants. In addition to the investment offerings by the Plan, participants may invest through a self-directed brokerage link account (“Brokerage Link”), which allows the participant to invest in any type of security available on the Fidelity platform.

- g) Notes Receivable from Participants. Participants may borrow one loan at a time from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loans will be repaid by payroll deduction from the borrower's wages or by such other method as of the loan policy may require. All loans have term lengths between 2 to 8 years and bear an annual interest rate of 4.25%-9.50%, as determined by Bracebridge based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate remains fixed throughout the duration of the loan. There are currently 6 outstanding loans with maturity dates ranging from July 11, 2026 to December 4, 2032.
- h) Forfeited accounts. When a participant terminates participation with the Plan, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. At December 31, 2024 and 2023, the forfeiture account, included in investments, totaled \$232,458 and \$138,582, respectively. At December 31, 2024 and 2023, \$178,777 and \$338,625 respectively, could be reinstated to participant's accounts if they return to Bracebridge within five years of their termination date. If an employee(s) returns, and the amount to be reinstated is larger than the balance in the forfeiture account, this difference will be paid by Bracebridge. The fully-vested portion of the forfeiture account can be used to off-set employer contributions or to pay for administrative fees. In 2024 and 2023, \$225,484 and \$144,508, respectively, was used from the forfeiture account to offset employer contributions.
- i) Termination. Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

## 2. Significant Accounting Policies

### Basis of Presentation

The Plan's financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Use of Estimates

GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan, such as loan maintenance fees, are paid by the participant. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the Company and are not included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Administrative expenses totaling \$17,762 consists of loan maintenance fees and fixed recordkeeping fees that are charged directly to participants in the Plan.

### 3. Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, what is disclosed in the accompanying financial statements and supplemental schedules were obtained or derived from the information supplied to the plan administrator and certified as complete and accurate by Fidelity.

#### 5. Fair Value Measurements

The Accounting Standards Codification 820 (“ASC 820”) defines fair value as “the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.” The objective of a fair value measurement is to determine an exit price.

ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are as follows:

- Level 1        Inputs that are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;
- Level 2        Inputs other than unadjusted quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly, including inputs in markets that are not considered to be active;
- Level 3        Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

*Self directed brokerage accounts:* Valued at the closing price reported on the active market on which the individual securities are traded. These investments consist of common stock, preferred stocks, exchange traded funds, and interest-bearing cash.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no significant changes in the valuation techniques and related inputs used by the Plan during the year December 31, 2024.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**7. Tax Status**

The Company has relied on the Internal Revenue Service ("IRS") letter issued to its Plan Administrator, Fidelity Management and Research Company ("FMR") dated March 31, 2014 that the Plan (as a prototype plan) and related trust are designed in accordance with the applicable sections of the Code. Although the Plan has been amended (amended in 2015) since receiving the determination letter, the plan administrator and the Plan's tax counsel continue to believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS. In 2021, there were two amendments to the Plan, removing the age restriction of when a participant can contribute to the Plan and adding a provision that allows employees to make after tax contributions to the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
