Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the

financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS Years ended December 31, 2024 and 2023

1. Plan description

The following brief description of the Plumbers Supply Co. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions. Copies of the Plan Agreement are available from Plumbers Supply Co. (the Company).

General – The Plan is a contributory defined contribution plan covering all Company employees who are age 21 or older, with the exception of certain employees who fail to meet minimum hours of service requirements as defined in the Plan Agreement. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Fidelity Management Trust Company (FMTTC) is the Plan's trustee and investment custodian.

Contributions – Participants may contribute up to 60% of their annual compensation, as defined in the Plan Agreement. Participants who have reached age 50 before the end of the plan year may contribute additional amounts over this limit. However, total annual deferrals for any participant may not exceed the maximum salary deferral set by law. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Plan allows participants to make after-tax Roth deferrals, and the Company to make additional discretionary matching and non-matching contributions which are determined by the Company's management. A participant must be employed by the Company at the Plan's year end to share in the allocation of any discretionary contributions made by the Company. The Plan requires Company matching contributions of 50% of each participant's salary deferral amounts up to 8% of each participant's compensation and has an automatic enrollment feature which provides for all newly-eligible employees to automatically enroll in the Plan at an 8% deferral rate unless the employee affirmatively elects out of participation or elects a different deferral percentage. Additionally, the Plan has a 1% automatic deferral percentage increase on March 1 of each year for each of the Plan's participants unless a participant affirmatively elects out of the deferral increase. This automatic increase will cease once a participant's deferral percentage has reached 10%. No additional discretionary matching contributions were made to the Plan during the years ended December 31, 2024 and 2023.

Participant accounts – All contributions are allocated at the discretion of the participant among selected investments. Each participant's interest in each of the investment accounts is accounted for in four separate accounts: one each relating to the participant's pre-tax contributions, Roth contributions, and rollover contributions, and the Company's contributions. Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings, and charged with allocations

of investment-related fees and administration expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions and related earnings. Vesting in the Company's matching portions of their accounts and the related earnings is based on years of service. A participant is fully vested with regard to the Company's contributions and related earnings after three years of credited service, as defined in the Plan Agreement. Participant rollover contributions from previous plans are fully vested. A participant becomes fully vested in the event of death, disability, or attainment of retirement age, as defined in the Plan Agreement.

Payment of benefits – In the event of death, disability, retirement, or termination, a participant's benefit will be distributed in accordance with specific provisions of the Plan Agreement. In-service distributions and hardship withdrawals are also permitted upon meeting certain requirements, as defined in the Plan Agreement.

Forfeitures – As of December 31, 2024 and 2023, forfeited nonvested accounts total \$6,416 and \$6,608, respectively. Nonvested portions of the Company's matching accounts are applied to reduce plan administration expenses and the Company's future matching contributions. The Company applied forfeitures totaling \$69,405 and \$35,650 to reduce its matching contributions for the years ended December 31, 2024 and 2023, respectively, and \$69 and \$130 to reduce the Plan's administration expenses for the years ended December 31, 2024 and 2023, respectively.

Administration – Certain administrative functions are performed by Company officers and employees. No such officers or employees receive compensation from the Plan. Certain accounting, legal, and other expenses to maintain the Plan's records are paid by the Company and are therefore not reported as expenses on the accompanying statements of changes in net assets available for benefits. However, administration expenses may be paid by the Company or the Plan at the Company's discretion. Administration expenses reported on the accompanying statements of changes in net assets available for benefits represent certain recordkeeping fees, investment advisory fees, and fees charged by the Plan's third-party administrator related to specific participant transactions.

2. Summary of significant accounting policies

Basis of accounting – The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Estimates – The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions and credit losses – Participant contributions are recorded when the Company computes payroll deductions. Company contributions are recorded based on amounts actually received or committed to be paid for the year. Contributions to the Plan are recorded net of any credit losses provided for on the basis of anticipated collection losses. Estimated losses are determined from historical collection experience, review of current period outstanding receivables, and projection of future activity in the allowance for credit losses. The Plan’s management has determined that the Plan is not exposed to significant credit loss risk as the Plan’s contributions represent only amounts from the Plan’s participants and Company contributions. Accordingly, there is no provision for credit losses, no write-offs, or recoveries collected during the years ended December 31, 2024 and 2023.

Investment valuation and income recognition – As more fully described in Note 4, the Plan’s investments in mutual funds are valued at fair value based on quoted market prices at the measurement date.

The Plan invests in an investment contract with FMTC through a common/collective trust (CCT) which is considered to be fully benefit-responsive under GAAP. Accordingly, the Plan’s investment in the CCT is reported at contract value as more fully described in Note 4. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the contract’s terms.

Realized gains and losses on the Plan’s investments in mutual funds are recognized upon the sale of the related investments, and unrealized appreciation or depreciation is recognized at period end when the carrying values of the related investments are adjusted to their estimated fair values. Net realized and unrealized appreciation or depreciation in fair value of the Plan’s investments in mutual funds includes gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Certain investment-related fees charged to the Plan are deducted from income earned on investments and are not separately reflected on the accompanying statements of changes in net assets available for benefits. Consequently, investment return is reflected net of those investment-related fees on the accompanying statements of changes in net assets available for benefits.

Benefit and withdrawal payments – Benefit and withdrawal payments are recorded when paid.

Fair value measurements – The Plan applies the *Fair Value Measurement* topic of the Accounting Standards Codification (ASC) which requires determination of fair value based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The *Fair Value Measurement* topic emphasizes that fair value is a market-based measurement, not an entity-specific measurement, and it applies in conjunction with other ASC topics that require or permit fair value measurements and disclosures. Impacted assets and liabilities are

measured and disclosed in one of three categories based on the significance and source of the inputs to their valuation. The hierarchy consists of three broad levels: Level 1, Level 2, and Level 3. Level 1 inputs have the highest priority and consist of observable unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs have the lowest priority, are unobservable, and include judgments about the assumptions that market participants would use in pricing the asset or liability.

An asset's or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan's management uses specific valuation techniques based on the available inputs to measure the fair values of the Plan's impacted assets and liabilities. When available, the Plan's management measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

These methods may produce fair value calculations that may not be indicative of net realizable values, or reflective of future fair values. Furthermore, while the Plan's management believes the valuation methods utilized are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair values of certain assets and liabilities could result in different fair value measurements as of December 31, 2024 and 2023.

Subsequent events – The Plan's management has evaluated subsequent events through July 22, 2025, the date the financial statements were available for issue.

3. Information certified by plan investment custodian

The Plan's administrator has elected the method of annual reporting as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, and dividend income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC, the Plan's investment custodian. This information has not been audited by the Plan's independent auditors.

4. Investments and fair value measurements

The Plan's investments are credited with earnings on the underlying investments, and charged for plan withdrawals, investment-related fees, and administration expenses.

The Plan's shares in mutual funds are publicly traded and are valued at the measurement date of the security reported on the principal exchange on which traded (Level 1 input). The mutual funds may be redeemed on a daily basis. Unfunded commitments are not applicable to mutual funds.

The CCT holds a Managed Income Portfolio (MIP) which has the investment objective to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this, the MIP invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into "wrap" contracts issued by third parties, and invests in cash equivalents represented by shares in money market funds. It is the MIP's policy to use its best effort to maintain a stable value of \$1 per unit, although there is no guarantee that the MIP will be able to maintain this value. The MIP's management attempts to obtain prices from one or more third-party pricing vendors or brokers to value the MIP's investments. Factors typically used in determining value vary by security type and may include market or security-specific events, transaction data, estimated cash flows, and market observations of comparable investments.

The MIP's management seeks to minimize exposure to the MIP's wrap credit risk through, among other means, diversification of the wrap contracts across an approved group of issuers. The MIP's ability to receive amounts due pursuant to the wrap contracts is dependent upon the issuers' abilities to meet their financial obligations. Withdrawals from the MIP made as distributions to participants may be made daily. Withdrawals from the MIP made as exchanges to another investment option may be made daily, provided the exchange is not directed to a competing fund. Transferred amounts must be held in a non-competing investment option for 90 days before subsequent transfer to a competing fund. Withdrawals from the MIP initiated by the plan sponsor will normally be provided at contract value as soon as practicable within twelve months following written notice to the MIP's trustee. The MIP's trustee may defer completing any withdrawal where doing so immediately might adversely affect the MIP. In such cases, the MIP's trustee shall make payments as quickly as cash flows and prudent investment management permit. There are no unfunded commitments related to the MIP. Events that may occur that may limit the MIP to transact at contract value include: the Plan's failure to qualify under applicable sections of the Internal Revenue Code; the establishment of a defined contribution plan that competes with the Plan for employee contributions; any substantive modification of the MIP or the administration of the MIP that is not consented to by the wrap issuers; any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on the MIP's cash flow; any communication given to unit holders by the plan sponsor, any other plan fiduciary, or FMTC that is designed to induce or influence unit holders not to invest in the MIP, or to transfer assets out of the MIP; or any transfer of assets from the MIP

directly to a competing investment option. The Plan's trustee does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with its participants is probable.

There have been no changes in the valuation methodologies used to value the Plan's investments in mutual funds as of December 31, 2024 and 2023.

5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan Agreement to discontinue its contributions, and at any time to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

6. Income tax status

The Plan operates under a defined contribution non-standardized pre-approved profit sharing plan sponsored by Fidelity Management and Research Company (affiliated with the Plan's trustee). The Internal Revenue Service (IRS) ruled in an opinion letter dated June 30, 2020 that the non-standardized plan was qualified under applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the IRS opinion letter. However, the Plan's trustee, sponsor, and administrator are not aware of any occurrences that would adversely affect the Plan's qualified status, and believe the Plan is currently designed and operating in compliance with the applicable IRC requirements, is qualified, and the related trust is tax-exempt.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a tax liability, or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress. The Plan's administrator believes the Plan is no longer subject to income tax examinations for years prior to the year ended December 31, 2021.

7. Party-in-interest assets and transactions

The Plan's investments are managed by FMTC, the Plan's trustee and investment custodian. Therefore, the Plan's investments qualify as party-in-interest assets. In addition, transactions conducted by FMTC, fees paid to Fidelity Investments Institutional, fees paid to the Plan's investment advisor and recordkeeper, and Company contributions qualify as party-in-interest transactions. These transactions are permitted under the plan provisions and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate and credit risks, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that reductions in the values of the Plan's investment securities reported as of December 31, 2024 will occur in the near term and that such reductions would materially affect participant account balances and amounts reported on the accompanying December 31, 2024 statement of net assets available for benefits.

The Plan's exposure to concentrations risk is limited by diversification of investments across all investment elections. In addition, the investments within each investment election are further diversified into various financial investments.
