INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the

Scope and Nature of the ERISA 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Atlantic Bulk Carrier 401(k) & Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it was permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Notes to Financial Statements

1. Description of Plan:

The following description of the Atlantic Bulk Carrier 401(k) & Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Atlantic Bulk Carrier Corporation (the "Company") and affiliated companies. Atlantic Bulk Carrier Corporation is a subsidiary of Atlantic Holding Corporation of Virginia. Atlantic Holding Corporation of Virginia sponsors the plan. Employees become eligible to participate after completing three months of service. Eligible employees may enter the Plan on the first day of the month coincident with or next following the date the eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute compensation, as defined in the Plan document, subject to Internal Revenue Code ("IRC") limitations. Participant salary deferrals may be traditional 401(k) (pre-tax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who enter the Plan are automatically enrolled to contribute 6% of annual compensation excluding bonuses unless other election is made. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may elect to make a discretionary matching contribution on the participant's elective contribution equal to a percentage of the participant's contribution. The percentage rate for the years ended December 31, 2024 and 2023 was 50% of the participant's elective contribution up to \$1,000. Additional profit-sharing amounts may be contributed at the discretion of the Company. No such contributions were made in 2024 or 2023. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions; if applicable and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options: Participants may direct the custodian as to the investment of their account balances in accordance with guidelines established by the Plan, into various investment options offered by the Plan. The Plan currently offers pooled separate accounts as investment options for participants. Participants may change their investment elections at any time.

Notes to Financial Statements, Continued

1. Description of Plan, Continued:

Vesting: Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their account plus actual earnings thereon is based on years of service, as defined by the Plan. A participant is 100% vested in employer contributions after 6 years of credited service. Participants will automatically become 100% vested upon attainment of normal retirement age 65 or severance from employment due to disability or death.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to having no more than two notes outstanding at any time. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants, deemed to be in default by the Plan Administrator, are reclassified as distributions based upon the terms of the Plan document.

Plan Administration: Overall responsibility for administering the Plan rests with the Company. Participant accounts are held by John Hancock Life Insurance Company (U.S.A.) ("John Hancock"), the custodian. Retirement Plan Solutions, Inc. ("RPSI") serves as the third-party administrator and recordkeeper of the Plan.

Payment of Benefits: Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment as described by the Plan. All vested balances are available for distribution after the participant reaches age 59 ½.

Forfeitures: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,937 and \$2,234, respectively. Forfeited accounts may be reallocated to participants' accounts, used to pay Plan administrative expenses, or reduce future Company contributions to the Plan. During 2024 and 2023, forfeitures of \$18,700 and \$11,588, respectively, were used to pay administrative expenses.

2. Summary of Significant Accounting Policies:

Basis of Accounting: The financial statements of the Plan are prepared on the accrual method of accounting.

2. Summary of Significant Accounting Policies, Continued:

Investment Valuation and Income Recognition: The Plan's Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net investment income includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent Events: Management has evaluated subsequent events through August 5, 2025, the date the financial statements were available to be issued and has determined there are no subsequent events to be reported in the accompanying financial statements.

3. Fair Value Measurements:

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets. There were no Level 2 assets or liabilities in the Plan as of December 31, 2024 and 2023.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no Level 3 assets or liabilities in the Plan as of December 31, 2024 and 2023.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

3. Fair Value Measurements, Continued:

Pooled separate accounts (“PSA”): Valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted. The PSAs invest in mutual funds and domestic stocks. The redemption frequency of each of these PSA’s is daily, and there are no redemption restrictions. There are no unfunded commitments related to the Plan’s investment in PSAs.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although not required by the Plan, some of the costs of the Plan administration are absorbed by the Company. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account. See Note 5 regarding administrative fees to related parties.

5. **Related Party Transactions:**

The Plan invests in pooled separate accounts that are managed by the custodian. These are related-party transactions and are identified as parties-in-interest in the accompanying schedule of assets (held at end of year). Fees to various service providers totaled \$56,417 and \$45,875 for the years ended December 31, 2024 and 2023, respectively.

6. **Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. **Tax Status:**

The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax jurisdiction.

8. **Risks and Uncertainties:**

The Plan provides for investments in various securities. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.
