Independent Auditor's Report

To the Trustees and Plan Administrator of
Baim Institute for Clinical Research 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Baim Institute for Clinical Research 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN

The following description of Baim Institute for Clinical Research 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution retirement plan covering substantially all full-time employees of Baim Institute for Clinical Research (Baim) (the Plan Sponsor). The Plan is structured under the provisions of Section 401(k) of the Internal Revenue Code (IRC) and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Trustees of the Plan.

b. Eligibility

Employees are eligible to participate in the Plan and receive a matching contribution upon the first day of employment and attaining the age of twenty-one. In order to be eligible for the annual discretionary profit-sharing contribution the participant must work 1,000 hours during the year and be employed at year-end.

c. Contributions

Participants may elect to reduce their salaries based on a percentage of pre-tax annual compensation per year, not-to-exceed the maximum allowed under the IRC. Participants are eligible to designate some or all of their contributions as post-tax (Roth) contributions. The Plan allows for catch-up contributions for participants who have attained age fifty by the end of the plan year. The Plan also allows for participants to contribute distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of contributions into various investment options offered by the Plan. All new and non-contributing participants are automatically enrolled in the Plan at 4% of eligible compensation (escalates 1% each year up to a maximum of 10%). Participants have the option to opt-out or elect a different deferral amount at any time.

Baim may elect to contribute a matching contribution equal to a percentage Baim determines annually for those employees that are participating in the Plan. Baim contributed 25% of the first 4% of employees' eligible compensation up to a maximum of 1% of the employees' total eligible compensation for the year ended December 31, 2024, amounting to \$66,149.

Baim may also elect an annual discretionary profit-sharing contribution equal to a percentage of eligible employees' annual compensation, regardless of whether or not the employee makes an elective contribution, as approved by the Board of Directors. In 2024, the Board of Directors elected to make a profit-sharing contribution of 3%, amounting to \$168,000.

The Plan allows for employer true up matching contributions, which are calculated at the end of the plan year and are funded subsequent to year end. Employer true up matching contributions for the plan year December 31, 2024, were \$3,595, and were funded fully by forfeitures that were included in the Fidelity Government Money Market Account in the accompanying statements of net assets available for benefits.

d. Participant Accounts

Each participant's account is credited with the participant's contributions, along with any of Baim's contributions, and an allocation of Plan earnings and losses and is reduced by any direct administrative expenses relating to distribution and loan processing fees. Allocations are based on participant's earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are fully vested at all times in their elective salary reduction account balances. Baim's matching and profit-sharing contributions in the participant's account are immediately vested for employees hired prior to January 1, 2010. For employees hired after January 1, 2010, the Plan follows the vesting schedule below for Baim's matching and profit-sharing contributions:

<u>Years of Credited Service</u>	<u>Vesting Schedule</u>
Less than one year of service	0%
After one year of service	25%
After two years of service	50%
After three years of service	75%
After four or more years of service	100%

Participants become fully vested upon death or disability.

f. Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan allowed is \$1,000. The loan term cannot exceed five years unless proceeds are used to purchase a primary residence, in which case the maximum repayment period is fifteen years. Participants may have two outstanding loans at a time. The loans are secured by the balance in the participant's account. Interest, as determined by the Plan Administrator, is due on the outstanding principal balance at the rate a bank would charge for a loan of that type. Principal and interest are paid ratably through payroll deductions.

g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. There are also retirement benefits available upon disability and death. Upon termination of service, a participant may elect to receive distributions in either the form of cash payments or rollovers. Distributions are made in lump-sum payments, partial lump-sum payments, and annuity distributions. Participants with vested balances of a value less than \$5,000 receive an involuntary cash-out distribution. Effective January 1, 2024, the involuntary cash-out distribution amount was increased to \$7,000 per the SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of the Treasury or their delegate.

h. Forfeitures

The portion of any non-vested Baim contributions remaining in a participant's account following termination of employment can be used to pay for plan expenses or reduce Baim's future contributions. There were \$30,625 and \$13,928 of unallocated forfeitures available as of December 31, 2024 and 2023, respectively. Forfeitures of \$1,533 were used to reduce plan expenses during 2024. Forfeitures of \$12,970 were applied to reduce Baim's 2024 profit-sharing contribution that was paid in 2025. Forfeitures of \$3,595 were also used to fully fund the 2024 true-up contribution that was paid in 2025.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

The assets of the Plan are invested in mutual funds and a money market fund. Mutual and money market funds are stated at fair market value as determined by Fidelity Management Trust Company, the qualified institution, based upon the last reported sales price on the last business day of the plan year. Gains and losses are recognized as incurred upon sale or maturity of investments or based on market value changes during the period.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of mutual and money market funds includes gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There were no defaulted loans as of December 31, 2024.

Contributions

Contributions from plan participants and the matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. Plan Sponsor discretionary profit-sharing contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by Baim and, accordingly, are not reflected in the accompanying statement of changes in net assets available for benefits. The asset management and third-party administrative fees are allocated to the individual participant accounts in accordance with the plan document and are included in administrative expenses. Investment-related expenses are included in net appreciation of mutual and money market funds.

Subsequent Events

Subsequent events have been evaluated through August 6, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition for disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to the certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although Baim has not expressed any intent to do so, Baim has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination participants shall become fully vested, and all accrued benefits shall be paid in accordance with the provisions of the Plan.

6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions. During 2024, the Plan paid the qualified institution and investment advisor administrative expenses of \$32,771.

8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in a number of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the accompanying statements of net assets available for benefits.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2023 and 2022, the Plan Sponsor failed to segregate and remit in a timely manner, certain participant contributions (salary reduction amounts) and loan repayments from its assets within the required time period as specified by the United States DOL Reg. 2520.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Plan Sponsor calculated and corrected lost earnings in February 2024.
