Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Thomas, Thomas & Hafer, LLP Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Thomas, Thomas & Hafer, LLP Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Thomas, Thomas & Hafer, LLP Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate that raise substantial doubt about the Thomas, Thomas & Hafer, LLP Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.



Note 1 – Plan Description

The following description of the Thomas, Thomas & Hafer, LLP Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan, established January 1, 1991, is a defined contribution plan covering all eligible employees and partners of Thomas, Thomas & Hafer, LLP (the “Company”) upon completion of one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s Trustees are responsible for oversight of the Plan and determine the appropriateness of the Plan’s offerings and monitors investment performance.

Contributions – Participants may contribute up to 50% of eligible compensation, not to exceed the annual amount permitted by Federal law. Eligible employees are auto enrolled at two percent of compensation to be deferred to the Plan. Catch-up contributions are permitted for eligible participants age 50 or older by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes a safe harbor non-elective contribution of 3% of eligible compensation. The Company made safe harbor matching contributions of \$674,047 and \$633,850 for the Plan years ended December 31, 2024 and 2023, respectively.

The Company may also make discretionary employer profit sharing contributions to each allocation group, as defined, in an amount determined by the Company. The discretionary contributions for the years ended December 31, 2024 and 2023 were \$990,076 and \$972,402, respectively. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service limitations.

Other employer contributions totaled \$0 and \$114 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts – Each participant's account is credited with the participant’s deferred compensation, and an allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested amounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary and the Company’s safe harbor non-elective contributions plus actual earnings thereon. Participants are vested in discretionary Company contributions plus actual earnings thereon based on years of continuous service. The participant receives 20 percent vesting for each year of service, becoming fully vested after five years of service.

Note 1 – Plan Description – Continued

Payment of Benefits – Upon termination of service, a participant may elect to receive either a lump-sum distribution equal to the vested value of his or her account or a partial distribution. Automatic distributions will be made to terminate participants with vested balances less than \$1,000. If a participant's vested balance is in excess of \$1,000 but less than \$7,000, the third-party administrator will rollover the distribution into an individual retirement plan (IRA) absent a distribution direction from the participant. If a terminated participant's vested balance exceeds \$7,000, a written request from the participant is required before the distribution. Hardship withdrawals are permitted by the Plan if certain criteria are met.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms range from one to five years or greater for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1% (4.25%-9.5%). Principal and interest are paid ratably through monthly or bi-weekly payroll deductions.

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$97 and \$476, respectively. Forfeitures may be used by the Plan to pay any administrative expenses of the Plan or reduce the Company's discretionary profit-sharing contribution. For the years ended December 31, 2024 and 2023, forfeitures used to pay Plan expenses totaled \$11,740 and \$16,718, respectively.

Life Insurance – The Plan previously allowed for participants to purchase life insurance through participant contributions to the Plan. At December 31, 2024 and 2023, 3 and 4 participants were invested in life insurance policies through the Plan, respectively. The Plan no longer permits the purchase of life insurance.

Note 2 – Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's custodian. See Note 5 for discussion and methods of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

Note 2 – Significant Accounting Policies – Continued

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All administrative expenses will be paid by the Plan unless paid by the Company. Certain administrative expenses associated with the Plan were paid by the Plan.

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through July 22, 2025, which is the date the financial statements were available to be issued.

Note 3 – New Accounting Standards

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

Note 4 – Investments

As of December 31, 2024 and 2023, the Plan's investments are held in a trust fund administered by Charles Schwab Bank. All investments are participant directed.

During the years ended December 31, 2024 and 2023, the Plan's investments, including gains and losses on investments bought, sold and held during the year, appreciated in value by \$3,849,763 and \$4,569,005, respectively.

Note 5 – Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 5 – Fair Value Measurements – Continued

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted market prices which represent the net asset value ("NAV") of shares held by the Plan at year end.

Common Stock: Valued at closing prices reported on active markets on which the individual securities are traded.

Money Market Fund: Valued at the quoted redemption price at year end.

Life Insurance: The life insurance policies are not actively traded and significant other observable inputs are not available. The life insurance policies are valued at their cash surrender value, which approximates fair value based on unobservable inputs using valuation methodologies to determine fair value, including discounted cash flows or other similar techniques.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination or partial plan termination, affected participants will become 100 percent vested in their accounts.

Note 7 – Parties-In-Interest Transactions

Certain Plan investments are managed by Charles Schwab Bank, the custodian, and therefore, these transactions qualify as party-in-interest transactions. The fair value of these investments was \$312,034 and \$421,299 as of December 31, 2024 and 2023, respectively. In addition, fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, and they are paid through revenue sharing, rather than direct payment.

Conrad Siegel Actuaries provides recordkeeping services to the Plan. Fees paid by the Plan for these services totaled \$26,045 and \$26,393 for the years ended December 31, 2024 and 2023, respectively.

The Plan has notes receivable from participants that are secured by participant account balances. All of these transactions qualify as party-in-interest transactions.

Note 8 – Tax Status

The Company adopted a non-standardized, pre-approved Profit Sharing Plan, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. The opinion letter stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan did not apply for a separate determination letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 11 – Subsequent Events

On November 25, 2024, the Plan was amended with an effective date of January 1, 2025, to include an automatic escalation feature. For participants automatically enrolled in the Plan, the automatic deferral will be increased by 1% each January 1 beginning with the first year following the participant's initial participation until the percentage equals 10%. The plan administrator will notify the participant 30 days before implementation. If an affirmative salary reduction is elected, the automatic escalation no longer will apply.
