## 1. Plan Description

The following description of Women's Care, P.C. Section 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective March 30, 2022. The Plan Trustees oversee governance of the Plan.

### General

The Plan is a defined contribution plan covering substantially all employees of Women's Care, P.C. (the Company), who have one year and 1,000 hours of service and are age 21 years or older. Effective July 18, 2024, the Plan's age requirement for eligibility was amended to 18 years or older. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as Plan Administrator. Participants must be employed as of the last day of the Plan year to be eligible to receive any employer paid profit sharing contributions, except in the event of death, disability, or retirement. Eligible participants enter the Plan on the first of the month after meeting the eligibility requirements.

### Contributions

*Participant contributions* – Each year, participants may contribute up to 85 percent of annual compensation on a pre-tax or Roth (after-tax) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts. The Plan includes an automatic enrollment provision whereby newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation.

*Employer match and profit-sharing contributions* – The Company may elect to make discretionary matching and profit-sharing contributions to the Plan. The Company matches 100 percent of employee contributions, up to 6 percent of eligible compensation deferred to the Plan. The matching contribution for the years ended December 31, 2024 and 2023 was \$801,439 and \$644,765, respectively. The profit-sharing contribution for the years ended December 31, 2024 and 2023 was \$992,217 and \$816,290, respectively, allocated based on the discretion of the executive committee of the Plan sponsor and in accordance with regulatory limits.

Contributions are subject to regulatory limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and earnings (losses) on the participant's account balances. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

**1. Plan Description, continued**

**Vesting**

Participants are vested immediately in their contributions and Company matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of continuous service. If termination is due to death, disability, or retirement at or beyond the normal retirement age, participant is considered to be 100 percent vested. Participants vest in the Company's profit-sharing contributions based on the following schedule:

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, a participant or their designated beneficiary may elect to receive the value of the participant's vested interest in their account in a lump-sum, installments, or a life annuity, or roll it over to another qualified plan. The Plan allows in-service distributions after a participant has reached normal retirement age, as defined by the Plan. The Plan does not allow hardships.

**Forfeitures**

Forfeitures are the non-vested portion of a participant's account that is lost after a five-year break in service or distribution upon termination of employment. Forfeitures are retained in the Plan and can be used to pay Plan administrative expenses or reduce future Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,078 and \$25,817, respectively, and were used to fund the Company profit-sharing contributions.

**Participant Loans**

Participants are not permitted to borrow from their accounts under the Plan.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Contributions**

Participant contributions, the employer match and profit-sharing contributions are recorded in the year in which the participant contributions are withheld or underlying compensation is paid.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefits are recorded when paid.

**Administration Expenses and Fees**

General Plan administrative expenses and investment management fees are paid by participant accounts, pro rata based on their account balances. General Plan administrative expenses may also be paid with forfeitures or by the Company. Plan expenses paid by the Company are excluded from these statements. Transaction-based fees relating to optional services, such as distribution requests, are charged directly against the appropriate participant's account.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

**3. Information Certified by the Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, acting as the trustee for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

**4. Tax Status**

The Plan is a volume submitter profit sharing plan with CODA. FMR LLC, the sponsor of the volume submitter plan, has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, that the basic Plan document satisfies Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**4. Tax Status, continued**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**6. Party-in-Interest Transactions**

Certain Plan mutual fund investments are managed by an affiliate of Fidelity Management Trust Company, the trustee of the Plan, and therefore these transactions qualified as party in interest transactions. Administrative fees paid to Fidelity Investments Institutional Operations Company LLC for 2024 and 2023 totaled \$16,458 and \$25, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**7. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**7. Fair Value Measurements, continued**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* The Plan's investments are units of mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

*Cash, interest-bearing:* Valued at cost which approximates fair value.

*Common/collective trusts:* Units held in the common/collective trusts are valued using the NAV of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily at NAV. All common/collective trusts investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Company contributions.

**9. Subsequent Events**

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
