There was no request for an extension of time to file. I started work on the return in early June because I knew I had travel planned for the end of the month.

However, the entity that created the pre-approved plan that we adopted had contacted me earlier in the year regarding whether we wished to terminate the plan and distribute the assets to individual IRA's. That entity had indicated that they would consult with their attorneys regarding how this could be done. Therefore my draft was saved awaiting word from that entity. I reached out to them via email but heard nothing.

Somehow I did not remember to go ahead and file the return. Maybe it was because of my travel, maybe because I was hospitalized earlier this year, maybe because my partner retired, maybe because I lost all my staff during covid and now don't have adequate reminders in place, but it was an honest mistake that I am now attempting to remedy. Please accept this as my reasonable explanation for failing to timely file this return.
