**Notes to Financial Statements**

---

**1. Plan Description**

The following brief description of the Wilson Construction Company 401(k) Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan intended to qualify as a profit sharing plan under Section 401(a) of the Internal Revenue Code (IRC), with a salary deferral feature qualified under Section 401(k). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The custodian of the Plan is Standard Insurance Company (Standard). All participant account balances are held by Standard. The participant directs the investment of all contributions and earnings thereon and may change their investment directive at any time.

**Eligibility** - All non-union employees who are 21 years of age or older are eligible to participate in the Plan. Non-union employees are considered as those employees whose employment is not governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining. Employees are eligible to participate in the Plan the first day of the month coinciding with the date they satisfy the eligibility requirements, which includes a three month service requirement.

**Contributions** - Each year, participants may contribute up to 100 percent of their pre-tax or post tax annual compensation to the Plan subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified employee benefit plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Wilson Construction Company (the Company) contributes a safe harbor amount of 3 percent of the employee's eligible compensation. The safe harbor contribution was \$953,135 and \$770,023 for the years ended December 31, 2024 and 2023, respectively.

The Company may also contribute, at its discretion and within statutory limitations, a profit sharing contribution to be allocated among participants based on each participant's annual compensation. The profit sharing contribution was \$582,988 and \$477,335 for the years ended December 31, 2024 and 2023, respectively.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, the Company's contributions, Plan earnings, and charged with an allocation of administrative expenses paid by the Plan and any distributions made to the participant. Allocations of administrative expenses are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Plan Description - Continued**

**Payment of Benefits** - Upon termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum distribution of the entire vested balance or roll over the entire vested balance to another plan or individual retirement account (IRA). Participants whose vested balance is \$7,000 or less will be automatically rolled over to an IRA. Hardship distributions are also allowed provided certain conditions are met. During the year ended December 31, 2024, the limit on accounts was increased to \$7,000 from \$5,000.

**Vesting** - Participants are immediately vested in their contributions and the Company's safe harbor contribution plus actual earnings on those contributions. Vesting in the Company's discretionary profit sharing contributions, plus earnings thereon, is based on years of service. A year of service is earned when a participant completes 1,000 hours of service during any plan year as defined in the Plan Agreement. The vesting percentage for the Company's contributions plus earnings thereon is as follows:

**Forfeited Accounts** - Forfeited balances of terminated participants' nonvested accounts will be used to restore rehired employees' previously forfeited account balances, to pay plan administrative expenses, or to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,870 and \$5,886, respectively. During the years ended December 31, 2024 and 2023, employer contributions were reduced by forfeitures and previous excess contributions of \$23,343 and \$12,037, respectively.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** - The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amount of net assets at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**2. Summary of Significant Accounting Policies - Continued**

**Investments and Income Recognition** - Investments (except for fully benefit-responsive investment contracts) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See *Note 4* for discussion of fair value measurements.

The Plan's investment in guaranteed investment contracts have been determined to be fully benefit-responsive contracts and therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See *Note 5* for further discussion of guaranteed investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefits Paid to Participants** - Benefits are recorded when paid. At December 31, 2024 and 2023, there were no benefits processed and approved for payment, but not paid.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment related expenses are included in net appreciation or depreciation in fair value of investments and other investment related expenses are included in administrative expenses.

**3. Information Certified by the Custodian (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net investment income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company, whom management has determined is a qualified institution.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The only assets held by the Plan at December 31, 2024 and 2023, that are reported at fair value are pooled separate accounts, which are valued at the net asset value per unit as provided by the custodian of the Plan. Net asset values per unit are derived from values of similar investments that have quoted prices in active markets. The net asset value is used as a practical expedient to estimate the fair value and is based on the fair value of the underlying investments, less liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations are carried out in an orderly business manner. Investments valued at the net asset value per unit practical expedient are not subject to the fair value hierarchy defined above. Investments held in pooled separate accounts totaled \$45,993,534 and \$37,260,840 at December 31, 2024 and 2023, respectively.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment objective for the pooled separate accounts is to lower the costs to investors through economies of scale available by combining the assets of multiple investors, to provide daily liquidity, and to provide better diversification. Each investor owns a participating interest that is calculated in units and represents its portion of the holdings of the fund.

**5. Guaranteed Investment Contracts**

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Standard, named the Stable Asset Fund. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**5. Guaranteed Investment Contracts - Continued**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$2,989,998 and \$4,140,419, respectively.

Certain events limit the Plan's ability to transact at contract value with Standard. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (d) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The Plan can elect to end its participation in the contract at any time. If the Plan elects to end participation, the Plan will receive the lesser of the guaranteed contract value or market value; if the market value is less than the Stable Asset Fund, the Plan may have the option of transferring its investment to a fixed rate, fixed maturity, general account contract of Standard, in which case the Plan's guaranteed value would be maintained.

The guaranteed investment contract allows Standard to terminate the contract with 30 days advance written notice solely for reasonable cause, including Plan disqualification or failure to maintain Plan assets of at least \$25,000. Upon termination by Standard, a market value adjustment or other withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

**6. Transactions with Parties-in-Interest**

The Company is the Plan Sponsor and Administrator and pays certain administrative costs, including accounting, legal, and consulting fees, on behalf of the Plan.

Certain Plan investments are managed by Standard. These investments and investment transactions qualify as party-in-interest transactions. Certain investment management fees are included in net appreciation or depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their accounts, and the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

**8. Income Tax Status**

Effective January 1, 2022, the Plan adopted a pre-approved basic plan document with an opinion letter dated June 30, 2020. The letter states the Plan is designed in accordance with the applicable requirements of the IRC and, therefore, the Plan Administrator believes the Plan is qualified and the related trust is tax exempt. Although the Plan had been amended since receiving the opinion letter, the Plan Administrator believed the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in a variety of investments. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible changes in the values of investment securities will occur in the near-term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


