Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of Iron Senergy, LLC 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and Adoption Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan available to eligible employees, as defined, of Iron Senergy, LLC, Iron Senergy Holding, LLC, Iron Execution, LLC, Iron Coal Sales, LLC, Cumberland Energy, LLC, Emerald Iron, LLC, Iron Coal Resources, LLC, Iron Pennsylvania Land, LLC, and Iron Pennsylvania Terminal, LLC (collectively referred to as the “Plan Sponsor”).

Employees are excluded from the Plan if they are covered by a collective bargaining agreement, nonresident aliens, employees of an affiliate that is not a participating employer, leased employees, or temporary employees. Participation in the Plan is strictly voluntary, and employees are eligible to participate after one hour of service. Newly eligible employees are automatically enrolled in the Plan at a 5% pre-tax deferral rate unless they affirmatively elect not to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Management of the Plan Sponsor is responsible for oversight of the Plan and for determining the appropriateness of the Plan’s investment offerings and monitoring the investment performance. Transactions are processed through Bank of America, N.A (the “Custodian”).

Contributions

Participants may contribute up to 70% of their pre-tax, post-tax (Roth), or after-tax (non-Roth) annual compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions to the Plan. Participants may also contribute to the Plan amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

Effective October 1, 2024, the Plan was amended to allow in-plan Roth conversions.

The Plan Sponsor makes discretionary matching contributions equal to 100% of the first 3% of compensation a participant contributes to the Plan. Participants are eligible to receive these discretionary matching contributions at the same time they are eligible for participation in the Plan.

Cash contributions receivables, if any, are unsecured.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and Plan Sponsor contributions, investment earnings and losses that are allocated based on each participant's relative account balance within the respective fund, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral and rollover contributions, Plan Sponsor contributions, and actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are required to bear interest at a reasonable rate determined by the Plan Administrator and are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over a period of time up to ten years. The notes are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the Internal Revenue Code (IRC), has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

Payment of Benefits

If the participant's vested benefit in the Plan does not exceed \$5,000 at the time of termination of employment, the participant's benefit may be distributed in a single lump-sum payment as soon as administratively feasible. If the participant's vested benefit in the Plan exceeds \$5,000 at the time of termination of employment, the participant may elect to either maintain their account in the Plan, receive a lump-sum distribution, or rollover their account balance into an individual retirement account. Participants may also withdraw their vested account balances at any time on or after the age of 59½ or upon retirement, death, or disability.

1. Description of the Plan (continued)

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under plan provisions, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting, as are the annual returns filed under applicable provisions of ERISA and the IRC.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

Investments

Investments are reported at fair value. Fair value (*Note 5*) is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's management determines the Plan's valuation policies utilizing information provided by the Custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies (continued)

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through July 28, 2025, the date the financial statements were available to be issued.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by Merrill Lynch Pierce Fenner & Smith Inc. that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Information (Unaudited)

The Custodian holds the Plan's investments assets and executes transactions therein. Financial information relating to those assets disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, net realized and unrealized appreciation in the fair value of investments, dividend and interest income, and interest income on notes receivable from participants, is based upon information provided to the Plan Administrator and agreed to or derived from information certified as complete and accurate by the Custodian.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

5. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes to the methodologies used as of December 31, 2024 and 2023.

Common collective trusts: Valued at the net asset value (NAV), which is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The funds consist of individual security positions that are mostly securities easily traded on recognized market exchanges. These securities are priced and traded daily, and therefore, these funds are valued daily.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Unrealized gains (losses) are included in net realized and unrealized appreciation in the fair value of investments in the statements of changes in net assets available for benefits.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.
