**Notes to Financial Statements**

**1. Description  
of Plan**

The following brief description of the Local Union 370 United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry of the United States and Canada AFL-CIO Supplemental Unemployment and Disability Trust Plan provides only general information about the Plan's provisions. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**General**

The Plan was formed under an agreement between Local Union 370 United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry of the United States and Canada AFL-CIO ("Local 370") and its members. The Plan is governed by the Board of Trustees. The Plan provides supplemental unemployment and vacation benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

A participant must be on the out of work list. A participant acquires one full credit for each month during which the participant works at least seventy (70) hours but less than one hundred forty (140) hours; and two (2) full credits for each month the participant works one hundred forty (140) or more hours, to a maximum of twenty full credits. In addition, one (1) full credit is earned for each full week the member serves in the "Uniformed Services".

A participant shall be permitted to make self-contributions at the prevailing rate to the Trust Plan for hours of work actually performed while employed outside the jurisdiction of UA Local Union 370 to earn credits. However, such employment must be within the jurisdiction of another UA Local Union, and certification of the hours must be given to the Trustees.

Once self-payments are initiated, the payments must continue until the participant returns to Local 370's jurisdiction to work; this will be for the entire duration of the participant's out-of-town work. If a participant chooses not to make self-payments, the participant will not lose any benefit credits already accumulated.

**Benefits**

The Plan provides for payment of supplemental unemployment benefits to covered participants. Payments are made to participants due to layoff, disability, jury or military duty.

Participants do not have a vested right in contributions made and no vested right to any benefits provided by the Plan except as provided under the Trust Plan. The benefits provided by the Plan shall be only such as can be provided from the assets of the Trust Fund and if Trust assets are not available, no benefits will be provided.

**Contributions**

Members of Local 370 covered by a collective bargaining agreement, negotiated between Local Union 370 United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry and the Flint Association of Plumbing-Heating-Cooling Contractors, on a voluntary basis, contribute to the vacation portion of the plan at a rate of \$.50 or \$1.00 per hour. Income and expenses incurred by the Plan are not allocated to participants' vacation accounts. Participants have a 100% vested right in their vacation account. Members also contribute to the supplemental benefit portion at a rate of \$.25 per hour, by means of a union dues check-off.

**2. Significant  
Accounting  
Policies**

**Basis of Accounting and Use of Estimates**

The accompanying financial statements have been prepared using the modified cash basis of accounting modified to provide for the reporting of investments at fair value, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Accordingly, additions to net assets, other than net unrealized appreciation of investments, are recognized when received rather than when earned, and deductions from net assets, other than net unrealized depreciation of investments, are recognized when paid rather than when the obligation is incurred. The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Payment of Benefits**

Supplemental benefit payments are recorded when paid and are paid from the general assets of the Plan.

**Administrative Fees**

The Plan pays administrative expenses that consist primarily of administrative fees to the third-party administrator, legal and audit expenses. These are reported on the statement of changes in net assets available for benefits as administrative expenses.

**Subsequent Events**

The Plan has evaluated subsequent events through the date of the independent auditor's report, the date the financial statements were available to be issued.

**3. Benefit Obligations**

The benefit obligations of the Plan at any month end is the product of participants' accumulated credit balances at the benefit rate of \$125.00 per week to a maximum of twenty (20) credits.

**4. Tax Status**

The Plan received an exemption letter from the Internal Revenue Service dated February 22, 1974, stating that the trust is tax exempt under the provisions of Section 501(c) (5) of the IRC.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, state or local taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. Priorities Upon  
Termination  
of the Plan**

Although it has not expressed any intention to do so, the Board of Trustees, as sponsor, has the right under the Plan to modify the benefits provided to, and contributions required of, employers to discontinue contributions at any time and to terminate the Plan. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for the participants. No assets of the Plan may be used for purposes other than for the exclusive benefit of the Plan's participants.

As described previously, the Plan pays fees for several arrangements with service providers. These transactions are considered exempt party in interest transactions under ERISA.

**7. Risks and  
Uncertainties**

Cash consists of monies held in non-interest-bearing transaction accounts. The Plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. At December 31, 2024, the Plan's cash exceeded federally insured limits by approximately \$258,000.
