Note 1 - Plan Description

The following description of Anesthesia Associates of Ann Arbor, PLLC Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Anesthesia Associates of Ann Arbor, PLLC (the "Company") and its affiliates, Midwest Anesthesia Consultants, LLC; Ascent Medical Group, LLC; Siromed Physician Services, Inc.; and A4 Anesthesia Holdings. The Plan provides benefits to eligible participants in accordance with the provisions of the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides employees the opportunity to contribute a portion of their compensation as a pretax or after-tax deferral up to a maximum of 75 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Upon eligibility, employees are enrolled automatically at a deferral rate of 5 percent unless the employee elects a different percentage or amount. Additionally, there is an automatic deferral escalation in which deferrals are increased by 1 percent in March of each year up to 12 percent. Employees can opt out of both the automatic enrollment and escalation. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer safe harbor nonelective contributions in the amount of 3 percent of an eligible participant's compensation for the year. Safe harbor contributions were \$1,022,198 for the year ended December 31, 2024. In addition, the Plan provides for discretionary profit-sharing contributions, which are determined by the board of directors every year and then allocated based on eligible compensation. Employer discretionary profit-sharing contributions were \$2,263,505 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in their elective deferrals, employer profit-sharing and safe harbor nonelective contributions, rollover contributions, and any income or loss thereon, except for those employed by Midwest Anesthesia Consultants, LLC, under which vesting in the Company's profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 50 percent after two years of service and become fully vested after three years of service.

Note 1 - Plan Description (Continued)

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount or in monthly installments over a period that does not extend beyond the participant's life or the participant's designated beneficiary's life. At any point, participants can withdraw all or part of the value of the following contributions: rollover contributions and Roth rollover contributions. If a participant reaches age 55, has participated in the Plan for at least 120 months, and is still an employee of the Company, the participant may withdraw all or part of the value of employer nonelective contributions. If a participant reaches age 70½ and is still an employee of the Company, the participant may withdraw all or part of their account balance.

Participants may request that all or a portion of their deferral contributions be distributed in the case of financial hardship, as defined in the plan document. The minimum hardship withdrawal amount is \$500, and participants are limited to two withdrawals during the calendar year.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are reallocated back to the participant accounts.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Upon termination of the Plan, participants become 100 percent vested in their account balances.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by T. Rowe Price Trust Company, Charles Schwab Trust Bank, or their affiliates. T. Rowe Price Trust Company and Charles Schwab Trust Bank (collectively, the "Custodians") are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 29, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The Custodians hold substantially all the Plan's investments and execute substantially all related investment transactions. The investment balances and related income and losses, except for the self-directed brokerage account (SDBA), included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians. The related net investment income of the SDBA was \$402,128 for the year ended December 31, 2024.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Note 5 - Fair Value Measurements (Continued)

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share, or its equivalent, of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

Other Contract Assets - Life Insurance Policies

Life insurance policies are valued at fair value based on the cash surrender value of the policies.

Self-directed Brokerage Accounts

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded mutual and money market funds and equity securities. The mutual funds, money market funds, and equity securities are valued at the closing quoted prices reported in active markets.
