Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Loren Cook Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Loren Cook Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities For The Audit Of The Financial Statements section:

Basis For Opinion

1. General Information

Description Of The Plan

The following brief description of the Loren Cook Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for more complete information about the Plan's provisions.

General

The Plan was formed on January 1, 1996 by Loren Cook Company (the Company and Plan Sponsor). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Eligibility

Generally, an employee is eligible to participate in the Plan on the first business day of the quarter coincident with or immediately after the date on which the employee completes a one-year period of service, which includes not less than 1,000 hours of service.

Contributions

Participants may elect to contribute up to 40% of pretax annual compensation, as defined, to the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes contributions at a discretionary percentage of participants' compensation. Prior to July 2023, the Company made contributions equal to 1.5% of compensation for each active participant. As of July 2023, the Company increased its contribution from 1.5% to 1.8% of compensation for each active participant, subject to IRC limitations.

Notes To Financial Statements (*Continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company contributions and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investments

Participants direct their deferral and Company contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year.

Vesting

Employees are immediately vested in their deferral contributions, Company contributions, and actual earnings thereon.

Notes Receivable From Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the vested account balance, reduced by any outstanding loan balance during the one-year period ending on the day before a new loan is made, subject to IRC limitations. Each plan participant is limited to one note at a time. Note terms range from one to five years unless the loan is for the purchase of a first home, in which case the repayment term may extend up to ten years. Loans are secured by the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably primarily through regular payroll deductions.

Payment Of Benefits

Upon the participant's death, retirement or separation from service, the participant may elect to receive either a lump-sum amount equal to the participant's vested interest in his or her account, or through annuity options, as defined by the Plan. On termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or the beneficiary may withdraw the participant's balance as a single-sum payment.

In-service distributions may be made to a participant who has not separated from service provided the participant has attained the age of 59½.

Notes To Financial Statements (*Continued*)

Participant Hardship Withdrawals

A participant is permitted to withdraw from the Plan a portion of their account in the event of undue financial hardship.

Administrative Expenses

The Plan permits the payment of expenses incurred in connection with the recordkeeping and administration of the Plan to be made from the Plan's assets. Expenses will generally be allocated among the accounts of all participants in the Plan proportionately based on the value of the participant's account balances. Specific fees such as loan processing fees may also be charged directly to a participant's account in response to transactions requested under the Plan. Certain expenses, such as advisory, audit and tax return preparation, are paid by the Company.

2. Summary Of Significant Accounting Policies

Basis Of Presentation

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use Of Estimates

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could vary from those estimates.

Investment Valuation And Income Recognition

Investments, except for the fully benefit-responsive investment contract which is reported at contract value, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Notes To Financial Statements (*Continued*)

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Principal Fixed Income Guaranteed Option is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available for issue, which is the date of the Independent Auditors' Report.

3. Investments

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Principal Life Insurance Company and Principal Trust Company (collectively, Principal), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal that the information provided to the Plan Administrator related to the following information is complete and accurate to the best of their knowledge and belief.

4. Fair Value Measurements

Fair value is determined based upon a framework that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820, Fair Value Measurement, are described below.

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds And Money Market Account

Valued at the daily closing price as reported by the funds. The mutual funds and money market account held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market account held by the Plan are deemed to be actively traded.

Pooled Separate Accounts

Valued at the NAV of units held by the Plan at year end. The NAV as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are primarily comprised of shares of registered investment companies held through subaccounts of a separate account of an insurance company at December 31, 2024 and 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. All pooled separate accounts have daily redemption frequencies at NAV with no redemption notice periods, and file annual reports on Form 5500 as direct filing entities. There are no capital commitments related to any of the Plan's pooled separate accounts.

Common/Collective Trusts

Valued at the NAV of units of the individual funds. The NAV, as provided by the trustees of the invested funds, is used as a practical expedient to estimate fair value and is calculated daily by the trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Withdrawals from a common/collective trust for benefit payments are made within 30 days after the request for distribution. The common/collective trusts file annual reports on Form 5500 as direct filing entities, and there are no capital commitments related to the common/collective trusts.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

The Plan is invested in a fully benefit-responsive investment contract (the Contract) with Principal. Principal maintains the contributions in a general account. The investment account issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the account. Contract Value, as reported to the Plan by Principal, represents contributions plus earnings, less participants withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon schedule with the issuer and is reset on a semi-annual basis. The crediting interest rate as of December 31, 2024 and 2023 was 1.65% and 1.55%, respectively.

Certain events may limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification.

6. Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan and the Plan Sponsor.

During the years ended December 31, 2024 and 2023, certain administrative expenses were paid directly by the Plan.

7. Income Tax Status

Effective February 17, 2022, the Plan was restated with a pre-approved 401(k) profit sharing plan document for savings plans sponsored by Principal Financial Group. Principal Financial Group received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan's qualified status. The Company has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Although the Plan has been amended since the pre-approved plan received the letter, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

8. Party In Interest Transactions

Certain Plan investments are units of a guaranteed interest account and units of pooled separate investment accounts and common/collective trusts managed by Principal or affiliates of Principal. Principal is the recordkeeper for the Plan, and, therefore, these transactions qualify as party in interest transactions.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions allowable under ERISA.

9. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and the Company's collective bargaining agreement. In the event of plan termination, participant accounts will remain 100% vested and non-forfeitable. Participant accounts will be held under the Plan and continue to be credited with investment earnings until used to provide benefits according to the terms of the Plan.
