We have performed audits of the financial statements of CubeSmart, L.P. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### (1) Description of Plan

The following description of CubeSmart, L.P. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan which provides savings benefits to eligible employees. Under the Plan, all employees of CubeSmart, L.P. (the Company) who have met the eligibility requirements may participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Effective March 15, 2024, participants of the Incentive Retirement Plan for the Employees of LAACO, Ltd., a California Limited Partnership (LAACO), merged into the Plan. Participants of LAACO are 100% vested.

##### ***Participation***

An employee may elect to participate in the Plan as of the first pay period coinciding with the first of the month following attainment of the age of 21 and completion of six months of service. Unless employees elect otherwise, eligible participants are automatically enrolled in the Plan.

##### ***Contributions***

Each year participants may contribute up to 100% of eligible pre-tax annual compensation, as defined in the Plan. Participants may elect to have their deferrals be either pretax or after-tax (Roth) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company's matching contribution is 50% of the first 6% of the participant's elective deferral contribution. Company matching contributions are made on employee deferrals beginning after the completion of six months of service, on a quarterly basis. The participant must be a covered employee on the last day of the quarter in order to receive a matching contribution. The Company may also elect to make additional discretionary contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### (1) Description of Plan, Continued

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Company's matching contributions, allocations of plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service in accordance with the following schedule:

Years of Service	Percentage Vested
Less than 1	0%
1 but less than 2	50%
2 or more	100%

##### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum equal to the value of the participant's vested interest in his or her account, or annual installments over their lifetime. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts total \$20,534 and \$17,470, respectively. These accounts will be used to either pay administrative expenses of the Plan or offset employer matching contributions, at the Company's discretion. During 2024, forfeited nonvested accounts were used to reduce employer matching contributions by \$64,402.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Contributions*

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Administrative expenses are paid by the Company or the Plan at the Company's discretion. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.

##### *Subsequent Events*

The Plan has evaluated subsequent events through July 17, 2025, the date the financial statements were available to be issued.

#### (3) Financial Information Certified by the Trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), a qualified institution.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Common stock:* These investments are valued using quoted market prices available in an active market for identical instruments for which the individual securities are traded.

*Common collective trust:* Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Participant transactions may occur daily. If the Plan were to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### (5) Tax Status

The Plan uses a prototype plan document developed by T. Rowe Price Retirement Plan Services Inc. T. Rowe Price Retirement Plan Services Inc. obtained its latest determination letter dated August 19, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended subsequent to the latest determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their account balances.

#### (7) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments include a registered investment account and a common collective trust held by T. Rowe Price. T. Rowe Price is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in the fair value of the investment. The Plan invests in CubeSmart common stock. At December 31, 2024 and 2023, the Plan held 15,117 and 15,665 shares, respectively, of CubeSmart common stock.
