INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Day's Chevrolet Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institutions in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of Plan

The following description of the Day's Chevrolet Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees except independent contractors of Day's Chevrolet Inc. (the Company or Plan Sponsor) who have six months of service and who are age twenty-one or older. All eligible employees are able to enter the Plan on January 1st or July 1st following the completion of six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pre-tax contributions up to 100% of eligible compensation as defined by the Plan document, generally not to exceed a maximum of \$23,000 for the Plan year, plus catch-up contributions of up to \$7,500 for those participants who are at least 50 years of age during the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan Sponsor contributes matching contributions in an amount equal to 25% of a participant's contribution up to 4% of the participant's compensation, as defined in the Plan document. The Plan Sponsor, at its discretion, may make supplemental contributions. There were no supplemental contributions made in 2024. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Plan Sponsor's contributions, earnings or losses on the investments in their account, and is charged with certain transaction fees. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in their contributions plus earnings and losses thereon. Participants vest in the Plan Sponsor contributions 20% per year after two years of service and are fully vested after six years of service, or upon the occurrence of their 65th birthday, total or permanent disability, or death.

Forfeited Accounts

There were no forfeited non-vested accounts at December 31, 2024 and 2023. Forfeited non-vested accounts may be used to pay administrative expenses or reduce Plan Sponsor contributions. In 2024, no monies were forfeited from participants accounts to pay administrative expenses or reduce Plan Sponsor contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account balance. The notes are secured by the vested balance in the participant's account and must bear a reasonable rate of interest as defined in the Plan document. As of December 31, 2024, the fixed rate of notes ranged from 3.25% to 8.50% for the term of the loan, not to exceed 5 years, unless used for the purchase of a personal residence. Principal and interest are paid through payroll deductions. Each participant is limited to one outstanding note at a time. Notes receivable from participants qualify as party-in-interest transactions.

Payment of Benefits

At time of death, disability, termination of service or retirement, the participant or their beneficiary may elect to receive a payment of the vested interest in their account in a lump sum distribution or annual installment. If a participant terminates employment and has a balance between \$1,000 and \$5,000, the participant will automatically have their account paid as a direct rollover to an individual retirement account established by the Company for the benefit of the participant equal to the value of their account. If the account balance is \$1,000 or less, the participant will automatically receive a lump-sum distribution equal to the value of their account. Participants are eligible to receive hardship withdrawals when certain conditions are met. After attaining the age of 59 ½, participants may also be eligible to receive up to five distributions in any 12-month period when certain conditions are met.

Administrative Expenses

Administrative expenses paid directly by participants include distribution fees, loan fees and other transaction fees. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. All other administrative expenses are paid by the Company. The Company does not expect reimbursement from the Plan for payment of these administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Plan Sponsor's matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and supplemental contributions are considered payable to the Plan when approved by management. Any unfunded participant or Plan Sponsor's contributions are included in participant or Plan Sponsor contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the guaranteed interest account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the note to be in default, the note balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

As of December 31, 2024, the Company had not adopted any provisions of the SECURE 2.0 Act of 2022 (the Act). However, subsequent to year-end, management indicated its intent to adopt certain provisions effective January 1, 2025, in accordance with the Act's implementation timeline. The Company is currently evaluating the impact of these changes, and formal plan amendments are expected to be made during 2025.

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institutions

All investment information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, including the net increase in fair value of investments and interest income, for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (collectively, Principal), the Plan's qualified institutions.

4. Investments

Plan investments include pooled separate accounts and a guaranteed interest account managed by Principal. Principal is a service provider of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include public healthcare emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest

priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value and contract value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in pooled separate accounts are valued daily using their net assets value (NAV) (Level 1). The NAVs are based on the fair value of the mutual funds, stocks, debt instruments, and other securities in the accounts. The pooled separate accounts can be traded daily at their NAV.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The guaranteed interest account is a fully-benefit responsive investment contract and is a general obligation of Principal. Principal maintains the contributions in a general account. Contract value of the guaranteed interest account represents deposits and transfers made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a rate guaranteed by Principal. The crediting rate is reviewed on a semi-annual basis for resetting.

5. Income Tax Status

The Plan is operating under a prototype plan document offered by Principal. The Internal Revenue Service has determined and informed Principal by a letter dated June 30, 2020, that the prototype is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants would become fully vested in their account balances.

7. Reconciliation of Financial Statements to Form 5500
