### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of SmartComms, LLC 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of Plan

#### *General*

SmartComms, LLC 401(k) Profit Sharing Plan (Plan) is a defined contribution plan that has been established to provide retirement benefits to eligible employees of SmartComms, LLC (Company). The Plan is a defined contribution plan, covering all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *Eligibility*

To be eligible to participate in the Plan, an employee must have attained the age of 21 and have been employed by the Company for at least one month. All classifications of the Company are eligible to participate in the Plan upon completion of the eligibility requirements except for employees whose benefits are governed by a collective bargaining agreement and nonresident aliens with no income from a U.S. source.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of the invested funds' earnings. Allocations of earnings are based on account balances as defined by the Plan. Certain administrative expenses may be charged directly to the participant's account incurring those expenses.

#### *Contributions*

Qualified employees may contribute a percentage of their pre-tax and after-tax annual compensation, as defined in the Plan, not to exceed the Internal Revenue Service (IRS) limitations each year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 are eligible to make catch-up contributions, subject to the statutory limit. The Company allows discretionary matching contributions of 100% up to 10% of gross pay with a maximum matching contribution totaling \$3,000 per year.

#### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in Company matching and discretionary contributions as follows:

#### ***Forfeitures***

Forfeitures of unvested Company matching and discretionary contributions are used to pay Plan expenses and to reduce future Company matching contributions. For the year ended December 31, 2024, forfeitures used to reduce company matching contributions totaled \$29,001. Forfeitures available for future use at December 31, 2024 and 2023 totaled \$1,898 and \$4,343, respectively.

#### ***Benefits***

Distribution of a participant's vested account is available upon the participant's retirement, death, disability, termination of employment or attainment of age 59 ½ or financial hardship.

#### ***Notes Receivable from Participants***

Notes receivable from participants represent loans that are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Plan participants may borrow from their accounts an amount generally not to exceed the lesser of \$50,000 or 50% of their vested account balance, except for amounts borrowed under the CARES Act. The repayment terms of loans may not exceed five years except for loans used to acquire a principal residence. Each loan bears interest at the *Wall Street Journal* prime rate plus two percent. Principal and interest are paid ratably through automatic payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be a distribution, notes receivable from participants is reduced and a benefit payment is recorded.

### ***Plan Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan in compliance with the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested in their accounts. The Company, however, does not intend to terminate the Plan.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Estimates and Assumptions***

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could vary from the estimates used in preparing the accompanying financial statements.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

### ***Payment of Benefits***

Benefits to participants are recorded when paid.

### ***Risks and Uncertainties***

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

## **3. Fair Value Measurements**

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

- Level 1 quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and model-derived valuations in which all significant inputs are observable in active markets.
- Level 3 valuations derived from valuation techniques in which one or more significant inputs are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

#### ***Mutual Funds***

These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying asset owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

#### ***Collective Trusts***

The Plan holds investments in collective trusts, that invest in assets, typically bonds and common stock. The fair value of the units of this investment is valued at NAV per unit, as determined by the custodian. The NAV is used as a practical expedient to estimate fair value.

The Plan holds other assets not measured at fair value on a recurring basis, including employer and participant contributions receivable. The fair value of these assets approximates the carrying amounts in the accompanying financial statements due to the short maturity of the instruments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **6. Tax Status**

The Plan has received a determination letter from the IRS dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.

#### **7. Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are managed by the Trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment.

#### **8. Subsequent Events**

Plan management has evaluated subsequent events through August 8, 2025, the date the financial statements were available to be issued and concluded that no additional disclosures are required.
