Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance, and; therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to, or derived from, the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to, or is derived from, the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the Bonney Forge Corp. Deferred Profit Sharing Plan for Bargaining Unit Employees (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution pension plan covering all employees of the Bonney Forge Corporation (the Company) who are in the United Steel Workers of America Local Union 6521-01 and who have completed 30 days of service and obtained the age of 18. For Company contributions, a participant must complete 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Effective November 3, 2023, participants may make Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. Participants are automatically enrolled in the Plan on the plan entry date, as defined in the plan document, unless they affirmatively elect to opt out. Participants who are automatically enrolled will have 1% of their eligible compensation withheld and remitted to the Plan. Each January 1, each participant's deferral rate is automatically increased 1%, up to a maximum of 10%, unless elected otherwise.

Employees employed on February 15, 2017, or recalled after that date from the layoff list as of February 15, 2017, will receive a Company matching contribution equal to 50% of the participant's elective deferral not exceeding 4% of eligible compensation (maximum match equaling 2% of the participant's eligible compensation). Employees hired on or after April 15, 2017 will receive a Company matching contribution equal to 100% of each participant's elective deferral not exceeding 3% of eligible compensation, plus 50% of each participant's deferral in excess of 3%, but not in excess of 5% of eligible compensation (maximum match equaling 4% of the participant's eligible compensation). Employees employed on February 15, 2017, or recalled after that date from the layoff list as of February 15, 2017, will also receive a Company discretionary contribution equal to 2% of eligible compensation.

On February 12, 2024, the plan was amended to adjust the employer contributions. Subsequent to this amendment, employees employed on December 15, 2016, or recalled after that date from the layoff list as of December 15, 2016, will receive a Company matching contribution equal to 50% of the participant's elective deferral not exceeding 4% of eligible compensation (maximum match equaling 2% of the participant's eligible compensation). Employees hired on or after December 15, 2016 will receive a Company matching contribution equal to 100% of each participant's elective deferral not exceeding 3% of eligible compensation, plus 50% of each participant's deferral in excess of 3%, but not in excess of 5% of eligible compensation (maximum match equaling 4% of the participant's eligible compensation). Employees employed on December 15, 2016, or recalled after that date from the layoff list as of December 15, 2016, will also receive a Company discretionary contribution equal to 2% of eligible compensation.

Contributions (continued)

The Company may also make a discretionary nonelective contribution, as defined by the Plan. The Company did not make a nonelective contribution for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

In November 2024, the Plan was amended to include a qualified replacement plan provision whereby the employer, who is the Company, transferred \$300,000 to the Plan from a related terminating defined benefit plan. The amount is held in a suspense account and allocated ratably over seven plan years, starting in 2024. Activity (allocation and investment income) for the year ended December 31, 2024 is not material to the financial statements. Amounts are allocated in accordance with the nonelective contribution criteria. Remaining amounts to be allocated over the term are included as deferred revenue on the statement of net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of (a) the Company's discretionary and discretionary nonelective contributions, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case the loan may be for up to ten years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Upon termination of employment, if a participant's vested interest in their account exceeds \$5,000, no distribution shall be made to the participant before they reach the age of normal retirement or receipt of consent to pay out by the participant and their spouse, if applicable. If the participant's vested balance does not exceed \$5,000, the vested account balance is paid out in the form of a lump-sum distribution. In the event of a mandatory distribution greater than \$1,000, the distribution will be paid in the form of a direct rollover to an individual retirement arrangement designated if the participant does not elect a direct rollover or lump-sum distribution.

In addition, the Plan allows for hardship distribution, if certain criteria are met, and in-service withdrawals for participants, which have attained age 59-1/2.

Forfeited Accounts

Forfeited nonvested accounts, if any, may be used to pay administrative expenses or used to reduce the matching and nonelective contributions. Forfeitures utilized during the years ended December 31, 2024 and 2023 were immaterial. The balance as of December 31, 2024 and 2023 was immaterial.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management and custody expenses are also included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Note 3 - Information Certified and Provided by Fidelity Management Trust Company

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The collective trust funds (CTFs) are valued based on the NAV of units of the units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. The CTFs are direct filing entities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Company has adopted a pre-approved plan document that was sponsored by FMR LLC. The pre-approved plan document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company contribution portion of their account.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management, custody services, and plan administrative services were not material to the Plan.

Note 9 - Transfer of Assets

During 2024 and 2023, plan assets of participants were transferred from the Plan to the Bonney Forge Corp. Deferred Profit Sharing Plan.

Note 10 - Rollover Contributions

On September 20, 2022, the Board of Directors voted to terminate the Bonney Forge Corporation-Huntingdon Machine Division Pension Plan for Employees of Huntingdon Machine USW Local 6521-01 (the Pension Plan). The Pension Plan termination was approved by the IRS on September 29, 2023, and participants began distributing balances. An aggregate of \$199,007 was rolled into the Plan during the year ended December 31, 2024 as a result of the Pension Plan termination and liquidation, and is included in rollovers on the statement of changes in net assets available for benefits.

Note 11 - Subsequent Events

Plan management has evaluated subsequent events through August 8, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Bonney Forge Corp. Deferred Profit Sharing Plan for Bargaining Unit Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Note 1 - Description of Plan

The following description of the Bonney Forge Corp. Deferred Profit Sharing Plan for Bargaining Unit Employees (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution pension plan covering all employees of the Bonney Forge Corporation (the Company) who are in the United Steel Workers of America Local Union 6521-01 and who have completed 30 days of service and obtained the age of 18. For Company contributions, a participant must complete 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Effective November 3, 2023, participants may make Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. Participants are automatically enrolled in the Plan on the plan entry date, as defined in the plan document, unless they affirmatively elect to opt out. Participants who are automatically enrolled will have 1% of their eligible compensation withheld and remitted to the Plan. Each January 1, each participant's deferral rate is automatically increased 1%, up to a maximum of 10%, unless elected otherwise.

Employees employed on February 15, 2017, or recalled after that date from the layoff list as of February 15, 2017, will receive a Company matching contribution equal to 50% of the participant's elective deferral not exceeding 4% of eligible compensation (maximum match equaling 2% of the participant's eligible compensation). Employees hired on or after April 15, 2017 will receive a Company matching contribution equal to 100% of each participant's elective deferral not exceeding 3% of eligible compensation, plus 50% of each participant's deferral in excess of 3%, but not in excess of 5% of eligible compensation (maximum match equaling 4% of the participant's eligible compensation). Employees employed on February 15, 2017, or recalled after that date from the layoff list as of February 15, 2017, will also receive a Company discretionary contribution equal to 2% of eligible compensation.

On February 12, 2024, the plan was amended to adjust the employer contributions. Subsequent to this amendment, employees employed on December 15, 2016, or recalled after that date from the layoff list as of December 15, 2016, will receive a Company matching contribution equal to 50% of the participant's elective deferral not exceeding 4% of eligible compensation (maximum match equaling 2% of the participant's eligible compensation). Employees hired on or after December 15, 2016 will receive a Company matching contribution equal to 100% of each participant's elective deferral not exceeding 3% of eligible compensation, plus 50% of each participant's deferral in excess of 3%, but not in excess of 5% of eligible compensation (maximum match equaling 4% of the participant's eligible compensation). Employees employed on December 15, 2016, or recalled after that date from the layoff list as of December 15, 2016, will also receive a Company discretionary contribution equal to 2% of eligible compensation.

Contributions (continued)

The Company may also make a discretionary nonelective contribution, as defined by the Plan. The Company did not make a nonelective contribution for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

In November 2024, the Plan was amended to include a qualified replacement plan provision whereby the employer, who is the Company, transferred \$300,000 to the Plan from a related terminating defined benefit plan. The amount is held in a suspense account and allocated ratably over seven plan years, starting in 2024. Activity (allocation and investment income) for the year ended December 31, 2024 is not material to the financial statements. Amounts are allocated in accordance with the nonelective contribution criteria. Remaining amounts to be allocated over the term are included as deferred revenue on the statement of net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of (a) the Company's discretionary and discretionary nonelective contributions, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case the loan may be for up to ten years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Upon termination of employment, if a participant's vested interest in their account exceeds \$5,000, no distribution shall be made to the participant before they reach the age of normal retirement or receipt of consent to pay out by the participant and their spouse, if applicable. If the participant's vested balance does not exceed \$5,000, the vested account balance is paid out in the form of a lump-sum distribution. In the event of a mandatory distribution greater than \$1,000, the distribution will be paid in the form of a direct rollover to an individual retirement arrangement designated if the participant does not elect a direct rollover or lump-sum distribution.

In addition, the Plan allows for hardship distribution, if certain criteria are met, and in-service withdrawals for participants, which have attained age 59-1/2.

Forfeited Accounts

Forfeited nonvested accounts, if any, may be used to pay administrative expenses or used to reduce the matching and nonelective contributions. Forfeitures utilized during the years ended December 31, 2024 and 2023 were immaterial. The balance as of December 31, 2024 and 2023 was immaterial.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management and custody expenses are also included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Note 3 - Information Certified and Provided by Fidelity Management Trust Company

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The collective trust funds (CTFs) are valued based on the NAV of units of the units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. The CTFs are direct filing entities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Company has adopted a pre-approved plan document that was sponsored by FMR LLC. The pre-approved plan document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company contribution portion of their account.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management, custody services, and plan administrative services were not material to the Plan.

Note 9 - Transfer of Assets

During 2024 and 2023, plan assets of participants were transferred from the Plan to the Bonney Forge Corp. Deferred Profit Sharing Plan.

Note 10 - Rollover Contributions

On September 20, 2022, the Board of Directors voted to terminate the Bonney Forge Corporation-Huntingdon Machine Division Pension Plan for Employees of Huntingdon Machine USW Local 6521-01 (the Pension Plan). The Pension Plan termination was approved by the IRS on September 29, 2023, and participants began distributing balances. An aggregate of \$199,007 was rolled into the Plan during the year ended December 31, 2024 as a result of the Pension Plan termination and liquidation, and is included in rollovers on the statement of changes in net assets available for benefits.

Note 11 - Subsequent Events

Plan management has evaluated subsequent events through August 8, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.
