Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We performed the audit of the financial statements of Fortress Bank Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - as of December 31, 2024, and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Fortress Bank Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- * The amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- * The information in the accompanying financial statements referred to above related to the assets held by and certified to by qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of Fortress Bank Profit Sharing Plan and to meet our ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise doubts about Fortress Bank Profit Sharing Plan's ability to continue as a going concern for one year after the date of the financial statements are available to be issued.

Note 1 - Description of the Plan

The following description of the Fortress Bank Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with salary reduction 401(k) features covering all employees of Fortress Bank, (Company) who have an age of 21 or older. Employees are eligible for employer's discretionary and non-discretionary contributions after a year of services. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the requirements of Section 401(k) of the Internal Revenue Code.

Contributions

Each year, participants may contribute up to the maximum dollar limit set by law. Under the Plan, a participant is permitted to deposit into the Plan distributions they have received from other plans and certain IRAs. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, in addition to the participant's salary deferrals the Company may contribute the following to the Plan: matching contributions, profit sharing contributions, and qualified nonelective contributions.

Participant accounts

Each participant's account is credited with the participant's contributions and the allocations of (a) the Company's contribution and, (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan includes an automatic deferral feature. Accordingly, the Employer will automatically withhold a portion of the participant's compensation each payroll period to contribute to the Plan as a pre-tax deferral once eligible, unless the participant makes a contrary election.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts thereon is based on years of continuous service. A participant is fully vested after six years of credited service. Employees are also 100% vested in the event of death or disability.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant with an account balance greater than \$7,000 may elect to receive either 1) a lump-sum amount 2) partial payments 3) installment payments or 4) an annuity contract. For participants with an account balance less than \$7,000 who do not elect to receive their distribution from the Plan in either a single lump sum or a direct rollover, benefits will be paid in the form of a lump sum.

Participants who leave the Plan will receive their vested percentage of their account balance within a reasonable time after the participant terminates employment and consents to the distribution.

Corrective Distributions

Certain ERISA regulations require that Highly Compensated Employees (HCEs) are limited as to the percentage of compensation they may elect to defer each year. Testing is performed after the end of each plan year to determine the allowable percentage deferred by the HCEs for that year. Any excess deferral is refunded to the individuals within 2 ½ months of plan year end. The Plan records these distributions in the year paid. Payments for corrective distributions paid in 2025 related to the plan year ended December 31, 2024 amounted to \$4,210.

Forfeitures

Forfeitures may be applied to payment of plan administration expenses, as well as towards profit sharing contributions and matching contributions. Forfeitures applied during the year ended December 31, 2024 amounted to \$40,315.

Participant loans

Notes receivables from participants represent participant loans that are recorded at their unpaid balance. Interest income on notes receivable is recorded when paid and is credited to the participant's account. Related fees are recorded as administrative expenses and are expensed as incurred. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of the participant's vested account balance, not to exceed \$50,000. The loans are secured by the participant's vested account balance and bear interest at a of 2% above the current USA Today prime rate. Principal and interest are paid ratably through regular payroll deductions. If a participant ceases to make note repayments and Plan management deems the participant note to be a distribution, the note balance is reduced and a benefit payment is recorded. For the year ended December 31, 2024, deemed loan distributions amounted to \$1,363, accordingly.

Investment options

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options listed in Note 4.

Participants may change the amount they are deferring into the Plan or stop making deferrals altogether at anytime. Participants may change their investment selection daily.

Note 2 - Summary of Significant Accounting Policies

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. The money market funds are valued at cost that approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Tax Status

The trust established under the Plan to hold the Plan's asset is qualified pursuant to relevant sections of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Sponsor has obtained a favorable tax determination letter from the Internal Revenue Service and the Sponsor believes that the Plan continues to qualify and operate as designed.

Note 2 - Summary of Significant Accounting Policies (Continued)

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Net Appreciation (Depreciation) in Fair Value of Investment

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Brokerage fees are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

Administrative Expenses

Administration expenses incurred in connection with the general administration of the Plan are paid by the Plan Sponsor.

Estimates

The preparation of financial statements in accordance with the accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Note 6 Plan Terminations

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 7 Subsequent Events

Plan Management has evaluated subsequent events through July 17, 2025, the date the financial statements were available to be issued.

Note 8 Related Party and Party-In-Interest Transactions

Certain administrative functions of the Plan are performed by employees of the Company. No such employee receives compensation from the Plan.

The Plan's investments are managed by Bankers Trust, the trustee. These transactions qualify as party-in-interest transactions. Fees for accounting and other administrative services are paid for by the Company. Administrative fees paid to Bankers Trust amounted to \$1,640 for the year ended December 31, 2024.
