Qualitative Aspect of Accounting Policies (Continued)

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

Management's estimate of the fair value of the Plan's investments in mutual funds is based on quoted prices in active markets. Management's estimate of the fair value of the Plan's investments in the collective trust is based on the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. We evaluated the key factors and assumptions management used to develop the fair value estimates pertaining to those investments and determined that such estimates and assumptions are reasonable.

The disclosures in the financial statements are neutral, consistent, and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Significant Unusual Transactions Identified During the Audit

We identified no significant unusual transactions during the audit.

Difficult, Contentious or Other Matters Encountered During the Audit

We encountered no difficult, contentious, or other matters for which we consulted outside the engagement team that were, in our professional judgment, significant and relevant to those charged with governance regarding the responsibility to oversee the financial reporting process.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. We did not identify any corrected or uncorrected misstatements in performing and completing our audit.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter that could be significant to the financial statements or the auditors' report. We are pleased to report no such disagreements arose over the course of the audit.

Circumstance Affecting the Form and Content of the Auditor's Report

We encountered no circumstances that affect the form and content of the auditor's report.

Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters. If a consultation involves application of an accounting principle to the Plan's financial statements, or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Significant Findings (Continued)

Management Representations

We have requested certain representations from management that are included in the management representation letter. This letter has been provided to you.

Independence

We are not aware of any relationships between Bonadio & Co., LLP and the Plan that, in our professional judgment, may reasonably be thought to bear on our independence. Relating to our audit of the financial statements of LeChase Companies 401(k) Salary Savings Trust as of and for the year ended December 31, 2024, Bonadio & Co., LLP hereby confirms in accordance with the Code of Professional Conduct issued by the American Institute of Certified Public Accountants, that we, in our professional judgment, are independent with respect to the Plan.

During the year ended December 31, 2024, Bonadio & Co., LLP provided the following services to the Plan:

- Preparation of plan financial statements

Form 5500

In performing our audit, in accordance with GAAS, we are responsible for obtaining and reading the draft Form 5500 in order to identify material inconsistencies, if any, with the audited ERISA plan financial statements. During our audit we obtained and read the draft Form 5500 from management and did not identify any material inconsistencies.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

With respect to the ERISA-required supplemental schedule accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedule to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the LeChase Companies 401(k) Salary Savings Trust (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for the benefit of substantially all employees of LeChase Construction Services, LLC and certain of its affiliates and subsidiaries (collectively, the Company). The Plan includes both profit sharing and 401(k) components, and, unless otherwise indicated, the provisions of the Plan are identical for both components. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

American Trust Company (ATC) is the trustee and custodian of the Plan's assets. AT Retirement Services, LLC provides recordkeeping services for the Plan. The Company is the plan sponsor and plan administrator. The Company pays certain administrative expenses of the Plan.

Eligibility

Effective May 1, 2023, employees that are not nonresident aliens or represented by a collective bargaining agreement are eligible to participate in the Plan and receive discretionary employer matching contributions, upon the attainment of age 21. Prior to May 1, 2023, the Plan did not include an age requirement for eligibility.

Contributions

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation and their contributions treated as a pre-tax deferral. Participants may complete a salary deferral agreement to elect an alternative deferral amount or to elect not to defer under the Plan in accordance with the deferral procedures of the Plan.

Participants may contribute a percentage of pretax annual compensation, as defined in the Plan, on a pretax basis or Roth after tax basis (collectively, Elective Deferrals), not to exceed the maximum contribution limits established by the Internal Revenue Code (IRC).

Participants may also rollover contributions from other qualified retirement plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Additional discretionary employer matching and profit-sharing contributions may be contributed at the option of the Company. Participants are eligible to receive discretionary profit-sharing contributions if they are employed on the last day of the Plan year, regardless of the amount of service completed during the Plan year. The discretionary employer matching contributions are based on a participant's elective deferral amount, up to a maximum of 4% of a participant's eligible compensation each payroll period.

1. DESCRIPTION OF THE PLAN (Continued)

Contributions (Continued)

During the 2024 and 2023 plan years, the Company made matching contributions equal to 100% of each participant's contribution, up to 2% of their compensation and matched additional contributions exceeding 2% of compensation in increments of 0.25% for each additional 1% of compensation deferred up to 6%. This results in a maximum matching contribution of 3%. The Company may also elect to make profit sharing contributions on a discretionary basis. There was no profit sharing contribution during 2024 or 2023.

Participant Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the elective deferral contributions, the employer discretionary matching contributions and profit-sharing contributions, and Plan earnings, losses and expenses. Allocations are based on participant compensation and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The \$50,000 maximum amount is reduced by the participant's highest outstanding loan balance in the previous twelve months, even if the amount has been repaid. Notes receivable are payable over a period not to exceed 5 years, except when used to acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator (currently prime plus 1%). Principal and interest are paid ratably through payroll deductions over the term of the loan.

Benefit Payments

The Plan provides for benefit payments of their vested account balance in a lump sum amount upon termination of service, death, disability or attainment of retirement age. The Plan provides for mandatory distribution of a participant's vested account balance following severance from employment when an account balance is less than \$5,000. The mandatory distribution is subject to automatic rollover if it exceeds \$1,000. The normal retirement age is the date a participant reaches the age of 60. Participants may also elect to make an in-service withdrawal of all or part of their account balances upon the attainment of age 59 ½.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's Elective Deferral contributions account balance under certain circumstances. All hardship withdrawals must comply with the IRS rules relating to hardships, which are uniformly applicable to all participants.

Vesting

Participants are immediately 100% vested in their Elective Deferrals, rollover contributions, catch-up contributions and actual earnings/losses thereon. Discretionary employer matching and profit-sharing contributions and earnings/losses thereon vest 20% per year beginning with the second year of service, and are fully vested after six years, or the attainment of age 60. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

1. DESCRIPTION OF THE PLAN (Continued)

Forfeitures

Forfeitures of non-vested account balances may be used to reduce future employer matching contributions or offset administrative expenses. During 2024 and 2023, forfeited non-vested account balances totaling \$97,777 and \$52,848 respectively, were used to offset administrative expenses of Plan. Forfeitures, including earnings thereon, totaled \$78,849 and \$60,501 during 2024 and 2023, respectively. Unallocated forfeitures totaled \$2,037 and \$20,965 at December 31, 2024 and 2023, respectively.

Administrative Expenses

Administrative expenses of the Plan are to be paid from plan assets or by the Company.

Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States.

Investments and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from those estimates.

(a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value ("NAV") per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: valued at fair value based on quoted prices in active markets.

Collective trust: valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the custodian reserves the right to temporarily delay withdrawal from the trust in order to ensure that the liquidations of the securities will be carried out in an orderly business manner.

The collective trust objective is to provide capital preservation and predictable, steady returns. The fund seeks to achieve this objective by investing primarily in stable value products, such as Guaranteed Investment Certificates ("GICs"), also known as traditional GICs, separate account GICs and synthetic GICs. The fair value of this investment is not readily determinable and has been estimated using the net asset value per share of the underlying investments.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS

The Plan adopted a pre-approved plan offered by AT Retirement Services LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

5. INCOME TAX STATUS (Continued)

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by ATC, the trustee and custodian of the Plan's assets, and therefore transactions involving securities managed by ATC qualify as party-in-interest transactions. Transactions involving notes receivable from participants also qualify as party-in-interest transactions.

7. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. However, net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

8. SUBSEQUENT EVENTS

Effective January 9, 2025, T. Rowe Price Trust Company became the trustee and custodian of the Plan's assets and T. Rowe Price Retirement Plan Services, Inc. became the recordkeeper of the Plan.

Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued.
