Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 401(k) Plan for AROW Global Corp. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS - DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF PLAN

401(k) Plan for AROW Global Corp. (the Plan) is a defined contribution plan sponsored by AROW Global Corp. (the Company). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of the Company who have reached twenty-one years of age and have completed three months of service. Employees can join the Plan on the 1st of the month coinciding with or following the attainment of these requirements. Effective April 19, 2023, the Plan was amended for automatic enrollment. Participants are automatically enrolled at 5% on the 1st of the month coinciding with or following the attainment of the requirements stated above. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

The Plan provides for both voluntary pre-tax and Roth employee contributions up to the maximum amount allowed by law. In 2024 and 2023, the Company matched 50% of the participant's contribution up to 5% of eligible compensation.

In addition, the Company's Board of Directors may authorize discretionary profit sharing contributions to employees who have completed a minimum of 1,000 hours of service during the plan year and are employed on the last day of the plan year. Even if they do not satisfy the annual service allocation requirement, employees are eligible to share in the allocation of profit sharing contributions if they retired, died, or became disabled during the plan year. There were no discretionary profit sharing contributions authorized for 2024 or 2023. Contributions from Plan participants and the related matching contribution from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and earnings thereon, and is charged with the withdrawals, losses, and an allocation of plan expenses. Depending on the nature of the expense, Plan expenses are allocated either proportionally based on the value of participant account balances, or as an equal dollar amount based on the number of participants in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant directed.

Investment Options

Participants may direct employee and Company contributions in any of several investment options. By designating these investment alternatives for participants, allowing frequent fund transfers, and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant Directed Account Arrangement.

The Plan currently offers various mutual funds as investment options for participants. The mutual funds invest in common stocks of domestic and foreign corporations, corporate bonds, and money market funds, which cover a wide range of fund objectives, risks, and returns.

Plan Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Administration and custodian fees and investment advisor fees are paid for by the Plan and are included in the financial statements. Withdrawal administration fees are charged directly to the participant's account and are included in administrative fees.

Vesting

Participants are immediately fully vested in their contributions, plus actual earnings thereon. Participants become fully vested in their account balances upon retirement, death, or disability, as defined by the Plan. A year of vesting service is a vesting service period in which a participant has at least 1,000 hours of service.

Company matching and profit sharing contributions are vested on a six-year schedule as follows:

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her account's vested balance, an annuity, to postpone distribution until required by Internal Revenue Code rules, or elect to rollover all of the balance into an Individual Retirement Account (IRA). If a participant's vested account balance exceeds \$7,000 the participant must consent to the distribution before it is made. If a mandatory distribution is being made to a participant whose vested account balance does not exceed \$7,000, but the amount of the distribution exceeds \$1,000, then the distribution is required to be in the form of an automatic rollover into an IRA. If a participant's vested account balance is \$1,000 or less, the participant will automatically be paid a lump-sum distribution or, if the participant so elects, the payment will be rolled over directly to an IRA or other eligible retirement plan as soon as administratively feasible. In-service distributions are allowed under certain circumstances as described in the Plan agreement.

Forfeitures

Forfeitures may be used to pay plan expenses or to reduce employer contributions. Forfeitures of \$32,613 and \$22,358 were used during the years ended December 31, 2024 and 2023, respectively. There were \$5 and \$1,400 of outstanding forfeitures as of December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

Valuation of Investments and Income Recognition

The Plan's investments are reported at their fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Realized gains (losses) and unrealized appreciation (depreciation) are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments. Realized gains (losses) on investment transactions are recorded as the difference between proceeds received and the carrying value of the investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance allowed by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company, the trustee of the Plan, as complete and accurate, except for comparing such information certified by the trustee with information included in the Plan's financial statements and supplemental schedule:

- a) Investments at fair value as disclosed in the Statements of Net Assets Available for Benefits.
- b) Interest and dividend income and the net appreciation (depreciation) in the fair value of investments as disclosed in the Statements of Changes in Net Assets Available for Benefits.
- c) The Schedule of Assets (Held at End of Year).

The Plan's independent auditor performed limited auditing procedures with respect to this information, including comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

There were no significant transfers between Level 1, Level 2, and Level 3 investments during the year ended December 31, 2024.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

NOTE 6 - TAX STATUS

The Plan, which is a non-standardized pre-approved profit sharing plan with CODA, obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan is qualified and tax-exempt at the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. However, they are not considered to be prohibited transactions.

NOTE 8 - CARES ACT PROVISIONS

The Plan adopted the CARES Act provisions, including allowing eligible participants to request a distribution of up to \$100,000 for qualifying coronavirus-related reasons. The Plan has until 2026 to formally amend the Plan with these provisions.

NOTE 9 - SECURE ACT 2.0

SECURE Act 2.0 includes provisions that are both mandatory and voluntary. The Plan adopted certain provisions of the SECURE Act 2.0 including increasing the dollar limit for mandatory distributions from \$5,000 to \$7,000. The Plan has until 2026 to formally amend the Plan with these provisions.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 23, 2025, the date on which the financial statements were available to be issued.
