NOTE A -- Description of plan and significant accounting policies

The following brief description of Dental Health Associates of Madison, Ltd. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Dental Health Associates of Madison, Ltd. (the Company, employer and Plan Sponsor) has adopted, with subsequent restatements, the Great-West Trust Company, LLC Defined Contribution Pre-Approved Plan and Trust with the most recent restatement effective February 5, 2021. The Plan was originally effective on October 1, 1974.

General

The Plan is a defined contribution profit sharing plan with elective deferral 401(k) features covering employees of the employer who are age 21 or older. Participants may enter the Plan the first day of the month following 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 39-1190243, and the Plan's number is 001.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Participants who do not opt-out will be increased by 1% annually up to a maximum of 10% of their total compensation.

The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan as a matching contribution. Additional amounts may be contributed at the option of the Company's board of directors which are allocated pro-rata based on a participant's eligible compensation to the total eligible compensation of all participants. In 2024, the employer's matching contributions totaled \$546,089, and the employer's non-elective contributions totaled \$1,139,344. To be eligible for employer matching contributions, participants must complete 1-year of service, or 1,000 hours. To be eligible for non-elective contributions, participants must complete 1-year of service, or 1,000 hours, and be employed on the last day of the Plan year (unless deceased, disabled, or retired during the year). Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Contributions receivable

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the company.

NOTE A -- Description of plan and significant accounting policies (Continued)

Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s matching and non-elective contribution, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of Company contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the rollover of funds from other qualified plans to a participant’s account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer’s matching and non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested ratably after six years of credited service. Participants who leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range up to 5 years or up to 15 years if proceeds are used for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate equal to the prime rate of interest as reported by the Wall Street Journal as of the first business day of the month the loan is originated, plus 1%. Principal and interest is paid ratably through payroll deductions.

Benefits

On termination of service due to death, disability, or retirement (age 55) or termination of service due to other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or in monthly, quarterly or annual installment payments if their vested balance is greater than \$1,000. A participant with an account valued at less than \$1,000 shall receive a lump-sum distribution. The Plan permits hardship distributions if certain criteria are met. The Plan permits in-service distributions at age 59 ½. The Plan does not permit in-service distributions from prior money purchase pension plan contributions.

Forfeited accounts

Forfeited nonvested accounts of participants (forfeitures) are treated as a reduction of the employer contribution, including matching contribution, for the Plan year in which the forfeiture occurs. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,873 and \$30,558, respectively. These accounts will be used to reduce future employer contributions. In 2024, employer contributions were reduced by \$20,604 from forfeited nonvested accounts.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The employer pays some of the administrative expenses of the Plan which are excluded from these financial statements. The major administrative expenses are contract, recordkeeping and investment advisor fees.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and adjustment to net appreciation in fair value of investments. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Subsequent events

These financial statements have not been updated for subsequent events occurring after July 30, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after that date.

NOTE B -- Information certified by the trustee and asset custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest, dividends, net appreciation, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC (Empower), the asset custodian and trustee of the Plan.

NOTE C -- Party-in-interest transactions

Empower is the asset custodian and trustee of the Plan as of and for the year ended December 31, 2024, and is therefore designated as a fiduciary and party-in-interest. Empower Annuity Insurance Company performs recordkeeping for the Plan. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions.

Empower (the provider) provides certain administrative and advisory services to the Plan pursuant to a Plan Services Agreements (PSA) between the employer and provider. The provider receive revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the provider for its services to the Plan.

If the revenue received by the provider from such mutual fund service providers exceeds the amount owed, the provider remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 there were \$43,024 of excess amounts received, which is included in other income on the Statement of Changes in Net Assets Available for Benefits. The Plan or Plan Sponsor may make a payment to the providers for administrative expenses not covered by revenue sharing.

Fees were also paid by the Plan during the year for investment advisor and investment management services rendered by Global Retirement Partners, LLC and Empower Advisory Group, LLC, respectively. These transactions also qualify as party-in-interest transactions.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Stable value collective investment fund. A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.
- Pooled separate accounts. The pooled separate accounts are invested in investments such as stocks, mutual funds, short-term investments, bonds, etc. Empower owns the underlying investments in the separate accounts. The underlying measurements for the separate key prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value of the separate account is not public quoted.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

Investments Measured Using the Net Asset Value per Share Practical Expedient

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE E -- Tax status

The Great-West Trust Company, LLC Defined Contribution Pre-Approved Plan and Trust that the Plan adopted effective February 5, 2021, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE F -- Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G -- Concentration of market risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
