We have performed an audit of the financial statements of the 403(b) Thrift Plan for R'Club Child Care, Inc., an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Note 1. Plan Description**

The following description of the 403(b) Thrift Plan for R'Club Child Care, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan, which was established in 2005 and subsequently amended and restated, is classified as a defined-contribution plan, covering the eligible employees of R'Club Child Care, Inc. and Louise Graham Regeneration Center (an affiliated employer under controlled group rules) (collectively, the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### **Contributions**

Immediately upon hire, substantially all employees of the Organization may contribute a percentage of their compensation, as defined in the Plan, subject to the Internal Revenue Code ("IRC") rules and limitations. Contribution deferral percentages can be changed throughout the year. The Plan also includes an automatic contribution arrangement where 3% of eligible participant wages will automatically be deferred unless an affirmative election is made. At the discretion of the Board of Directors, the Organization may also make contributions to the Plan each year. Employees must be at least 21 years of age and complete one year of service, have 1,000 hours of service, and be employed on the last day of the Plan's year to be eligible to receive employer contributions. The employer matching contribution for the years ended September 30, 2024 and 2023 were \$99,077 and \$104,916, respectively, and were receivables at year end.

### **Participant Accounts**

A separate account is maintained for each participant. Each participant's account is credited with the participant's contribution, the Organization's contribution, if any, an allocation of Plan earnings, and may be charged for Plan administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service as follows:

### **Forfeited Accounts**

Forfeited balances of terminated participants' non-vested accounts are used for the payment of Plan expenses. The unallocated forfeitures account, which consists of the unused balance of terminated participants' non-vested employer contributions, approximated \$2,000 and \$10,000 for the years ended September 30, 2024 and 2023, respectively. Approximately \$10,000 of forfeitures were used during the 2024 Plan year to pay Plan expenses and as reallocations to participants.

***Investment Options***

Participants may direct their account balance among any of the investment options offered by the Plan, which include pooled separate accounts and insurance company general accounts. Participants may change their investment options at any time, with certain exceptions.

***Participant Loans with Mutual***

The Plan provides for participants to obtain loans directly from Mutual of America Life Insurance Company ("Mutual") as opposed to borrowing from their individual accounts; accordingly, such loans are not deemed to be Plan assets. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. The loans are collateralized by the balance in the participant's account (required collateral of 120% of the outstanding loan balance) and bear interest at a rate that is 3% higher than the interest rate credited to the insurance company general account. Loans must be repaid to Mutual by the participant in accordance with the repayment terms of the agreement. In the event of default, foreclosure on the participant's account balance will not occur until a distributable event occurs in the Plan. The amount collateralized for participant loans held by Mutual was approximately \$52,000 and \$54,000 at September 30, 2024 and 2023, respectively.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant becomes fully and automatically vested and may elect to receive either a lump-sum payment equal to the value of the participant's vested interest in their account, installments, or annuity payments over a fixed period of time, not to exceed the life expectancy of the participant/designated beneficiary. Participants who terminate for reasons other than death, disability, or retirement are entitled only to their vested balances payable in a lump-sum distribution. The Plan allows for in-service distributions if a participant reaches age 59<sup>1/2</sup> and hardship distributions subject to Plan provisions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are presented on the accrual basis of accounting.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments held in pooled separate accounts are reported at fair value and are valued using a market valuation basis at the reported closing net asset value ("NAV") of the funds daily. NAV is based on the fair market value of the funds' underlying investments, less any fund liabilities.

Purchases and sales of securities are recorded on a trade-date basis, and interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation/depreciation in the fair value of the Plan's investments include the Plan's gains and losses on investments bought and sold, as well as the unrealized gains and losses on those investments that are held at the end of the year.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts. Contract value is deemed to be the relevant measurement attribute for those contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions and reinvested income, less any withdrawals, plus accrued interest. The Plan's investments in the Mutual of America Interest Accumulation Account and Empower's Guaranteed Certificate and Guaranteed Fixed Funds, which are insurance company general accounts, are stated at contract value (see Note 5).

***Payment of Benefits***

Benefits to participants are recorded when paid. As of September 30, 2024 and 2023, there were no amounts allocated to the accounts of individuals who have elected to withdraw from the Plan but had not yet been paid.

***Administrative Costs and Investment Fees***

Administrative costs are paid by the Plan and are allocated to the individual participant accounts in accordance with the Plan document. Investment-related fees and commissions are netted against net appreciation/depreciation in fair value of investments. Certain Plan expenses are paid directly by the Organization.

***Subsequent Events***

In preparing these financial statements, the Organization has evaluated events and transactions for potential recognition or disclosure through August 4, 2025, the date the financial statements were available to be issued.

**Note 3. Information Certified by the Plan Custodians**

Mutual, the Empower Trust Company, and the Empower Annuity Insurance Company of America (the "Plan Custodians") hold the Plan's investments and execute all investment transactions. All investment information disclosed in the financial statements and supplemental schedule, including investments held at September 30, 2024 and 2023, net change in fair value of investments and interest for the year ended September 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan Custodians.

**Note 4. Fair Value Measurement**

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Note 5. Fully Benefit-Responsive Investment Contracts**

Investments held in unallocated insurance company contracts are invested in the Mutual of America General Account, Empower Guaranteed Certificate Fund, and the Empower Guaranteed Fixed Fund. These funds are deemed to be fully benefit-responsive investment contracts and are reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, withdrawals influenced by Organization-triggered events, such as reallocation of investments, may result in a distribution at other than contract value, and are subject to certain restrictions. The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the contract issuer's ability to meet its financial obligations. There are no reserves against contract values for credit risk of the contract issuer or otherwise.

The insurance company contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The average yield for these contracts ranged from 1.3% to 4.0% for the year ended September 30, 2024.

**Note 6. Risk and Uncertainties**

The Plan has investments that are exposed to risk, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the value of investment securities may occur in the near term and that such change could materially affect the amounts reported in these financial statements.

The value, liquidity, and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investments are not insured or protected by the Plan Custodians, the Plan sponsor, the Pension Benefit Guarantee Corporation, or any other governmental agency; accordingly, the Plan is subject to the normal investment risks associated with similar investments.

**Note 7. Income Tax Status**

The Plan is intended to be qualified under Section 403(b) of the IRC and is subject to the provisions of ERISA. The Plan document is a prototype plan prepared and maintained by Mutual. The prototype plan received a determination of qualification from the IRS. The Plan administrator believes that the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC and will remain exempt from federal income taxes.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 9. Party-in-Interest Transactions**

During 2024 and 2023, certain Plan investments were managed by the Plan Custodians and, therefore, these transactions qualify as party-in-interest transactions.
