# FIRST NATIONAL BANK OF SCOTIA 401(K) PLAN

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the First National Bank of Scotia 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a participant directed, defined contribution plan which includes all eligible employees of the First National Bank of Scotia ("the Bank" or "the Company"), the Plan sponsor, and its related companies. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan effective date was October 1, 2004. The Plan is administered by an Administrative Committee appointed by the Bank. The assets of the Plan are held by Fidelity Management Trust Company ("Fidelity" or "the trustee"), the Trustee of the Plan.

#### **Eligibility**

Employees become eligible to make salary deferrals upon reaching age 18 and completing 90 days of employment. Effective January 2, 2024, employees are eligible to receive bi-weekly matching contributions and nonelective employer contributions after meeting the following criteria: attainment of age 18, completion of one year of service, and having made salary deferrals to the Plan during the current year. Prior to January 2, 2024, employees were also required to have completed at least 1,000 hours of service within that one-year period. To receive nonelective contributions, employees must be employed on the last day of the Plan year.

#### **Contributions**

Active participants may make voluntary pre-tax contributions in the form of salary reductions up to 100% of annual compensation. Starting November 3, 2023, participants have the option to elect to have Roth 401(k) contributions made to the Plan. Roth contributions are includable in a participant's taxable gross income for the year in which the contribution is made. Active participants may also contribute any applicable rollovers from other qualified plans. Contributions are subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 401(k). Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the IRC. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible pretax compensation. All participants who are automatically enrolled will have their deferral increased each year by 1% until a maximum deferral rate of 10% is reached, unless they elect a different deferral rate.

The Bank makes nonelective safe harbor contributions to all eligible participants at an amount equal to 3% of eligible compensation. The Bank may also make discretionary matching contributions each year. The discretionary matching contributions are based on a percentage of a participant's elective deferral amount. For the years ended December 31, 2024 and 2023 the matching percentage was 50% of the first 6% of a participant's elective deferrals contributed each pay period. During 2024 and 2023, discretionary matching contributions totaled \$244,980 and \$223,024 respectively. During 2024 and 2023, the Bank made nonelective safe harbor contributions of \$316,664 and \$296,955, respectively.

## 1. DESCRIPTION OF PLAN (Continued)

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Bank's nonelective safe harbor contribution, (b) the Bank's discretionary matching contribution (if any), (c) Plan earnings, (d) certain forfeitures of terminated participants' non-vested accounts and (e) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants are allowed to direct employee and employer contributions among funds offered by the Plan. Participants may change their investment options at their discretion.

### **Vesting**

Participants are immediately vested in their voluntary contribution plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. Company nonelective safe harbor and matching contributions plus actual earnings thereon become 20% vested upon the completion of one year of service and continue to vest at the rate of 20% for each successive year of service until 100% vested after five years of credited service.

### **Notes Receivable from Participants**

Participants may request a loan from their elective deferral accounts under the terms and conditions established by the Administrative Committee with a minimum loan of \$1,000, not to exceed the lesser of 50% of a participant's vested account balance or \$50,000, subject to certain conditions as defined in the Plan agreement. All loans must be repaid in level payments through payroll deductions on at least a quarterly basis over a five-year period unless it is for the purchase of a principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan. If repayment is not made by payroll deduction, a loan shall be repaid to the Plan by payment to the Company. All loans shall bear a reasonable rate of interest as determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances.

### **Payment of Benefits**

Upon retirement or termination of service, participants may elect to receive a lump-sum distribution of their vested account balance or elect a rollover to another qualified retirement plan or an Individual Retirement Account. Effective January 2, 2024, a terminated participant may elect a partial withdrawal. Benefit payments from the Plan will be made in a lump sum distribution if the balance is less than the applicable IRS Limits and the participant does not direct the Plan otherwise.

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted from a participant's pre-tax contribution account, rollover contribution account, and the vested portion of the Company's matching contribution account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Forfeitures**

Forfeited non-vested account balances may be used to pay administrative expenses or are applied to reduce future employer contributions in accordance with the Plan document. Otherwise forfeitures will be reallocated to participants eligible to receive an allocation of Nonelective Employer Contributions. In 2024 and 2023, there were forfeitures of non-vested employer contributions and earnings on unused amounts totaling \$8,442 and \$5,493, respectively. At December 31, 2024 and 2023, the balance of the forfeiture account was \$560 and \$352, respectively. During the years ended December 31, 2024 and 2023, forfeitures totaling \$8,234 and \$6,965, respectively, were applied toward employer contributions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America.

### **Investments**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments are exposed to various risks, such as interest rate, currency, market and credit risk. Due to the level of risk associated with investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Investment Fees**

Net investment returns reflect certain fees paid by the various investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

### **Fair Value Measurement - Definition and Hierarchy**

The ASC 820 framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means;
  - If the asset or liability has a specified (contracted) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurement - Definition and Hierarchy (Continued)

A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 4. There were no transfers between levels of the fair value hierarchy during 2024 or 2023.

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Payment of Benefits

Benefit payments to participants are recorded when paid.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based on the terms of the plan document.

### Administration Expenses

Expenses incurred in connection with the purchase or sale of securities are charged against the investment funds whose assets are involved in such transactions. Certain administrative costs of the Plan are paid by the Company or by the use of forfeitures. All other expenses, unless allocable to the accounts of the particular participant, are allocated against the accounts of all participants.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts of net assets and the changes in net assets during the reporting period. Actual results could differ from those estimates, and such differences, may be significant.

## 3. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has received a certification from Fidelity Management Trust Company, the trustee of the Plan, that states the following information is complete and accurate as of and for the years ended December 31, 2024 and 2023.

#### 4. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023.

*Mutual funds:* valued at the quoted market prices of the shares held by the Plan at year-end. The quoted market prices are reported on an active market on which the securities are traded.

*Stable value fund:* The stable value fund's objective is to preserve principal and achieve high current income through a diversified portfolio of high-quality investment contracts. The Plan uses the NAV per share of the fund provided by the trustee of the fund as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the trustee reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The fund units are issued and redeemed daily at the constant NAV of \$1 per unit.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

#### **Investment in Entities that Calculate Net Asset Value ("NAV")**

The Plan is invested in a stable value fund that calculates net asset value on a daily basis. Units are issued and redeemed as of the end of each day at the daily net asset value. This investment does not have any unfunded commitments. The Plan can redeem the investment daily.

## **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100 percent vested in their employer contributions.

## **6. TAX STATUS**

The Internal Revenue Service has determined and informed the Bank by a most recent letter dated June 30, 2020, that the Prototype Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

## **7. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. Therefore, related transactions qualify as party-in-interest transactions. All other transactions which may be considered party-in-interest transactions relate to normal plan management and administrative services, and the related payment of fees.

## **8. RECONCILIATION TO FORM 5500**

While total net assets available for benefits and the change in net assets available for benefits agree between the financial statements and Form 5500 as of and for the years ended December 31, 2024 and 2023, certain classifications differ between the financial statements and Form 5500.

## **9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through August 7, 2025, which is the date the financial statements were available to be issued.
