Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of RCG Global Services, Inc. Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the RCG Global Services, Inc. Savings Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of RCG Global Services, Inc. ("RCG"), and its eligible subsidiaries or affiliates (collectively, the "Employer"). Employees must attain the age of 21 to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

RCG's Benefits Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. RCG is the Plan's sponsor and administrator, and is responsible for oversight of the Plan. Plan investments are held by Principal Trust Company (the "Trustee"), who executes transactions pursuant to instructions from the plan administrator.

Effective January 1, 2024, the Plan was amended to merge Woodridge Advisors LLC into the Plan. Accordingly, \$4,455,547 of plan assets were transferred into the Plan during the year ended December 31, 2024.

Contributions

Eligible employees are automatically enrolled in the Plan on the first date of the month following the date the employee satisfies the eligibility requirements. Under the terms of the automatic enrollment provision, the Employer withholds 3% of each eligible employee's compensation each payroll period, unless the participant makes an affirmative election not to defer or to defer more or less than the automatic deferral percentage. Employees can elect to contribute up to 100% of their eligible compensation into the Plan on a pre-tax basis, subject to certain limitations as defined by the Internal Revenue Code (the "Code"). Participants may elect to categorize a portion or all of their contributions under the Plan's Roth deferral feature on a post-tax basis, subject to certain limitations as defined by the Code. Eligible participants may make "catch-up" contributions subject to certain limitations as defined by the Code. Contributions are funded to the Plan following each pay date. Participants may also make rollover contributions from other qualified plans.

The Employer may elect, at its discretion, to make matching contributions to the Plan. Participants are eligible to receive Employer contributions if they are an active employee on the last day of the Plan year or they ceased being an active participant during the Plan year due to retirement, death or disability.

Contributions (*continued*)

The Employer provided a discretionary matching contribution for the years ended December 31, 2024 and 2023 of \$481,025 and \$300,000, respectively, of which is recorded as an employer contribution receivable as of December 31, 2023, in the accompanying statements of net assets available for benefits. Effective January 1, 2024, the Employer remitted the employer contribution per pay period.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as an allocation of the Employer's contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their account balances to any combination of the Plan's investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's matching contribution portion of their account is based on periods of service. A participant will be credited with a period of service for each twelve-month period from their date of hire until their employment terminates. A participant vests at the following rate:

Forfeited Accounts

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and may be used to pay administrative expenses or to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$34,798 and \$36,044. During 2024, no forfeitures were used to reduce Employer contributions and forfeitures of \$33,990 were used to reduce administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 minus the highest outstanding loan balance during the immediate preceding twelve months. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or for other reasons, a participant or their beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions may also be made in installments to comply with required minimum distribution rules required by the Code. The Plan permits in-service withdrawals to participants meeting certain requirements.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

2. Summary of Significant Accounting Policies *(continued)*

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily Net Asset Value and to transact at that price. These mutual funds are deemed to be actively traded.

Investments in collective investment trusts, pooled separate accounts and the RCG Global Services Inc. Fixed Account are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 30, 2025.

The RCG Global Services Inc. Fixed Account (the “Account”) is a unitized investment that is a blend of the frozen holdings from the former Prudential Guaranteed Income Fund (GIF) and the new offering of the Principal Guarantee Option (PGO). RCG Global Services Inc Benefits Committee is the investment manager for the Account.

The investment contract was valued at NAV and amounted to \$3,589,055 and \$4,467,595 at December 31, 2024 and 2023.

5. Collective Investment Trusts

In 2023, the Plan entered into a participation agreement to invest in the Wilmington Trust Collective Investment Trust (the “Trust”). Wilmington Trust, N.A. (the “Trustee”) maintains the Trust for the collective investment of certain qualified retirement plan assets.

Units of the collective investment trusts are valued daily. Unit purchases and redemptions are transacted at the NAV determined as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

6. Party-in-Interest Transactions

Certain investments of the Plan are managed by Principal Life Insurance Company or Principal Trust Company, both of whom are members of Principal Financial Group. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

6. Party-in-Interest Transactions *(continued)*

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

7. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the prototype document preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since that date, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021, however, there are currently no examinations for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

9. Risk and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan’s net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan’s net assets available for benefits cannot be predicted.
