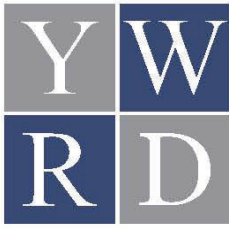

To the Trustees

Opinion

We have audited the accompanying financial statements of Trac-Work, Inc. NOTE A - DESCRIPTION OF PLAN

The following brief provisions of the Trac-Work, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

Trac-Work, Inc. Employee Stock Ownership Plan was established January 1, 1989, with an effective date of January 1, 1989 for the benefit of all employees of Trac-Work, Inc. (the "Employer"). The Plan is a non-contributory, Employee Stock Ownership Plan (ESOP), providing benefits to employees who meet the eligibility requirements indicated below.

The Plan is designed to comply with section 4975(e)(7) and the regulations there under of the Internal Revenue Code of 1986, as amended (Code) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan has filed for exemption from Federal Income Tax under the appropriate sections of the Code. Under such an exemption, employer contributions to the Plan, as well as investment earnings are not taxable to the participants until distributed. The Plan has received a favorable determination letter from the Internal Revenue Service covering the Plan's tax exempt status dated August 28, 2014. The plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS.

Eligibility and Participation

Each eligible Employee becomes a Participant in the Plan on the nearest January 1 following completion of 12 months service. Participants must be at least 20.5 years of age. All Employees of Trac-Work, Inc. who met the eligibility requirements as of January 1, 1989 (the effective date of the Plan) became Participants of the Plan as of the effective date of the Plan. Participants are credited with one year of service for each 12 month period in which they complete at least 1,000 hours of service to the Employer beginning January 1, 1989.

Benefits

Employees will be entitled to receive the value of their account in this ESOP at normal retirement age 65. If an active Employee dies, a death benefit equal to the full value of the employee's account balance will be paid to the designated beneficiary. Active Employees who become totally disabled prior to their normal retirement age also become fully vested in their account values.

Plan Termination

The Employer reserves a right to amend or terminate the Plan. In the event the Plan is terminated, the net assets of the Plan would be allocated, as prescribed by ERISA and its related regulations. All Participants become 100 percent vested at Plan termination.

Allocation of Employer Contributions and Forfeitures

Employer contributions will be allocated as of each anniversary date among the accounts of participants who are employed on the last day of the plan year, or employees whose employment terminated during the year because of retirement or death, in the proportion that each such participant's covered compensation bears to the total covered compensation of all such participants for that year. Forfeitures shall be allocated in the same manner as employer contributions are allocated. Forfeitures reallocated at December 31, 2024 and 2023 totaled \$6,894 and \$22,264, respectively.

Vesting

Vesting in the Company's discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. The Plan provides for 20% vesting of benefits after two years of service, and increases by 20% for each year of service. A participant is 100% vested after six years of credited service.

Employer Contributions

Contributions to this Plan by the Employer are discretionary and will be determined each year by the Board of Directors.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. Participants eligible to diversify make their election after year-end based on the number of shares of the employer's stock held in their account at year-end.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuations

The common shares of Trac-Work, Inc. are valued at fair value on December 31, 2024 and 2023. Fair value is determined by an annual independent appraisal. Certificates of deposit are valued based on amortized cost or original cost plus accrued interest.

Plan Administration

The Employer pays substantially all costs associated with the operation of the Plan and serves as the Plan Administrator.

Operating Expenses

All expenses of maintaining the Plan are paid by the Employer.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 3 Fair Value Measurements

The fair value of the Employer common shares is based on an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of company assets and liabilities. The following table provides further details of the Level 3 fair value measurements.

NOTE E - CERTIFICATE OF DEPOSIT

Certificate of deposit at December 31, 2024 and 2023 consisted of an amount on deposit at a bank, with interest rates of 4.50% and 5.00%, respectively, with maturities of three months or more.

NOTE F - LOAN PAYABLE

In 2020, the Plan purchased 3,807 shares of common stock of the Employer from certain participants' ESOP accounts at a cost of \$2,898,252. The Plan financed the purchase price of the shares pursuant to a loan to the Plan from the Employer, evidenced by a non-recourse promissory note made by the Plan in favor of the Employer. Such shares were pledged as collateral for the note. The note does not bear interest and is to be repaid in six annual installments on December 15 2020 through December 15, 2025. Payments will be funded with cash contributions from the Employer. As note payments are made, shares are released from collateral and allocated to active employees, based on the proportion of debt service paid in the current year. 460 and 365 shares were released and allocated as a result of the note payments for the plan years ended December 31, 2024 and 2023, respectively. The note may be prepaid without penalty. The Plan reports contribution income equal to the Plan debt principal repayment. The outstanding balance of the note payable is \$0 and \$350,106 as of December 31, 2024 and 2023, respectively.

NOTE G - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated August 28, 2014, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE H - ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of Employer common stock, are held by the Trustees of the Plan.

Company contributions are held and managed by the Trustees, which makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustees' fees are paid directly by the Employer.

NOTE I - RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Employer's common stock, which is exposed to various risks, including interest rate and credit risks, as well as valuation assumptions based on earnings and cash flows. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE J - NET ASSETS AVAILABLE FOR BENEFITS

Net assets available for benefits at December 31, 2024 and 2023 included \$6,597,084 and \$5,886,218, respectively, allocated to the accounts of persons who as of or prior to that date had withdrawn from participating in the earnings and operations of the Plan.
