Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Network Health, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge and belief.

Notes to Financial Statements

Note 1. Description of Plan

The following description of Network Health, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution salary reduction plan covering substantially all employees of Network Health, Inc. (the Company). Employees are allowed to participate in the Plan immediately upon their date of hire. The Plan qualifies as a tax-exempt plan under the provisions of the Internal Revenue Code (IRC) and complies with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Administrative Committee (Plan Committee) is responsible for oversight of the Plan. The Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan no longer credits employees with service provided to Ministry Health Care, Inc., Froedert Health, Inc., Affinity Health System and related employers for purposes of vesting and allocation accruals.

Contributions: Each year, participants may contribute up to 80% of their compensation, as defined by the Plan, up to the maximum percentage allowable by the Internal Revenue Service (IRS). Participants who will attain age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allows for Roth elective deferrals to be made to the Plan. The Plan allows for Company discretionary matching contributions equal to 50% of the participant's deferral contributions up to 6% of the employee's pretax compensation and catch-up contributions are included in the participant deferrals to be matched. For 2024, the Company matching contributions totaled approximately \$1,006,500. The Plan allows for a discretionary non-elective contribution to be made annually based on years of service to employees who are employed at the end of the plan year and who are credited with 1,000 hours of service during the Plan year. For 2024, a non-elective contribution of approximately \$1,916,000 was made by the Company. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, discretionary non-elective contributions, if any, and allocations of plan earnings and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and Company matching contributions plus actual earnings thereon. Participants are 100% vested in discretionary non-elective contributions after three years of credited service or upon death or disability during the term of employment.

Participant investment options: Upon enrollment in the Plan, a participant may direct their accounts in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at the prime rate as stated in *The Wall Street Journal*, plus 1%. Note maturities range from one to five years, unless for the purchase of a personal residence, in which note maturities may not exceed 20 years. Principal and interest are paid ratably through monthly payroll deductions.

Note 1. Description of Plan (Continued)

Payment of benefits: Upon termination of employment, a participant is entitled to receive either a portion of or their entire vested amount of their account in a single lump-sum payment in cash. If a participant's account value exceeds \$1,000 but is less than \$7,000, the administrator shall provide for the payment of such to the participant in a lump sum within a reasonable time following termination. A participant who has attained age 59½, but who has not terminated employment, is entitled to have the whole or any part of the accounts paid to him or her under the previous options. A participant who has not terminated employment and has not attained age 59½ shall be permitted to make cash withdrawals to meet certain financial hardships, as defined by the Plan. Upon the death of a participant, the participant's accounts shall be payable to their beneficiary.

Forfeited accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$13,700 and \$9,400, respectively. Forfeited non-vested accounts are used to restore participant accounts and then reduce Company contributions. During the year ended December 31, 2024, approximately \$11,400 was used to reduce Company discretionary non-elective contributions. In addition, approximately \$14,600 was used subsequent to year-end to reduce the Company contribution receivable.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment custodian and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accounted for on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

Payment of benefits: Benefits paid and withdrawals to participants are recorded when paid.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant compensation is earned.

Administrative expenses: Administrative expenses can be paid either by the Company or from the Plan assets. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are offset against net appreciation of fair value of investments.

Subsequent events: Plan management has evaluated subsequent events through August 7, 2025, the date on which the financial statements were available to be issued and concluded no events or transactions that require recognition or disclosure in the financial statements.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB Accounting Standards Board 820 are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV), and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: The Plan's interest in the common/collective trust fund is comprised primarily of fully-benefit responsive investment contracts and is valued based on the NAV of units of the collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management has evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 6. Investment Contract With Insurance Company

The Plan holds a traditional investment contract issued by Transamerica. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the investment contract held by the Plan as of December 31, 2024 and 2023, was \$13,850 and \$9,361, respectively.

The Plan owns only the contracts themselves under a traditional investment contract. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The Plan entered into a fully benefit-responsive investment contract for the stable value fund with Transamerica. Transamerica maintains the contributions in a general account. This contract is an evergreen product as it has no maturity date. It does not operate like a mutual fund, variable annuity product, or conventional fixed rate individual annuity product. This product is not a traditional Guaranteed Investment Contract (GIC), therefore, there are no known cash flows that could be discounted. This annuity contract is not backed by specific securities of the issuer's general account and, therefore, it would be inappropriate to look to the market value of the securities within the insurer's general account to determine a fair value. The concept of a value, other than contract value, does not apply to this insurance company issued evergreen group annuity product. This contract's operation is different than many other evergreen group annuity products as a market value (fair value) adjustment does not apply upon discontinuance. The Plan has guaranteed benefits under the terms of the contract. The contract value equals deposits made to the fund, plus interest credited under the terms of the contract, less any withdrawals. The contract contains a minimum guaranteed interest rate, which is determined by the issuer, but may not be less than the minimum guaranteed rate. Such interest rates are reviewed quarterly for new deposits received during a calendar quarter and are applicable through the end of the calendar year. The crediting rate established by the issuer is on a calendar year basis. The rate in effective during both 2024 and 2023, is 0.75%.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs or a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 7. Related-Party and Party-in-Interest Transactions

Transamerica Retirement Solutions Corporation, an affiliated entity with Transamerica, provides recordkeeping services to the Plan. Transamerica is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid approximately \$85,400 in fees to Transamerica Retirement Solutions Corporation during the year ended December 31, 2024.

The investment contract is managed by Transamerica. Transamerica is the custodian, as defined by the Plan and, therefore, this transaction qualifies as a party-in-interest transaction.

Certain employees of the Company provide administrative services to the Plan. These employees are not paid from the Plan for their services. In addition, the Company pays outside administrative expenses of the Plan.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 9. Tax Status

The Plan has adopted the Pre-Approved 401(k) Profit Sharing Plan of Transamerica Retirement Solutions Corporation. The Transamerica Retirement Solutions Corporation Pre-Approved 401(k) Profit Sharing Plan has received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan's qualified status. The opinion letter has been relied upon by this Plan. The Plan has been amended since the pre-approved plan received the opinion letter; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
