**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Weber Holdings, LLC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The accounting records of the Plan are maintained on the accrual basis and presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contributions - Contributions by Weber Holdings, LLC are accrued based on the amount determined by the Company for the fiscal year and as allowable by the Internal Revenue Service Code.

Interest and Dividend Income - Interest and dividend income is recorded when earned during the year.

Purchases and Sales of Securities - Purchases and sales of securities are reflected on a trade-date basis. Gain or loss on sales of securities is based on cost. Cost is the fair value at the beginning of the Plan year or historical cost if the security was purchased during the Plan year.

Payment of Benefits – Benefits are recorded when paid.

Cash Equivalents - Cash and equivalents consists of uninvested cash.

Estimates - The preparation of the financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**NOTE 2 - PLAN DESCRIPTION**

The brief Plan description is provided for general information purposes only; for more complete information, the participants should refer to the Plan agreement.

The Plan is a defined contribution employee benefit plan covering substantially all employees of Weber Holdings, LLC, (all divisions); Charmant Hotel and Home2Suites who have met the eligibility requirements. The Plan was effective January 1, 2015 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Effective January 1, 2015, Weber Holdings, LLC employees who are twenty-one years of age and have been employed full time and achieve 480 hours in the first three months are eligible to participate in the Plan. If the employee does not satisfy the 480 hours in the first three months, the employee is then required to be twenty-one years of age, have been employed twelve months and have completed at least 1,000 hours of service during the first twelve months of employment to be eligible to participate in the Plan. The Company allows employees to enter the Plan on the first day of next quarter after the eligibility requirements are met during the first twelve months of employment. If the employee does not achieve 1,000 hours during the first twelve months of employment, the employee is then required to be twenty-one years of age and achieve 1,000 hours during the calendar year to be eligible to participate and can enter the plan on the next January 1.

**NOTE 2 - PLAN DESCRIPTION, CONTINUED**

Forfeitures - Forfeitures of non-vested Company contributions are used to reduce future Company contributions and expenses. During 2024 and 2023, \$0 and \$10,610, respectively, of forfeited participant accounts were used to reduce the Company's contributions and expenses. The Company had \$15,447 and \$918 of unapplied forfeitures at December 31, 2024 and 2023, respectively, which may be used to pay Plan fees or Company contributions.

Contributions - Under provisions of the Plan, employees may contribute up to 100% of their annual wages up to the maximum percentage allowable by Internal Revenue Code Sections 401(k), 402(g), 404 and 415. The Company may make matching contributions equal to a discretionary percentage of the employee's deferral up to a limit of 6% of wages defined in the Plan document. For 2024 and 2023 the match was 3%. Employees may change their investment elections daily. Each employee's account is credited with his contribution and an allocation of the Company's contribution, Plan earnings, and forfeitures of non vested accounts of terminated employees. Allocations are based on employees' earnings or account balances, as defined. The benefits to which an employee is entitled are the benefits that can be provided from his/her account.

Vesting - Participants' accounts are vested according to the following schedule for employer contributions:

<b>Years of Service</b>	<b>Percentage Vested</b>
After 1 year	25%
2 years	50%
3 years	100%

This means that the vesting percentage times the employees account is his/her benefit if they terminate employment. Employee contributions are always 100% vested.

Payment of Benefits - Upon termination of service of an employee, or in certain hardship cases, an employee may elect to receive benefits by a lump sum payout, a series of substantially equal periodic installments not to exceed the participant's life expectancy, or partial withdrawals as described in the Plan's provisions.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs rather than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds are based on quoted prices of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements*

The fair value of these investments are determined by pricing data provided by outside valuation service providers who generally use the mean bid/ask prices but may also use alternative observable pricing inputs including discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

*Level 3 Fair Value Measurements*

The fair value of these investments are determined by inputs to the valuation methodology that are not observable and are significant to the fair value measurement.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1, 2, or 3.

The Plan's sponsor pays certain plan administrative fees, audit fees, and ERISA bond coverage for the Plan. These expenses are not reflected on the statement of changes in net assets.

**NOTE 7 - INCOME TAX STATUS**

The Plan has received a determination letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, collateral and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 – TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments are managed by TrustPoint, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$19,456 and \$16,991 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 11 – AMOUNTS OWED TO PARTICIPANTS WITHDRAWING FROM THE PLAN**

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

**NOTE 12 – CONCENTRATIONS**
