### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tom Kadlec & Affiliates 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Description of the Plan

---

The following description of the Tom Kadlec & Affiliates 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan covering all eligible employees (other than members of a collective bargaining unit and nonresident aliens) of Kadlec Motors, Inc. dba Tom Kadlec Honda, TTT, Inc. dba Tom Kadlec Kia, and TAK of Rochester, Inc. dba ABRA Auto Body & Glass (collectively, the Company). The Plan became effective January 1, 2018 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Most recently, the Plan's operations for the 2020 plan year were amended to adopt the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

*Administration* – The Plan is administered by plan trustees and advised by an external third party consultant. The Trustee of the Plan's assets is John Hancock Life Insurance Company (the Trustee). The Trustee executes transactions based upon direction from the Plan's administrator and the Plan's participants.

*Participation* – To be eligible for the Plan, employees must be age twenty-one or older and have completed one year of service, as defined in the Plan document. Plan entry dates are the first day of the first month and seventh month of the plan year.

*Contributions* – Contributions to the Plan include pre-tax and post-tax (Roth) salary reduction contributions, rollover contributions, catch-up contributions, employer safe harbor matching contributions and the Company's discretionary nonelective and/or matching contributions (if any).

For the years ended December 31, 2024 and 2023, the Company contributed a safe harbor matching contribution of 100% of a participant's elective deferral up to 3% of a participant's compensation, plus 50% of a participant's elective deferral from 3% up to 5% of a participant's compensation. There were no discretionary nonelective contributions made for the years ended December 31, 2024, and 2023.

*Participant Accounts* - Each participant's account is updated to include the participant's contributions and distributions, if any, and an allocation of (a) the Company's contribution, (b) plan earnings (losses), and (c) plan expenses, as applicable. The Plan uses a daily valuation system for each participant's individually-directed account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participants' funds are invested in various pooled separate accounts held by the Trustee.

*Notes Receivable from Participants* – The Plan does not allow for participants to borrow from their fund accounts.

#### 1. Description of the Plan (Continued)

---

*Vesting* – A participant shall at all times have a fully vested, nonforfeitable interest in his or her salary deferral contributions, rollover contributions, and safe harbor matching contributions. Employer discretionary nonelective and/or matching contributions are fully vested after six years of service. A participant is also 100% vested upon death or reaching normal retirement age. Participants are fully vested at all times in all other contribution types. Participants vest in discretionary nonelective and/or matching contributions as follows:

0-2	0%
2	20%
3	40%
4	60%
5	80%
6 or more	100%

*Benefit Payments* – On termination of service, disability, death, retirement or reaching normal retirement age, participants or their beneficiaries, as applicable, are eligible to receive a distribution in an amount equal to the participant's vested account balance, or if the balance exceeds \$5,000, elect to defer the benefit payment in accordance with plan guidelines. If the participant's account balance is between \$1,000 and \$5,000, the participant's balance will be paid in the form of a direct rollover to an IRA if no other election is made by the participant. Participant balances that are less than \$1,000 will be paid to the participant in the form of a lump-sum distribution.

Participants are allowed to take in-service distributions from any of their account balances in the Plan after reaching age 59 ½. Participants are also able to take a hardship distribution from their vested account balance in an amount not to exceed the participant's financial hardship, as defined by the Plan document.

*Plan Termination* - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

#### 2. Summary of Significant Accounting Policies

---

##### Basis of Accounting

The financial statements are prepared in accordance with generally accepted accounting principles on the accrual basis from the financial records supplied by John Hancock Life Insurance Company, the Trustee.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### Benefit Payments

Benefit payments are recorded upon distribution to participants.

##### Forfeitures

Forfeited, nonvested amounts may be used to pay administrative expenses of the Plan or to reduce employer contributions. Forfeitures during the year ended December 31, 2024 amounted to \$220. There were no forfeitures during the year ended 2023. There were \$779 and \$559 in forfeiture balances available to offset plan expenses or to reduce employer contributions as of December 31, 2024 and 2023, respectively.

##### Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

##### *Use of Estimates in Preparation of Financial Statements*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

---

#### **3. Financial Information Certified by the Trustee**

---

John Hancock Life Insurance Company (the Trustee) has provided the Plan Administrator with certifications as to the completeness and accuracy of total investments of the Plan held by the Trustee aggregating \$5,726,621 and \$4,313,659 as of December 31, 2024 and 2023, respectively, and the related investment income of \$672,442 and \$645,242 for the years then ended, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule based upon the certifications from the Trustee.

Under the terms of the trustee agreement, the Trustee has non-discretionary authority over Plan assets and maintains investment funds on behalf of the Plan. The Trustee has been granted authority to make purchases and sales of investments at the direction of the Company and plan participants and maintains records of all participant and Plan transactions and accounts.

#### 4. Fair Value Measurements

---

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Observable market-based inputs or unobserved inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

**Pooled Separate Accounts:** Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the funds derived from inputs principally from or corroborated by observable market data by correlation or other means, although not based upon quoted prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

**4. Fair Value Measurements (Continued)**

The methods described on the previous page may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Party-in-Interest Transactions**

---

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Certain plan investments include pooled separate accounts that are managed by the John Hancock Life Insurance Company (the Trustee); and therefore, these transactions qualify as party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

Additionally certain employees of the Company provide accounting and administrative services for the Plan for which no fees are charged. These transactions are also permitted under ERISA regulations.

---

#### **6. Tax Status**

---

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

As of December 31, 2024, the Plan does not believe that it has taken any tax positions that require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months.

The Plan's informational returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal informational returns generally remain open for a period of three years.

#### **7. Risks and Uncertainties**

---

The Plan offers a number of investment options to participants that are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect amounts reported in the statements of net assets available for benefits and participant accounts.

---

#### **8. Subsequent Events**

---

In preparing the financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through July 23, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.
