To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Power System Engineering, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section,

- the information in the accompanying 2024 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Power System Engineering, Inc. 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through July 23, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Power System Engineering, Inc. is the plan sponsor, employer and the plan administrator. Empower Trust Company, LLC holds custody of the plan's mutual funds and common/collective trusts. Empower Annuity Insurance Company of America holds custody of the plan's guaranteed investment contract. Empower Retirement, LLC maintains investment and participant records and is the brand name which refers to the products and services provided by both Empower entities discussed above, collectively referred to as "Empower". Peak Retirement Group is the third party administrator and performs various compliance tests as tax counsel. M3 Financial is the plan's investment advisor. An officer of the plan sponsor is the trustee.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the prospectuses and annual reports of the investments for more information. Earnings, including the net appreciation (depreciation) of investments bought, sold and held during the year, is reflected in the accompanying statement of changes in net assets available for benefits.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - Valued at the daily published market prices as reported by the funds. These investments held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trust - Valued at the NAV based on the units of the common/collective trusts. The common/collective trust investments are direct filing entities. The NAV, as certified by Empower, is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by the common/collective trusts less their liabilities. This practical expedient would not be used if it is determined to be probably that the common/collective trusts will sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

Investment at contract value - The plan invests in the Key Guaranteed Portfolio Fund, a general account product of Empower. The investment is a fully benefit-responsive guaranteed portfolio investment through a group fixed annuity contract issued by Empower. As a general account product, participants' principal and interest amounts are fully guaranteed by the general assets of Empower. The methodology for calculating the interest crediting rate is based on the prevailing market conditions and earnings of medium-long term investments compared to a minimum interest crediting rate, as stated in the plan's contract with Empower. The interest crediting rate is reset quarterly. The average yield earned by the fund was 1.41% in 2024.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor may request a full distribution at any time. In the event the plan requests an immediate lump sum distribution, a market value adjustment is calculated or the plan may request the distribution in installments over a period of 12 months at contract value.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that might limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The plan was established on January 1, 2011 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to contribute to plan once they have reached age twenty-one. Employees can enter the plan on the first day of the month following completion of eligibility requirements. For purposes of employer contributions, employees are eligible once they have completed six months of employment with at least 500 hours of service and have reached age twenty-one. If the service requirement is not met in the first consecutive period of months, an employee will also become eligible once they have completed one year of employment with at least 1,000 hours of service. An employee becomes eligible for employer contributions on the first day of the quarter following completion of eligibility requirements.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contribution). The plan also permits Roth elective deferral contributions. Upon meeting eligibility requirements, employees are enrolled in the plan and have 6% of compensation withheld as elective deferral contributions. These participant deferral percentages automatically increase by 1% each year until they reach a maximum of 10%. Such participants have the option to increase, decrease or stop the deferral at any time by completing the necessary documentation.

- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Safe harbor employer contributions are made in conjunction with each pay period equal to 3% of each eligible employee's compensation.
- d. Employer matching contributions can be made at the employer's discretion. The discretionary employer matching contributions made were equal to 1% of each eligible employee's compensation in 2024. These contributions are funded annually subsequent to year-end. To receive discretionary employer matching contribution, employees must be employed on the last day of the year and must have completed 1,000 hours of service during the plan year to which the contributions relate. These requirements are waived upon death, disability or attainment of normal retirement age (defined as 59 ½) during the year which the contribution relates.
- e. Nonelective employer contributions can be made at the employer's discretion. No such contributions were made in 2024.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions and rollover contributions and an allocation of employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

Vesting - Participant accounts are always 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions can be made in the form of a single lump sum payment or partial payments. In-service withdrawals can commence upon attaining the age of 59½. In addition, hardship withdrawals are also permitted under certain circumstances.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and are recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution and loan fees and non-participant directed fees for service and administrative services. Non-participant directed fees are allocated to participants on an account value basis.

Notes receivable from participants - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may not have more than two loans outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had various repayment schedules through August 2029 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

The plan's investments are managed by Empower. Empower is the custodian as defined by the plan, and therefore, these transactions qualify as party-in-interest transactions. In addition, Empower receives indirect compensation from the plan's mutual fund investment providers for services Empower provides to the funds. Certain revenues received by Empower from such service providers are remitted to the plan in the form of service credits (as part of an administrative services agreement between the plan sponsor and Empower). Such service credits received by the plan are used by the plan to pay service and administrative fees and other plan fees. There are also certain other plan expenses that Empower charges that are paid directly. Direct fees paid by the plan to Empower were \$26,000 in 2024.

Notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA.

5. INCOME TAX STATUS

The plan adopted a FTWilliam pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. As a result, the plan administrator has not obtained a separate Internal Revenue Service opinion letter for the plan. The plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

Management has obtained certifications from Empower, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- d. The report of individual participant accounts as of and for the year ended December 31, 2024.
