Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Lawrence Technological University DC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Emphasis of Matter

As explained in Note 5, the financial statements include investments valued at approximately \$23 million at December 31, 2024 and 2023 (23 percent and 24 percent, respectively, of net assets), whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF). Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Note 1 - Plan Description

The following description of Lawrence Technological University DC Retirement Plan (the "Plan" or the "Retirement Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees, except for adjunct professors, temporary project employees, and employees enrolled as students, of Lawrence Technological University (the "University"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to participate in the Plan on the first day of the month following their date of hire, and there is no age requirement. Employees are eligible for employer matching contributions when they are age 25 or older and have completed one year of service or have a qualifying existing retirement account sponsored by a prior employer.

Contributions

The Plan provides for employee pretax elective deferrals subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The University provides a matching contribution to the accounts of eligible participants, as determined by the University's board of trustees. The employer matching contribution is 1.5 percent of the participant's compensation for eligible employees who have pretax elective deferrals of at least 2.5 percent of annual compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the University's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions and the employer matching contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Benefit Payments

Distribution of a participant's elective deferrals and any employer contributions are payable upon termination of employment, the incurrence of a disability, attainment of age 59½ for a participant's elective deferrals only, or attainment of age 65 for employer contributions and a participant's elective deferrals. Participants' elective deferrals may also be distributed on account of hardship or at any time with respect to pre-1989 elective deferrals in an annuity contract. Distributions may be received in the form of a lump-sum, partial payments, installment payments, or annuity amount. Certain amounts invested in the TIAA Traditional Annuity group annuity contract may not be distributed in a lump sum (see redemption restrictions below).

Note 1 - Plan Description (Continued)

Redemption Restrictions

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participants to transfer or withdraw from the fund. Transfers from the Retirement Annuity (RA), Group Retirement Annuity (GRA), and Transfer Payout Annuity (TPA) contracts must be paid out in 10 annual installments. Transfers from the Retirement Choice (RC) contract must be paid over 84 monthly systematic payments. Withdrawals from the RA contract must be paid out in 10 annual installments. The Interest Payment (IP) contract is an interest-only payment stream and typically has redemption restrictions ranging from 84 months to 10 years. Withdrawals from the GRA and RC contracts are available within 120 days after termination of employment, subject to a 2.5 percent surrender charge; otherwise, they must be paid over 10 annual installments or 84 monthly systematic payments, respectively. The remaining contracts under the TIAA Traditional Annuity investment do not have restrictions related to transfers and withdrawals.

Plan Loans

Prior to September 25, 2020, participants could borrow from TIAA using their TIAA Traditional Annuity account balances as collateral for the loan. Collateral is required in an amount equal to 110 percent of the outstanding loan balance. Participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45 percent of their TIAA Traditional Annuity account balances subject to annuity contract and plan provisions. Loan terms range from 1 to 5 years or up to 10 years for the purchase of the participant's primary residence. Loans bear interest at market rates. Principal and interest are paid ratably by the participant to TIAA, and each payment will reduce amounts collateralized by the participant's TIAA Traditional Annuity account balance. The amount of these outstanding loans was \$43,073 and \$81,926 at December 31, 2024 and 2023, respectively. These loans are not included as assets in the accompanying financial statements. At December 31, 2024 and 2023, \$13,847 and \$26,018, respectively, of the plan loan balances was in default.

Participant Notes Receivable

Effective September 25, 2020, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Participant notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Party-in-interest Transactions

All plan assets are in investment funds managed by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF); TIAA Trust, NA (formerly known as TIAA, FSB); or their affiliates. TIAA-CREF is a service provider of the Plan, and TIAA Trust, NA is a custodian as of December 31, 2024 and 2023. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time, to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA, or to amend the Plan at any time.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below.

Note 2 - Summary of Significant Accounting Policies (Continued)

Investments in registered investment companies are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There were no unfunded commitments or redemption restrictions on the investments in registered investment companies. Investments in the pooled separate account are valued at NAV (or its equivalent) of the fund, which is based on the fair market value of the fund's underlying net assets, which primarily consist of rental property subject to long-term leases, and have been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved. There were no unfunded commitments or redemption restrictions on this investment.

The TIAA Traditional Annuity is a guaranteed annuity account issued by Teachers Insurance and Annuity Association of America that invests in the general assets of TIAA. TIAA considers the following contracts to be benefit responsive: Supplemental Retirement Annuity (SRA), Group Supplemental Retirement Annuity (GSRA), and Retirement Choice Plus (RCP). TIAA considers the following contracts to be non-benefit responsive: Retirement Annuity, Group Retirement Annuity, Interest Payment, Retirement Choice, and Transfer Payout Annuity. The benefit-responsive portion is recorded at contract value. The non-benefit-responsive portion is reported at fair value. Since there are no specific securities in TIAA's general account related to these contracts and due to the contract terms, including the frequency of the interest rate reset intervals, contract value is the best estimate of fair value for the non-benefit-responsive contracts. For all portions, contract value represents principal invested, plus interest earned, less any withdrawals.

All other investments are valued based on quoted market prices. See Note 5 for additional information.

Benefit Payments

Benefits are recorded when paid. There were benefit payments requested but not paid (due to redemption restrictions) totaling \$861,667 and \$876,621 as of December 31, 2024 and 2023, respectively.

Allocated Insurance Contracts

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact. During the year ended December 31, 2024, additional contracts were purchased for approximately \$609,000. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

Administrative Expenses

Various administrative costs are paid by the University.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 5, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

TIAA-CREF holds the Plan's investments, except mutual funds, and executes related transactions. TIAA Trust, NA holds the mutual fund investments and executes all related transactions. TIAA has the authority to certify the investment balances and related investment activity on behalf of TIAA Trust, NA. The investment balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by TIAA-CREF, including TIAA, as agent for TIAA Trust, NA.

Note 4 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated August 7, 2017. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

- (2) This class represents investments in actively managed registered investment companies that invest in a variety of fixed-income investments, which may include corporate bonds, both U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures.
- (3) This class represents investments in actively managed registered investment companies with investments in both equity and debt securities. The investments may include common stock, corporate bonds, U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures.
- (4) This class represents investments in actively managed registered investment companies that invest primarily in money market funds, with the objective of providing high current income consistent with the preservation of capital and the maintenance of liquidity.
- (5) This is a direct filing entity.

Note 6 - Annuity Contracts

The total TIAA Traditional Annuity balance was \$23,966,284 and \$24,270,753 at December 31, 2024 and 2023, respectively. Based on the terms of the contracts, a portion of the TIAA Traditional Annuity is considered benefit responsive. The benefit-responsive portion totaled \$3,383,651 and \$3,677,288 at December 31, 2024 and 2023, respectively. The contract issuers maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a vintage approach. Under this methodology, TIAA groups the dollars it receives over defined time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the benefit-responsive contracts is generally 3.00 percent; however, in some recent contracts, it is between 1.00 and 3.00 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value with payments made within 90 days or, in rare circumstances, paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.
