INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of **Blu Omega 401(k) Plan**:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Blu Omega 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Blu Omega 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. A. Description of Plan

The following description of Blu Omega 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution, tax-deferred 401(k) plan covering salaried and hourly wage employees of Blu Omega LLC (the "Company") who are at least 21 years of age and meet other eligibility requirements as defined by the Plan. In general, employees are eligible to make deferral contributions after completing one month of service with the company. Entry dates are monthly. Participation in employer matching contributions and nonelective contribution requires six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of eligible compensation, not to exceed the maximum salary deferral limit and other limitations established by law. Eligible compensation is defined in the Plan documents as taxable income on Form W-2, plus elective deferrals, contributions made to a qualified cafeteria plan and certain other amounts.

Participants may elect deferral contributions either as pre-tax or as after-tax Roth elective deferrals or as a combination of both pre-tax and Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code (IRC). Participants also may make rollover contributions as defined in the Plan. Participant contributions are invested according to direction of the participants.

New employees are automatically enrolled as Plan participants with an initial deferral rate of 3% of compensation, with the option to choose a different percentage, including zero. Each year the deferral rate is increased by 1% up to a maximum 10% deferral rate for employees participating in the automatic enrollment process. An affirmative election by a participant overrides any automatic enrollment or escalation of the deferral rate.

The Company has the option to make employer matching contributions and employer nonelective contributions to the Plan, although the Company is not required to do so. In 2024, the company matched 100% of employee contributions on the first 3% of employee compensation and 50% of employee contributions on the next 2% of employee compensation, as defined. Employer contributions are invested according to participant investment elections.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions. Investment earnings, losses, and changes in market value are allocated based upon the investment experience of each holding in a participant account. Certain transactional costs and service charges, if any, are allocated to the specific accounts involved in the transaction or receiving the service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their own deferral contributions and rollover contributions and related earnings at all times. Employer matching contributions, employer nonelective contributions, and earnings

thereon are subject to a three year vesting schedule. Participants vest in 33% of employer matching and nonelective contributions after one year of credited vesting service, 67% after two years of credited vesting service, and 100% after three years of credited vesting service.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. One outstanding loan is allowed at any one time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%, as specified in the Plan documents. Principal and interest are paid ratably through payroll deduction.

Payment of Benefits

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, and at death. Hardship distributions and in-service distributions are available for eligible participants. Benefit payments may be made as a lump-sum payment equal to the value of the participant's vested interest in his or her account or partial payments. Upon termination of employment, accounts with vested balances of less than \$5,000 may be distributed out of the Plan.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The loans are secured by vested participant account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Only expenses paid by the plan are included in these financial statements. Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Per-use transaction fees are charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions. In addition to per-use transaction fees, participants with account balances share in the operational expense of the Plan. Investment operating expenses are net against the investment returns of the applicable investments.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through August 7, 2025, the date the financial statements were available to be issued.

C. Information Prepared and Certified by the Plan Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Voya Retirement Insurance and Annuity Company, the insurance company of the Plan, has certified as to the completeness and accuracy of reported investment balances and related investment activity in these financial statements and supplemental schedule, summarized as follows:

D. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective trusts are valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled separate accounts are valued per the unit value methodology, which is calculated based on the observable net asset values of the underlying investments

The following tables sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Guaranteed Interest Contract

The Voya Fixed Account investment is guaranteed interest contract issued by Voya Retirement Insurance and Annuity Company (“VRIAC” or “Voya”). Voya maintains the contributions in a general company account and is contractually obligated to repay principal and a specified interest rate to the Plan. A single interest crediting rate is applied to all Fixed Account assets regardless of when contributions are made. Voya periodically resets the crediting interest rate based on changes in markets, subject to the contractual guaranteed minimum interest crediting rate of 1.00%. The effective annual crediting interest rate during 2024 and 2023 was 1.65% and 1.50%, respectively. The Voya Fixed Account contract value was \$9,640 and \$1,161 (unaudited) at December 31, 2024 and 2023, respectively.

The Voya Fixed Account contract meets the fully benefit responsive investment criteria and therefore is presented at contract value on the statements of net assets available for benefits. Contract value is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus interest credited, and less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, subject to provisions for transfers to “competing investment options.”

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its financial obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events, such as termination of the contract by the Plan sponsor, may be subject to a market value adjustment and a surrender charge and limit the ability of the Plan to transact at contract value with the issuer of the contract. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

F. Related Party and Party-In-Interest Transactions

Voya Retirement Insurance and Annuity Company (“VRIAC” or “Voya”) is the recordkeeper of the Plan and custodian of the Plan’s assets and receives fees for recordkeeping and custodial services. Voya receives fees for other administrative services that are included in fees and other expenses. A financial advisor receives fees for services and commissions. The Company provides the Plan with accounting and administrative services, for which no fees are charged to the Plan. The Plan allows loans to participants. These transactions qualify as exempt party-in-interest transactions.

G. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their accounts, and the Company will arrange for distributions as soon as administratively feasible.

H. Tax Status

The Internal Revenue Service has determined and reported in its opinion letter dated June 30, 2020, that the form of adopted pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator

believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions have been taken or are expected to be taken that would require recognition or disclosure in the financial statements.

I. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
