We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter – Plan Termination and Liquidation Basis**

As discussed in Note G to the financial statements, the Board of Directors of Corporate Immigration Partners, LLP, the Plan's sponsor, elected to terminate the Plan effective July 31, 2023, and management determined liquidation is imminent. As a result, the Plan used the liquidation basis of accounting to present the financial statements. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Corporate Immigration Partners 401(k) Plan (the Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. General

The Plan was a defined contribution profit sharing and 401(k) plan covering eligible employees of Corporate Immigration Partners, LLP (the Company). All non-union, non-leased employees who were not nonresident aliens or interns were immediately eligible to participate upon hire and attaining age 18. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As discussed in Note G, effective July 31, 2023, the Plan was terminated.

2. Contributions

The Plan was funded by voluntary contributions of participants and discretionary matching and profit sharing contributions of the Company. Prior to the termination of the Plan described in Note G, participants were able to contribute to the Plan, through regular payroll deductions, and participants who had attained age 50 before the end of the calendar year were eligible to make catch-up contributions. Participants were able to also roll over amounts representing distributions from other qualified employee benefit plans. There were no discretionary matching contributions to the Plan for the year ending December 31, 2024. The company made no discretionary profit sharing contributions to the Plan for the year ending December 31, 2024. Contributions were subject to certain IRS limitations.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants had their deferral rate increased up to a maximum of 15% of eligible compensation, unless otherwise elected by the participant.

3. Investment Options

Participants were permitted to direct their salary deferral contributions and the Company's contributions into a variety of investment options that were available and determined by the Plan Administrator. Participants were permitted to change their investment options at any time.

4. Participant Accounts

Each participant's account was credited with the participant's contribution, an allocation of the Company's contributions, and an allocation of plan earnings. The Company's discretionary matching contribution was allocated based on a percentage of the participant's contribution. The Company's discretionary profit sharing contribution was allocated as of the last day of the plan year and is based on a ratio of each eligible participant's compensation to total compensation for all eligible participants. Plan earnings were allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance.

5. Vesting

Participants were immediately fully vested in participant and rollover contributions plus the actual earnings thereon. As a result of the decision to terminate the Plan during 2023 (Note G), all participants became fully vested in their account balances.

6. Payment of Benefits

On termination of service, a participant could have elected to receive a single, lump-sum payment equal to the value of his or her vested account balance, installments over a specified period of time, or a direct rollover distribution. In-service withdrawals were permitted upon attainment of age 59 1/2. Hardship withdrawals were also permitted by the Plan.

7. Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Participants were permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans were collateralized by the borrowers' respective vested account balances. Principal and interest were paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence.

8. Administrative Expenses

Certain expenses incurred maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments.

9. Forfeitures

At December 31, 2024 and 2023, unallocated plan assets resulting from forfeited nonvested accounts were approximately \$0 and \$43,000, respectively. Forfeitures could be allocated to participants or used to pay Plan expenses. Forfeitures of approximately \$55,000 were allocated to participants during 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

As a result of the Plan termination (see Note G), management determined that the liquidation of the Plan was imminent and the financial statements have been prepared using the liquidation basis of accounting.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1                      Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2                      Inputs to the valuation methodology include the following:

- \* Quoted prices for similar assets or liabilities in active markets;
- \* Quoted prices for identical or similar assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability;
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023. The Plan did not hold investments as of December 31, 2024 due to the termination (Note G).

3. Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the custodians. See Note B-2 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income from notes receivable from participants was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments was included the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

5. Payment of Benefits

Benefits were recorded when paid.

NOTE C - INFORMATION CERTIFIED BY MATRIX TRUST COMPANY

Certain information related to investments disclosed in the accompanying financial statements, including cash and cash equivalents and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, a qualified institution (the custodian of the Plan).

NOTE D - TAX STATUS

Effective April 22, 2022, the Plan adopted a non-standardized pre-approved 401(k) profit sharing plan sponsored by CCH Incorporated, DBA ftwilliam.com. The pre-approved plans had received opinion letters from the Internal Revenue Service as to the pre-approved plans' qualified status. The pre-approved plan opinion letters had been relied upon by this Plan. The Plan Administrator believed that the Plan was currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

NOTE E - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments were managed by the custodian; therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issued loans to participants, which were secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualified as party-in-interest. Employees of the Company provided administrative services to the Plan for which no fees were charged.

NOTE G - PLAN TERMINATION

Effective July 31, 2023, the Board of Directors of Corporate Immigration Partners, LLP, the Plan's sponsor, elected to terminate the Plan and management determined liquidation is imminent. In accordance with IRS regulations, participants had the option to receive a lump-sum cash distribution, rollover their balance into another qualified plan, or a combination of both. As of January 8, 2025, the Plan's investments were fully liquidated and distributed to participants in a lump sum or rolled over into preselected individual retirement accounts. Administrative costs for expenses incurred by the Plan relating to the liquidation were paid by the Plan and are included in administrative expenses on the accompanying statement of changes in net assets in liquidation.

NOTE H - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through August 8, 2025, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions, other than those disclosed in Note G, have occurred subsequent to the statement of net assets available for benefits date that require disclosure in the financial statements.
