## **Independent Auditor's Report**

We have performed audits of the financial statements of Joint Township District Memorial Hospital Employees' Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1 - Plan Description

The following description of Joint Township District Memorial Hospital Employees' Pension Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all full-time employees of Joint Township District Memorial Hospital (the "Hospital"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan, originally effective as of February 1, 1990, was amended and restated in its entirety effective as of August 1, 2008. Each employee who was eligible immediately prior to August 1, 2008 continued to be an eligible employee. Other employees shall become eligible as of the next enrollment date coinciding with the employee reaching 19 years of age and completing one year of credited service, as defined in the plan agreement.

#### **Contributions**

Employees who were hired prior to January 1, 2007 and were eligible for contributions shall receive a supplemental contribution of 5.5 percent of the participant's compensation plus 3.3 percent of any compensation in excess of \$25,000. In addition, the Hospital matches 50 percent of the first 4 percent of participant compensation contributed to Joint Township District Memorial Hospital Tax Deferred Annuity Plan.

For employees hired on or after January 1, 2007, no supplemental contribution will be made. The Hospital matches 50 percent of the first 8 percent of participant compensation contributed to Joint Township District Memorial Hospital Tax Deferred Annuity Plan.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's rollover contributions and allocations of the Hospital's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

A participant is 100 percent vested in the employer match portion of his or her account after three years of credited service, as defined in the plan agreement.

A participant is 100 percent vested in the rollover funds of another qualified plan, as defined in the plan agreement, and any income or loss thereon.

#### **Benefit Payments**

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The designated beneficiary is entitled to a death benefit equal to the participant's account balance.

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future hospital contributions.

### Note 1 - Plan Description (Continued)

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Talcott Resolution Life Insurance Company (TRLIC) or its affiliates. TRLIC is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are held in pooled separate accounts valued at fair value and an unallocated investment contract that is maintained by TRLIC valued at contract value. The pooled separate accounts are valued at net asset value per share (or its equivalent) of the accounts, which is based on the fair value of the accounts' underlying net assets. The Plan's unallocated investment contract is a benefit-responsive group annuity contract with TRLIC that invests in TRLIC's general assets. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

See Notes 4 and 6 for additional information.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Administrative expenses for the years ended December 31, 2024 and 2023 were paid by the Hospital. Additionally, the Hospital provides certain accounting and administrative services at no cost to the Plan.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 28, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

TRLIC holds the Plan's investments and executes all related transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Empower Annuity Insurance Company of America on behalf of TRLIC.

### Note 4 - Unallocated Investment Contract

The Plan invests in a benefit-responsive unallocated investment contract with TRLIC. TRLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest rates are established and declared for new contributions that will be received in a calendar quarter. The rate is based on the return TRLIC expects on new investments made by it and held with the TRLIC general account. When establishing interest crediting rates for these contracts, TRLIC considers past general account investments, adjusted for portfolio turnover and withdrawals for benefit payments. The crediting rate will always equal or exceed the contractually guaranteed rate.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rate is based on a formula agreed upon with the issuer but may not be less than 3 percent for the TRLIC contract. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with TRLIC. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with the plan participants, is probable.

Liquidation of the entire contract may cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from contract value. The unallocated investment contract does not permit the insurance companies to terminate the agreement prior to the scheduled maturity. This total liquidation is a contingent event, which cannot be initiated by the plan participants and can only be initiated by the plan trustee upon termination of the Plan or complete termination of the contract.

### Note 5 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS. The Plan has not individually sought its own determination letter.

### Note 6 - Fair Value Measurements

#### *Investments in Entities that Calculate Net Asset Value per Share*

The Plan holds shares or interests in pooled separate accounts for which fair values are estimated based on the net asset value per share (or its equivalent) of underlying assets in the accounts.
