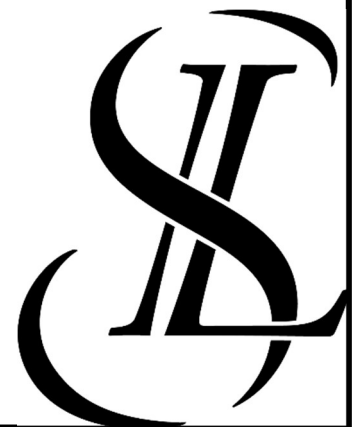

## Independent Auditor's Report

To the Plan Administrator and Participants  
Interstate Foam and Supply, Inc. Retirement Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Interstate Foam and Supply, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended October 31, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023, and for the year ended October 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

### ***Basis for Opinion***

## Notes to Financial Statements

---

### 1. Description of Plan

The following description of the Interstate Foam and Supply, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by Interstate Foam and Supply, Inc. ("Company") covering substantially all employees who have completed three months of service and are age twenty or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Participants may contribute up to 100% of their pre-tax and/or after-tax annual compensation as defined by the Plan, not to exceed the limits set by the Internal Revenue Service ("IRS"). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). The Company may make a discretionary matching contribution at a rate to be determined annually. During 2024, the Company matched 75% of the first 4% of compensation deferred into the Plan. The Company may also make a discretionary profit-sharing contribution to be determined annually for participants employed on the last day of the Plan year and have more than 1,000 hours of service during the year. The discretionary profit-sharing contribution is allocated to eligible participants at a rate to be determined annually. During 2024, the Company made a profit-sharing contribution of approximately \$25,000.

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant's account is credited with the participant's and Company's contributions, the individual earnings or losses on the participant's accounts, and an allocation of the Plan's administrative expenses. Allocations are based upon participant account balances or participant distribution requests, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The portion of the participant's accounts attributed to Company discretionary matching and profit-sharing contributions plus actual earnings thereon vest based on continuous years of service according to the following schedule:

### 1. Description of Plan (Concluded)

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum payment or installment payments over a period not to exceed the life expectancy of the participant and the designated beneficiary. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

#### ***Notes Receivable from Participants***

Participant loans are not permitted by the Plan.

#### ***Forfeitures***

Forfeitures from non-vested participant accounts may be used to reduce future Company discretionary contributions, with no forfeitures utilized during 2024. Available forfeited non-vested accounts totaled approximately \$11,000 at both October 31, 2024 and 2023.

#### ***Administrative Expenses***

The Plan's administrative fees relate to fees for disbursements and asset based fees related to investments. Both are paid by the participants in accordance with the fee agreement. Other fees are absorbed by the Company.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through July 31, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at October 31, 2024 and 2023 and net appreciation (depreciation) in the fair value of investments, interest, and dividends for the year ended October 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype non-standardized plan document sponsored by Ascensus, LLC ("Ascensus"). The IRS has determined and informed Ascensus by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

Ascensus and its affiliate serve as the recordkeeper and trustee of the Plan, and as such, these transactions qualify as party-in-interest. Administrative fees paid by the Plan to Ascensus for administrative services were approximately \$49,000 in 2024.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurements***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

### 8. Fair Value Measurements (Concluded)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer using the estimated fair value of the underlying assets, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
