Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Laing Companies 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. Plan Description

The following description of Laing Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of the Plan's provisions. The Plan Administrator oversees the governance of the Plan. The Plan was originally effective January 1, 1961. The Plan's most recent restatement was effective January 1, 2021.

General

The Plan is a defined contribution plan covering substantially all employees of Eugene Welders Supply Co. (the Employer). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate in the Plan after 90 days of continuous employment provided that they are not union employees, nonresident aliens, or leased employees. Entry into the Plan is the date on which eligibility requirements are met for participant deferrals and the Plan's Safe Harbor contribution. Employees become eligible for profit-sharing contributions after one year of service with at least 1,000 hours. Entry dates for profit-sharing contributions are January 1 and July 1 of the Plan year coinciding with or next following the date the eligibility requirements are met.

Contributions

Each year, participants may contribute up to 100 percent of pre-tax or after-tax (Roth) annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan uses an auto enrollment feature with a pre-tax deferral rate of 2 percent for eligible participants who do not make a voluntary election. The Plan also allows for participants to make rollover contributions from existing qualified plans into the Plan.

The Employer makes Safe Harbor nonelective contributions equal to 3 percent of each participant's compensation. The Employer also makes nonelective profit-sharing contributions to the Plan and may include each participant in a separate allocation group. In 2024 and 2023, the Employer made a nonelective profit sharing contribution equal to 1.07 and 3.50 percent, respectively, of eligible compensation for participants with one year of service. All other employees are allocated enough profit sharing in order to pass the required nondiscrimination test. For the year ended December 31, 2024, the total Employer's Safe Harbor and profit-sharing contributions were \$308,798 and \$129,286, respectively. For the year ended December 31, 2023, the total Employer's Safe Harbor and profit-sharing contributions were \$282,925 and \$374,775, respectively.

Contributions are subject to regulatory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, and earnings on the participant's account balances. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts, continued

Participants are able to direct the investments in their beneficial account within Plan guidelines. This may include individually directed accounts in the custody of the Plan's custodian in a Personal Choice Retirement Account (PCRA).

Vesting

Participants are vested immediately in all contributions plus actual earnings thereon.

Payment of Benefits

Upon retirement, disability, death, or termination of employment a participant may elect to receive the value of the participant's vested interest in his or her account in a lump-sum. In-service distributions are permitted upon attainment of retirement age. In-service distributions for hardships are also permitted on account of an immediate and heavy financial need of the participant, subject to the Plan's rules governing hardship withdrawals.

Participant Loans

Participants are not permitted to borrow from their accounts under the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Contributions

Participant contributions are recorded in the year in which they withheld from compensation. Employer Safe Harbor and profit-sharing contributions are recorded in the year in which the underlying compensation is paid.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administration Expenses and Fees

Administrative expenses of the Plan are paid by Plan assets or may be paid by the Employer at the election of the Plan Administrator. Expenses paid by the Employer are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments or are reported as a reduction from investment income.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

4. Tax Status

The Internal Revenue Service (IRS) has informed Prime Retirement Solutions LLC by an opinion letter dated October 24, 2022, that the prototype non-standardized pre-approved profit-sharing plan with CODA adopted by the Plan, as then designed, is qualified under Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the advisory opinion, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the net asset value (NAV) of shares held by the Plan at year end. All mutual funds held by the Plan are open-end mutual funds that are registered with the SEC and are deemed to be actively traded and have a readily determinable fair value. These funds are required to publish their daily NAV and to transact at that price.

Common stocks (including investments held in PCRA accounts): Valued at the closing price reported on the active market on which the individual securities are traded.

Interest-bearing cash: Cash equivalent funds held by the Plan are valued at the contract value of the cash instrument. Because these inputs are not observable, these assets are considered to be valued at Level 2 in the hierarchy.

7. Fair Value Measurements, continued

Common/collective trusts: Units held in the common/collective trusts are valued using the NAV of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the common/collective trusts measured at NAV have not been classified in the fair value hierarchy. All common/collective trusts investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Party-in-Interest Transactions

Certain Plan investments are managed by Alerus Retirement Solutions, an affiliate of Alerus Financial, N.A., the custodian of the Plan, and therefore these transactions qualify as party-in-interest transactions. Administrative fees paid to Alerus Retirement Solutions were \$1,546 and \$28,743 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
