NOTES TO FINANCIAL STATEMENTS

December 31, 2024

1. Description Of Plan

The following description of the Motion & Flow Control Products, Inc. 401(k) Plan (the Plan) provides only general information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is available to all employees (with the exception of part-time or temporary employees, nonresident aliens or union members) of Motion & Flow Control Products, Inc. (the Company), and its wholly owned subsidiaries, McCoy Sales Corporation, Fluid Connector Products, Inc. and American Hose and Fittings, Inc.

Fidelity Management Trust Company (the Trustee) serves as the trustee of the Plan assets.

Eligibility

The Plan is a defined contribution pension plan covering virtually all employees of the Company who have completed 30 days of service and are age 18 or older. Employees may enter the Plan on the first day of each month after the eligibility requirements have been met.

Contributions

Each year, participants may contribute pretax deferrals up to 75% of pretax annual compensation and Roth deferrals, as defined in the Plan, not to exceed certain limitations established by the Internal Revenue Service (the IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in the amount of \$7,500 up to 90% of their pretax annual compensation. Participants may also make rollover contributions representing distributions from other qualified defined benefit or contribution plans. Any employee who reaches the eligibility requirement will be automatically enrolled and have a 6% deferral of compensation into a Fidelity target-date fund based on the employee's age unless a contrary election is made. The Company has a discretionary employer match. For the year ended December 31, 2024, the Company contributed 50% of the first 6% of base compensation that a participant contributed to the Plan.

Notes To Financial Statements *(Continued)*

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of discretionary Company contributions and Plan earnings and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of both their contributions and the Company's contributions into various investment options offered by the Plan. Participants have the option to invest in self-directed brokerage accounts. Participants may change their elections daily.

Vesting

Participants are immediately vested in employer and their elective salary deferral contributions plus actual earnings thereon.

Notes Receivable From Participants

Active participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance as of the last valuation date, less the highest outstanding loan balance during the prior 12-month period. The repayment period is limited to 5 years, except a note used for the purchase of a principal residence may be repaid over a term not to exceed 10 years. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates at note origination, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment Of Benefits

Participants or their beneficiaries are eligible for benefits upon retirement, termination, death or disability. Vested benefits are made in a single lump sum payment or as a direct rollover to an individual retirement account or to another employer's tax qualified plan. If the participants vested account balance is less than \$5,000 immediately following termination, a distribution will be automatically rolled over into an IRA.

In-Service Distributions

Active participants who reach age 59½ or experience a qualifying financial hardship may withdraw all or part of their vested account. Hardship withdrawals will be approved only if they conform to Plan provisions and established Internal Revenue Code (the Code) safe harbor withdrawal provisions.

Administrative Expenses

Substantially all administrative expenses are paid by the Plan. Administrative expenses paid by the Plan included record keeper fees, service fees, investment advisor fees and transaction fees.

Forfeited Accounts

Forfeited nonvested accounts are first used to reduce administrative expenses and then are used to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$11,167 and \$1,109, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use Of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Risks And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes To Financial Statements *(Continued)*

Investment Valuation And Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The net appreciation in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year, and includes any realized gains and losses in shares that were bought and sold during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

3. Certification Of Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net change in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified by the Trustee.

4. Fair Value Of Investments

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies

Assets are valued at the daily closing price as reported by the registered investment company. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (the NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts

These accounts consist primarily of common stocks that are valued on the basis of readily determinable market prices.

Common Collective Trust

These are valued at the unit value or the NAV of shares held by the Plan at year end. The NAV, as provided by the Trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities, divided by the number of shares outstanding. All of the underlying investments held by the Plan may be redeemed daily. The common collective trusts held by the Plan are not required to be reported in the fair value hierarchy. All of the common collective trusts held by the Plan file an annual report on Form 5500 as a direct filing entity. The common collective trust has no unfunded capital.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Tax Status

The Plan uses a volume submitter defined contribution plan. The IRS has issued an opinion letter dated June 30, 2020 stating the Plan is qualified under Section 401(a) of the Code, and the underlying trust is therefore exempt from federal income taxes under Section 501(a) of the Code. The Plan has been amended since receiving the opinion letter. Plan management and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

6. Party In Interest Transactions

Plan investments consist of certain registered investment companies and self-directed brokerage accounts managed by the Trustee. These transactions qualify as party in interest transactions allowable under ERISA.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company may pay certain outside administrative expenses of the Plan.

Certain participants in the Plan have outstanding loans with the Plan as of December 31, 2024. These loans are considered party in interest transactions in accordance with the Department of Labor guidelines.

7. Subsequent Events

Management evaluates subsequent events through the date the financial statements were available for issue, which is the date of the Independent Auditors' Report.
