Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Greenville National Bank Employees Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting as described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) (modified cash basis) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Greenville National Bank Employees Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Greenville National Bank, (the “Bank” or “Employer”) who have completed three months of service. Pentegra Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 50% of their eligible compensation, as defined by the Plan Document, on a pre-tax or after-tax (Roth) basis. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from compensation and contributed to a qualified plan that is determined by the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution retirement plans. Participants may direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make a discretionary matching or non-elective profit-sharing contribution to the Plan. The Employer made a matching contribution equal to 25% of a participant’s elective deferrals. Catch-up contributions are not matched. The Employer made a non-elective profit sharing contribution equal to 6% of a participant’s eligible compensation, as defined by the Plan Document. Participants are eligible to receive the Employer non-elective profit-sharing contribution if they are employed as of the last day of the Plan year and have completed 1,000 hours of service. The Employer directs the investment of their contributions into the Greenville National Bank common stock and the money market fund offered by the Plan. Participants may transfer their shares of the Bank stock to another investment offered by the Plan at any time. For the year ended December 31, 2024, the Employer discretionary match totaled \$103,089 and the Employer non-elective profit-sharing contribution totaled \$285,090.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each eligible participant’s account is credited with (a) the participant’s contributions, allocations of (b) the Employer’s matching contributions on a quarterly basis and non-elective profit sharing contributions on an annual basis, (c) earnings on their individual investment selections, and charged with an allocation of administrative expenses.

1. Description of Plan (*continued*)

Voting Rights

Each participant is entitled to exercise voting rights attributable to the common stock of the Bank allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised.

Vesting

Participants are fully vested in their contributions and employer matching contributions plus actual earnings thereon.

A participant's vested interest in the value of his or her employer non-elective profit sharing contributions held in his or her account will be determined in accordance with the following schedule:

Payment of Benefits

Upon termination of the Plan or termination of service with the Bank due to death, disability, retirement, or attaining the age of 59½, a participant is entitled to receive an amount equal to the value of a participant's vested interest. Benefits can also be distributed from a participant's vested portion of his or her pre-tax salary deferrals and Roth deferrals in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Investment Concentration

The Plan holds approximately 51% and 52% of its investments as of December 31, 2024 and 2023 in shares of the Bank's stock.

Forfeitures

Forfeitures of the non-vested portion of terminated participants' employer non-elective profit-sharing accounts are maintained in a separate account and may be used to pay administrative expenses or to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$3,087 and \$16,682. During 2024, forfeitures of \$16,000 were used to reduce Employer matching contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis; investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

Although the Plan's financial statements are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. GAAP, the Plan follows U.S. GAAP guidance on Fair Value Measurements for disclosure purposes. That guidance defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The Bank's common stock is valued monthly at the fair value as determined by the Bank. See Note 5 for valuation method. Mutual funds and money market funds are registered investment companies which are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded.

The common/collective trust is valued at the NAV of units held by the Plan. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

2. Summary of Significant Accounting Policies *(continued)*

Investment Valuation and Income Recognition (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in the NAV of the respective funds and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 7, 2025.

3. Nonparticipant-Directed Investments

Nonparticipant-directed investments are put into participants' accounts by the employer (matching contribution and discretionary non-elective profit sharing contribution). Employees do not get to select or direct into which funds or investments the employer contributions are deposited.

The Bank paid dividends to the Plan of \$251,750 during the year ended December 31, 2024. The dividends are allocated to each participant's stock account.

The Bank's common stock held by the Plan is reported at fair value on a monthly basis with an independent valuation appraisal at the end of the year. The Bank's Board of Directors reviews and approves the stock valuation at year end. This appraisal was based upon the market valuation techniques consistent with prior years as illustrated in the following table.

6. Common/Collective Trusts

The Reliance Trust Company Stable Value Fund (the "Fund") is a collective investment trust that was formed for the purpose of allowing plan sponsors of defined contribution plans qualified under Sections 401(a) and 401(k) of the IRC to invest in the MetLife Group Annuity Contract 25053. This contract was issued by Metropolitan Life Insurance Company to Reliance Trust Company, who is the Trustee of the Fund. Units of the Fund are valued daily. Unit purchases and redemptions are transacted at the NAV determined as of the close of business each day. Issuances and redemptions of units of this Fund may be made on such days, based upon the NAV per unit, with no advance notice requirement. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values. The Fund has no unfunded commitments as of December 31, 2024 and 2023.

7. Plan Termination

Although it has not expressed any intention to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants' Employer profit sharing account balances under the Plan will become fully vested and nonforfeitable.

8. Tax Status

The Bank has adopted its most recent restated plan document effective January 1, 2021. The plan document preparer has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed and currently being operated in accordance with applicable sections of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Related Party and Party-in-Interest Transactions

The Plan invests in the Bank's common stock. These transactions qualify as exempt party-in-interest transactions.

Certain employees of the Bank perform administrative services related to the Plan; the Bank pays the salaries of these individuals.

The Trustee charges the Plan an administrative expense that is charged to participant accounts.

10. Risks and Uncertainties

The Plan invests in various investment securities including the Bank's common stock. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
