## **INDEPENDENT AUDITOR'S REPORT**

The Trust Finance and Administrative Committee  
Metlang LLC Health and Welfare Plan

### **Opinion**

We have audited the accompanying financial statements of Metlang LLC Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

**1. DESCRIPTION OF PLAN**

The following description of Metlang LLC Health and Welfare Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan document and trust agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General

The Plan was established on January 1, 2023, and is a contributory defined contribution and benefit health and welfare plan established by Metlang LLC (the Plan sponsor and the Company). The Plan has a defined contribution feature in consideration of the premium reserve accounts maintained for each Service Contract Act (SCA) employee. The Plan sponsor established a trust to serve as a funding vehicle for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility and Benefits

The Plan provides medical and prescription drug benefits under fully-insured contracts. Only SCA employees of the Company are eligible for these benefits under this Plan. The Plan purchases annual insurance contracts from Kaiser Permanente and Aetna Life Insurance Company for these benefits. Premiums for these benefits are paid to the insurance companies from assets of the Plan's Voluntary Employees' Beneficiary Association (VEBA) trust.

Employees of the Company who are working under federal contracts covered by the McNamara-O'Hara Service Contract Act (the Act) and are regularly scheduled to work at least 30 hours per week, are eligible to participate in the Plan on the first day of the month after 60 days of employment. Eligible participants may also purchase additional coverage for their spouse and dependents through pre-tax and after-tax deductions as allowable under Internal Revenue Service (IRS) and ERISA rules and regulations. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections.

Contributions (Continued)

Employer contribution rates are established annually by the Plan in accordance with prevailing wage rates and health and welfare rates for employees covered under the Act. The Plan sponsor adjusts the health and welfare contribution rates annually upon renewal or modification of the contract by the federal government. The Plan sponsor provides qualified fringe benefits for each employee covered by the Act up to the statutory limitations. As of December 31, 2024 and 2023, the Company contributed up to \$4.93 and \$4.57 per hour based on The Act's effective health and welfare contribution rate established by the Department of Labor (DOL).

The Company also contributes excess funds in participant premium reserve accounts, as defined and maintained by the Plan in meeting the health and welfare contribution rate requirement under the Act, and as required for the Plan to meet its obligations to Plan participants and service providers. The participants' premium reserve accounts can hold up to a maximum of three months of their required monthly premium payments, and any excess over that amount will be contributed to a qualified retirement plan established for the benefit of the participants. The balance in the premium reserve accounts can be used to pay for the monthly premiums for their respective benefit elections. If the balance of a participant's premium reserve account does not have sufficient funds to pay for coverage for a specific month, they will be required to pay the additional funds to continue coverage under the benefit programs for such month.

Experience-Rated Contracts

The contract with Aetna Life Insurance Company is subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

Plan Administration and Expenses

Under the Act, employers are required to ensure compliance with the prevailing wage rate and health and welfare benefit requirements. Accordingly, many employers establish separate trusts or other funded arrangements, which receive and administer the health and welfare contributions. If such contributions are paid to a trust, the trust must preclude the employer from recapturing any of the contributions paid into the trust in meeting the minimum prevailing wage requirement and from diverting any of the funds of the trust for its own benefit or use. The Plan established a trust to satisfy the Act's requirements. The Plan is managed by the Trust Finance and Administrative Committee, who are primarily representatives of the Plan sponsor. Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Plan management retained the services of a third-party administrator, Government Service Administrators (GSA), that specializes in providing administrative and accounting services for employee benefit plans under the Act.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

### Premium Reserve Accounts

The Plan maintains premium reserve accounts at the individual participant level which represents the unexpended balance in the participant accounts from contributions made at the prevailing health and welfare contribution rates established under the Act, less the benefit premiums, retirement plan allocations, and other benefit payments made on behalf of the participants. Amounts remaining in the participant premium reserve accounts at termination of employment are generally used to fund benefits or are contributed by the Company to a qualified retirement plan for the benefit of the participants. The balance of the premium reserve accounts as of December 31, 2024 and 2023 totaled \$272,056 and \$269,345. The activity related to the premium reserve accounts is excluded from the Plan's financial statements as the Plan is not obligated to pay those amounts to the participants.

### Use of Estimates

The preparation of financial statements is in accordance with accounting principles generally accepted in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trust Finance and Administrative Committee determines the Plan's valuation policies and procedures utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

### Concentrations

As of December 31, 2024 and 2023, the Plan had investments that represented more than 10% of net assets of \$379,199 and \$342,924, respectively, that were concentrated in one fund.

Payment of Benefits

Premium payments are recorded as insurance premiums paid in the accompanying statements of changes in net assets available for benefits.

Administrative Expenses

The Plan pays investment custodial and plan administration fees from plan assets.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**3. FAIR VALUE MEASUREMENTS (Continued)**

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used at December 31, 2024 and 2023.

*Money market mutual fund:* Valued at the daily closing price as reported by the fund. Money market mutual fund held by the Plan are open-ended mutual fund that are registered with the US Securities and Exchange Commission. This fund is required to publish its daily net asset value and to transact at that price. The money market mutual fund held by the Plan is deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**5. TAX STATUS**

The trust established under the Plan to hold the Plan's assets has not applied for exemption from federal or state income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by the Internal Revenue Code (IRC). Unrelated business income consists of investment income earned on the excess of the net assets available for plan benefits over the required reserve balance allowable under the IRC. The Plan sponsor believes the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023; therefore, no tax liability is reflected in these financial statements.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. PARTY-IN-INTEREST TRANSACTIONS**

The Plan has several arrangements with service providers and pays fees to Wilmington Trust, the Plan's Custodian. These transactions are party-in-interest transactions under ERISA.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in an investment security. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan participants are employees of the Company working under contracts with the federal government, many of which are subject to the Act. As such, federal contracts are subject to termination clauses whereby the government may terminate contracts for cause or convenience. Any contract terminations or funding delays caused by political, budgetary, or other administrative matters may affect employees participating in the Plan and the ability and necessity of the Plan sponsor to fund and maintain the Plan.

**8. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through August 5, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
