Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Retirement Plan for Bargaining Unit Employees of Marcegaglia USA, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Management has obtained a certification from a qualified institution as of October 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

The following description of the Retirement Plan for Bargaining Unit Employees of Marcegaglia USA, Inc., (formerly known as the Retirement Plan for Bargaining Unit Employees of Damascus-Bishop Tube Company, Inc.) (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

The sponsoring employer is Marcegaglia USA, Inc. (a wholly owned subsidiary of Marcegaglia Specialties S.r.l., an Italian Corporation). Marcegaglia USA, Inc. (formerly Damascus-Bishop Tube Company, Inc.) is referred to as the Company in these financial statements.

General and Eligibility

The Plan is a non-contributory defined benefit pension plan covering eligible hourly bargaining unit employees of the Company, including individuals who are members of a collective bargaining unit represented by the United Steelworkers of America AFL-CIO, Local Union #8790. Principal Life Insurance Company (Principal) serves as the custodian of the Plan and manages the Plan's investment assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

As part of a 1999 agreement between the Company and the bargaining unit employees, benefits under the Plan were frozen effective June 30, 1999. Employees became covered under the Steelworkers' Pension Trust (a multi-employer plan) effective July 1, 1999.

Employees covered under the Plan are entitled to benefits earned for services rendered through June 30, 1999, after which no additional employees were admitted to the Plan.

Pension Benefits

Eligible employees are entitled to monthly retirement benefits beginning at normal retirement age (65) equal to their years of credited service, subject to a maximum of 40 years, multiplied by the benefit unit (as defined in the plan document) in effect at the time of retirement. The Plan also has provisions for early, deferred vested, disability and survivor benefits for those participants who are eligible to receive such benefits. Benefits are payable in the form of a survivor annuity, a single life annuity or a modified cash refund annuity.

1. Plan Description (cont.)

Funding Policy

The Plan, although frozen, continues to be funded under the ERISA minimum funding requirements. The Company has satisfied the minimum funding requirements of ERISA for the years ended October 31, 2024 and 2023. The Plan is subject to quarterly contributions in the amount of \$6,903 for the year ended October 31, 2025.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to discontinue contributions to or terminate the Plan at any time subject to any current union provisions and the provisions set forth in ERISA.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivors' pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination, subject to a statutory ceiling on the amount of an individual's monthly benefit.

Whether all participants receive their benefits should the Plan be terminated at some future time would depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits, the priority of those benefits to be paid and the level and types of benefits guaranteed by the PBGC at that time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted (GAAP) in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein; and disclosure of contingent assets and liabilities. Significant estimates also include the fair value measurements of Plan investments and the actuarial present value of accumulated plan benefits at the date of the financial statements and the changes therein. Accordingly, actual results could materially differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investment in the Pooled Separate account is presented at fair value in accordance with ASC 820 Fair Value Measurements and Disclosures (see Note 4). The fair value of a financial instrument is the amount that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Disclosures include a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

Net appreciation (depreciation) in fair value of investments includes the pooled separate accounts' gains and losses on investments bought and sold as well as held during the year.

Employer Contributions

Employer contributions are recorded based upon the actuarial valuation calculations as determined by the Plan's actuary.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments that are attributable under the Plan's provisions to employee services rendered the valuation date, the date as of which the benefit information is presented. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits payable under all circumstances such as retirement, death, disability, and termination of employment are included to the extent they are deemed attributable to employee service rendered to the valuation date of the Plan.

The actuarial present value of accumulated plan benefits has been determined by the Plan's independent actuary. It is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. Actuarial valuations are based on demographic information as of the beginning of the Plan year.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

Expenses

Certain fees and expenses incurred by the custodian are paid by the Plan (see Note 7). Professional and PBGC fees are paid by the Company.

Benefit Payments

Benefit payments to participants and beneficiaries are recorded when paid.

Risks and Uncertainties

The Plan invests in a pooled separate account (see Note 4). Investment securities are exposed to various risks, such as interest rates, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are prepared based on certain assumptions pertaining to interest rates, inflation rates, mortality rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

4. Fair Value Measurements

ASC 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Basis of Fair Value Measurement

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 – Refers to securities not traded on an active market but for which observable market inputs are readily available;

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation methodologies maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at October 31, 2024 and 2023.

The methods described below may provide a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While the Plan's management believes its valuation methods are appropriate and consistent with other market participants, it is possible that different fair value measurements may arise due to the use of different methodologies or assumptions in determining the fair value measurement at the reporting date.

Pooled Separate Account

The Plan's investments are held in a pooled separate account and managed by Principal. The investments of the Plan are reported at fair value, which is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

4. Fair Value Measurements (cont.)

The value of the accumulation units held in pooled separate accounts are based on quoted market prices of the underlying investments which are based on the net asset value of the shares held by the Plan at year end. The value of investments in these accounts will increase or decrease to reflect the investment experience of the underlying investments. The accumulated unit value is used as a practical expedient to estimate fair value.

The following tables set forth by level within the fair value hierarchy the Plan investment assets at fair value, as of October 31, 2024 and 2023. As required by ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan had no material financial liabilities as of October 31, 2024 and 2023.

6. Income Tax Status

The Plan obtained its latest determination letter on March 29, 2017, in which the Internal Revenue Service states that the Plan, as designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, the Plan is exempt from income taxes. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than would not be sustained upon examination. The Plan Administrator believes that there are no uncertain tax positions that would have a material impact on the financial statements of the Plan. Therefore, no provision for income taxes has been recorded in these financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party Transactions

Plan investments include a pooled separate account managed by Principal. Principal is the Custodian of the Plan, therefore, these transactions qualify as party-in-interest transactions.

Amounts paid to Principal for investment advisory and contract administrator fees totaled \$27,190 and \$20,760 for the years ended October 31, 2024 and 2023, respectively.

8. Subsequent Events

Subsequent events have been evaluated through August 7, 2025 which is the date the financial statements were available to be issued. Management did not identify any events requiring recording or disclosure in the financial statements.

Methods prescribed by law

Liability measure Funding target is the present value of the benefits accrued on the valuation date. Included in Funding Target is the value of any missed required minimum distributions (defined in IRC §401(a)(9) and Treasury Regulation §1.401(a)(9)), equal to back payments with interest at 9.00%.

Target normal cost is based on benefits expected to accrue during the current plan year and includes an estimate of plan expenses for the year.

Methods selected by plan sponsor

Asset method The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years.

The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

Segment rates 24-month average with no weighting to prior law basis. Use rates where June is the last month included in the average.

Vested benefits A benefit is included in vested benefits if it meets the requirements under PBGC. The benefit is multiplied by the participant’s vesting percentage applicable to each benefit on the valuation date.

The following ancillary benefits are always treated as nonvested: disability benefits payable to retirement age unless in pay status, pre-retirement death benefits in excess of the survivor annuity death benefit and post retirement death benefits for non-retired participants except as noted in the Plan provisions.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Blue collar base rate table was selected based on information provided by the plan sponsor.

Mortality improvement

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe “Approach 1” is reasonable for this plan.

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes' arithmetic returns of the plan's target asset allocation, and then converted to the geometric under lognormal distribution assumption. For details, see Long-Term Capital Market Assumptions link.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

Optional forms of benefit payments

The optional forms of benefit payments are:

- Monthly annuity payable for life.
- Monthly annuity payable as a survivorship life annuity with survivorship percentages of 50 or 75.

The optional form conversion basis is 9.0% interest and 1971 Group Annuity Mortality Table for males, set back two years for both males and females other than lump sums. For lump sum payments, the conversion basis uses the applicable interest rate and applicable mortality table as set forth in Code Section 417. The applicable interest rate uses the first calendar month preceding the first day of the stability period which is the calendar month.

There have been no changes in principal eligibility or benefit provisions since the last valuation.
