Significant Audit Matters

No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management.

Management has determined the effect of not recording a payable for excess contributions paid after year end is immaterial, both individually and in the aggregate, to the financials taken as a whole.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have performed an audit of the accompanying financial statements of UBG 401(K) – Alliance Ag & Grain, Spearville, Kansas, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE 1—DESCRIPTION OF PLAN

The following description of UBG 401(K) – Alliance Ag & Grain (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all employees of Alliance Ag and Grain, LLC (the Company). Employees are eligible to participate in the Plan when they have completed three months of service and have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Each year, participants may elect to defer not less than 1% and not more than 75% of eligible compensation, as defined in the Plan, subject to the maximum amount allowable under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to make after-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Company Contributions

The Company may make a discretionary contribution equal to a uniform percentage or dollar amount of participant elective deferrals each payroll period. Each year, the Plan sponsor will determine the formula for the discretionary matching contribution. For the year ended December 31, 2024, the Company matched 50% of the first 6% of compensation that the participant contributed to the Plan.

In addition to discretionary matching contributions, the Company may make a discretionary nonelective contribution to the Plan. For the year ended December 31, 2024, no discretionary nonelective contribution was made.

Investment Options

Participants direct the investment of their contributions as well as the Company's contributions into various investment options offered by the Plan. The Plan currently offers Mutual Funds, Fixed Annuities, and Common Collective Trust Funds as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, an allocation of Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Upon attainment of normal retirement age, death, or disability of the participant, all amounts are fully vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance the participant had during the previous 12-month period or 50% of their vested account balance. The loans are secured by the balance of the participant's account and bear a commercially reasonable rate of interest. Loans used to purchase a residence may be repaid over fifteen years. Loans for all other purposes must be repaid within five years. Principal and interest is paid ratably through payment terms specified in each note agreement.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in installments. Participant accounts with a vested benefit not exceeding \$5,000, will be distributed as a single lump sum payment.

In-service distributions are allowed by meeting certain conditions, including attaining age 59½, incurring a financial hardship, or incurring a disability.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested account balances totaled \$662 and \$0, respectively. For the year ended December 31, 2024, \$7,470 was used to reduce Company contributions.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any unpaid interest. Delinquent participant loans, if any, are classified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See also Note 3—Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses (realized and unrealized) on investments bought and sold as well as held during the year.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are included in benefits paid to participants.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Operating Expenses

Certain administrative expenses of maintaining the Plan are paid by the Company.

Date of Management's Review

Management has evaluated subsequent events through July 30, 2025, the date which the financial statements were available for issue.

NOTE 3—FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: are valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Mutual Funds held by the Plan are considered to be actively traded.

Fixed Annuities: this is an EI Fixed Account that is backed by the general account assets of Empower Annuity Insurance Company of America. The reported values are reported daily as calculated by the annuity provider.

Common Collective Trust Funds: are valued at the NAV as determined by the trustee of such funds based upon the underlying securities stated at fair value. The NAV as provided by the trustee of the fund is used as a practical expedient to estimate fair value.

NOTE 4—SUMMARY OF INFORMATION CERTIFIED BY TRUSTEE OF PLAN UNDER SECTION 29 CFR 2520.103-8 OF THE DEPARTMENT OF LABOR'S RULES AND REGULATIONS FOR REPORTING AND DISCLOSURE UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974. THE FOLLOWING INFORMATION INCLUDED IN THE ACCOMPANYING FINANCIAL STATEMENTS AND SUPPLEMENTAL SCHEDULE WAS OBTAINED FROM DATA THAT HAS BEEN PREPARED AND CERTIFIED TO AS COMPLETE AND ACCURATE BY THE TRUSTEE AS OF DECEMBER 31

The trustee of the Plan held all of the Plan's investment assets and executed transactions therein. Financial information relating to those assets is included in the accompanying financial statements based on information provided by the trustee. The Plan administrator has obtained certification from the trustee, Empower Trust Company, LLC, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate. That information, which has not been audited by independent accountants, is summarized as follows:

- a. Investment balances and transactions
- b. Participant loan balances and transactions
- c. Investment activity and accrued income

NOTE 5—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6—TAX STATUS

The Plan has adopted a prototype-standardized plan designed to qualify under Section 401(k) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the prototype plan has received an opinion letter dated November 14, 2022, that this Plan is relying on. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, exempting it from federal income taxes.

NOTE 7—RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8—RELATED PARTY TRANSACTIONS

The Company absorbs significant expenses of administering the Plan, including general administration and recordkeeping costs.

NOTE 9—RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The guaranteed account is included in the financial statements at fair value.
