To the Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the CBI Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the CBI Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of the CBI Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the CBI Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the CBI Retirement Plan (the Plan) provides only general information. For more complete information, participants should refer to the Plan instrument.

General

The Plan is a defined contribution 401(k) profit sharing retirement plan covering all eligible employees of Cliff Berry, Inc. (the Company). In order to be eligible to participate in the Plan, employees of the Company must have completed three months of continued service with the Company, amongst other criteria. The Plan commenced on January 1, 1999 and was amended and restated effective January 1, 2016 and July 1, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Funding

Each year participants may contribute up to 100% of pretax annual compensation as defined in the Plan, subject to IRS limits. Participants who have reached at least age 50 may contribute additional amounts. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

The Company may make discretionary matching and profit-sharing contributions at the option of the Company's board of directors each Plan year. Participants must be employed by the Company on the last day of the Plan year in order to be eligible to receive matching contributions which are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of any Company contributions, and an allocation of Plan earnings. Participant accounts are charged with benefit payments and an allocation of any administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Vesting

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Beginning on the second year of service, the vesting percentage increases by 20% after each year of service. A participant is 100% vested after 6 years of credited service. Participants are also 100% vested in the employer's contribution portion of their accounts upon death, disability or attainment of normal retirement age, as defined in the Plan.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to be allocated among a selection of securities provided by the Plan administrator (see Note 3).

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments over a fixed reasonable period of time, as defined in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeitures

Forfeitures may be used to reduce employer contributions and to pay for Plan expenses. They may be used in the year following the Plan year in which the forfeitures occur.

As of December 31, 2024 and 2023, the balance of forfeited non-vested accounts totaled \$13,212 and \$8,821, respectively. During the year ended December 31, 2024, \$8,821 in forfeitures were used to reduce employer contributions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts from \$1,000 up to a maximum of \$50,000 or 50% of their non-forfeitable account balance, whichever is less. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. The loans are secured by the balance in the participant's account and bear interest at a rate based on market rates, as defined by the Plan. As of December 31, 2024 and 2023, the notes bore interest at rates ranging between 4.25% and 9.50% with various maturities through 2029. Principal and interest are to be paid through direct after-tax payroll deductions based on each loan amortization schedule. For terminated participants, the loan balances will become due and payable on the first day of the third month after the end of the quarter in which the termination occurred. Participants had outstanding loans of \$166,282 and \$183,395 as of December 31, 2024 and 2023, respectively.

Termination

Although there has not been any expressed intent to do so, the Plan document provides for termination of the Plan subject to the provisions of the agreement and ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of Credit Risk

Financial instruments which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of investments, employer contributions receivable, and notes receivable from participants. The Plan invests in mutual funds, fixed annuities and common collective trusts which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual debt security.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

Empower Retirement, as custodian, held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule of Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds, fixed annuities, and common collective trusts) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$587,492. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used to measure fair value as of December 31, 2024 and 2023.

The following is a description of the valuation methods used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the net asset values reported by the fund managers as of the financial statement date.

Fixed annuities: Valued daily based on valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The Empower Investments Fixed Account is a general account product offered through the group annuity contract with principal and interest being fully guaranteed by the entire general account assets of Empower Annuity Insurance Company of America. NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 6. TAX STATUS

The Plan is exempt from Federal income taxes under Internal Revenue Code (IRC) and, therefore, no provision for Federal income taxes has been made. In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes no such positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax periods prior to December 31, 2021.

NOTE 7. RELATED PARTY

Cliff Berry, Inc. is the Plan sponsor and participating employer. They absorb virtually all of the Plan's administrative expenses.

NOTE 8. PARTY-IN-INTEREST TRANSACTIONS

The Empower Investments Fixed Account is a general account product of Empower Annuity Insurance Company of America (EAICA). Participant principal and interests are backed by the entire general account of EAICA who serves as Plan custodian and has fiduciary responsibility. This makes transactions between the Plan and EAICA party-in-interest transactions.

Additionally, the Plan pays Empower Annuity Insurance Company for record-keeping fees. For the year ended December 31, 2024, these expenses amounted to \$10,372. They have been included in the accompanying statement of changes in net assets available for benefits as part of administrative expenses.

NOTE 9. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for the Plan through June 20, 2025, the date the financial statements were available to be issued.
